

Israeli Violations' Activities in the oPt

31 October 2011

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

- The Israeli occupation Army raided the house of Raja Mohammad Salem in Ash Shawawra village east of Bethlehem city, searched the house and arrested his son Anas (22 years old).
- The Israeli occupation Army arrested Abed Al Karim Al Shwikhi (14 years old), Muhammad Al Qaq (20 years old) after storming their houses in Silwan city in Jerusalem.
- The Israeli occupation Army arrested Ahmad Shaker Odeh and Ayman Odeh after storming their house in Al Funduq village in Qalqiliya

Governorate. The IOF also arrested M'azouz Hussein Musalha, Taleb Husien Musalha from Hajja village in Qalqiliya Governorate.

- The Israeli occupation Army arrested Ahmad Mohammad Shreteh and Muhannad Mohammad Shreteh from Yatta town south of Hebron Governorate, after storming their houses and messing up the contents. Furthermore, the IOA raided Al Shuyokh, Halhul, Dura and Sa'ir towns and several neighborhoods in Hebron, stopped Palestinian cars and checked in their ID cards.
- "Mikrot", the Israeli Water Company stopped the water supply used by residents of 'Ein Al Baiyda in the northern Jordan valley. Additionally, the Israeli occupation Army raided the village and searched the houses. It is important to mention that the Israeli settlers of Maskiyyot settlement tried to confiscate a piece of land owned by Majed Younis Al Foqah'a.

Israeli settlers Violence

• A group of Israeli settlers threw stones at an elderly Palestinian lady (80 years old), while harvesting olive trees in their lands in Mikhmas village south east of Ramallah city.

Home Demolition and Demolition Threats

- The Municipality of Jerusalem handed demolition notices for Palestinian houses in Silwan city. The notices were given to Odeh family in Al Bustan neighborhood, Jalajel family in Wadi Yasoul and Al Abbasi family in 'Ein Al Louza neighborhood.
- The Israeli occupation Army along with the Israeli bulldozers demolished 3 residential structures made of tin owned by Mohammad B'aran, Sliman B'aran and Salman B'aran, in Khan Al Ahmar area north east of Jerusalem city.
- Israeli Occupation Army raided Silat Al Harithiya and Zububa towns
 west of Jenin and placed checkpoints on the entrnaces of the towns.
 The IOA also stopped Palestinian cars, carried out thourough
 inspection and checked the ID cards
