## Israeli Violations' Activities in the oPt 2 April 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- The Israeli occupation Army (IOA) set up sudden checkpoints at Al Fawwar road junction south of Hebron city and Halhul Bridge. ARN (April 2, 2012).
- The Israeli occupation Army (IOA) stormed many students' houses in Bir Zeit city and Bir Zeit University Students' Dormitories north of Ramallah. The IOA arrested Ayman Abu 'Arram, the former head of Students' union in the university and raided the house of Hamdan As Sayyed and took him to unknown destination. ARN (April 2, 2012).

## **Israeli Arrests**

- The Israeli Occupation Army (IOA) raided Al Madeena Al Munawwara building in Nablus city and arrested residents Kahled Al Halabi (21 years) and Issam Amar Abu Ghazala (16 years). Wafa (April 2, 2012).
- The Israeli Occupation Army (IOA) raided Qabatyia town south of Jenin city and arrested three residents, Mufeed Yacoub Nazzal (55 years), Tamer Fayegeq Saba'na (38 years) and Fadi Yousif Khazimeieh (20 years). The IOA also handed resident Naser Muhammad Zakarna (22 years) a notification to interview the Israeli Police Intelligence in Salem Detention center. Wafa (April 2, 2012)
- The Israeli Occupation Army (IOA) handed resident Ahmad Jihad Wishahi (26 years) from Muthalath Al Shuhada (Martyrs' Square) a notification to interview the Israeli Police Intelligence in Salem Detention center. Wafa (April 2, 2012)
- The Israeli occupation Army (IOA) arrested resident 'Anan Naji Al Tamimi (16 years) from An Nabi Saleh village northwest of Ramallah city while on his way to school. Wafa (April 2, 2012).
- The Israeli occupation Army (IOA) arrested four citizens from Marka village south of Jenin city. The arrestees are: Saleh 'Ali Nafe' Musa (33 years), Ahmad 'Ali Nafe' Musa (22 years), Mustafa Hisham Abdel 'Aziz (35 years) and Fares Tayseer Musa (34 Years). Wafa (April 2, 2012).

## **Home Demolition & Demolition threats**

- The Israeli occupation bulldozers residential and animal shelters in Al Jawana area in Kherbit Tana in Nablus Governorate. Three Palestinian families suffered from the demolition. DWG (April 2, 2012).

## **Confiscation & Razing of lands**

- Israeli settlers of Karmeit Tzur settlement razed agricultural lands and uprooted tens of fruit trees (Grapes and plum) in lands located adjacent to the settlement and are owned by Sabarna, Awad and Abu Maria in Beit Ummer town. The razing process comes in preparation for opening a road for the use of the army and settlers in the area. Wafa (April 2, 2012)

## **Others**

- Israeli planes dropped pamphlets in the southern Gaza Strip warning Palestinians not to enter a no-go zone on its southern border. The

leaflet, signed by Israeli forces general command, included a map of the zone. An Israeli army spokeswoman said the leaflets were dropped in several locations, and "reiterated to the citizens of the Gaza Strip to keep a 300-meter distance," from the border area. Israeli soldiers "will operate in accordance with the rules of engagement, and will use live fire if they need when the security fence is approached," the leaflet warned. It also warned against "cooperation with terror organizations, involvement in violent riots, and approaching the security fence". Maannews (April 2, 2012).

- The Israeli Supreme Court rejected the petition filed by one of the heirs of the late Grand Mufti Haj Amin al Husseini on the issue of seizing Karm Al Mufti "Haj Amin al-Husseini" and the "Shepherd" hotel in Sheikh Jarrah neighborhood. The petition was filed against (1) the illegitimate application of the Custodian of Absentee Property law on Palestinians living in East Jerusalem and (2) against the illegal actions that led to the transfer of ownership of Karm Al Mufti to the US Company (C & M Brobbertz) which belongs to the Jewish American businessman Irvin Moskowitz through the Custodian of Absentee.
