

Israeli Violations' Activities in the oPt

6 December 2011

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

- The Israeli Occupation army raided a number of Palestinian houses in Kafer Qaddum village and gave notifications to interview the Israeli Intelligence to the following: Anas Barham (20 yeras old), Ref'at Barham (20 years old), Abdalla Rajab (21 years old), Abd Al Hafeez Anwar (20 years old) and Ihab Mo'ayad
- The Israeli Occupation arrested Mo'taz Khalil 'Ezba (16 years old), Ahmad Mohammad Edris (18 years old) and Mos'ab Sobhi Al 'Aza (18 years old) from Al Doha town west of Bethlehem city.

- The Israeli occupation Army accompanied by military vehicles moved hundreds of meters into the east of Beit Hanuon north of Gaza city. In addition, the Israeli gunboats fired at Palestinian fishing boats in Al Sudaniya northwest of Gaza, causing no damages to the boats.
- The Israeli Occupation Army arrested Mahmud Nassar at Beit Hanoun crossing north of Gaza strip.
- An Israeli military court ordered the deportation of Ahmad Attoun; a Palestinian lawmaker from Jerusalem to Ramallah.

Home Demolition and Demolition Threats

 The Israeli Occupation Army demolished the 70 square meters house owned by Khamis Al Dodo in Al Khalila neighborhood in Al Jeib village northwest of Jerusalem city under the pretext of being built without a building permit.

Confiscation& Razing of Lnads

 The Jerusalem Planning and Building Committee is to consider a plan for a new national park in the Mount Scopus area, which will block the development of two Palestinian neighborhoods in the east of the city, Issawiya and A-Tur neighborhoods. The new national park would be built on 734 dunums of lands of the two aforementioned communities
