## Israeli Violations' Activities in the oPt 23 February 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- The Israeli gunboats fired at Palestinian fishing boats in the shores of Rafah south the Gaza strip, no injuries were reported.
- The Israeli Occupation Army arrested 9 Palestinian citizens, 7 of them are from Nablus city.
- The Israeli Occupation Army accompanied with the workers of Civil administration raided Beit Iksa village north west of Jerusalem city and

stormed a kindergarten in the village and started photographing the buildings. In addition to that, the IOA stationed at the military checkpoint on the entrance of the village, prevented the citizens from entering or existing the village.

- The Israeli Occupation Army raided a number of Palestinian houses and arrested 7 Palestinian citizens from 'Azzun town east of Qalqiliya city. The arrestees are; Ja'far Ahmad Husien (20 years old), Mohamad Samir Abu Hania (20 years old), Adi Mohamd Sa'ed Salama (21 years old), Tilal Taher Salim(19 years old), Othman Salim Salim (22 years old) and Ahmad Yousef Salim (20 years old). The Israeli soldiers attacked and beat Taher Salim.
- The Israeli soldiers arrested Samer Mohamad Ali Qenawi (28 years old) after storming his house and messing with its contents in Arraba town in Jenin city.
- Israeli Special Forces in the Israeli police arrested 4 Palestinian citizens from the yards of Aqsa mosque in Jerusalem city.

### **Israeli Settlers Violence**

- Israelis settlers attacked and threw stones at Palestinian cars near Jaba' town north Jerusalem city, causing injury to Palestinian women; Ala' Kizmar from Tulkarem city citizen.
- Israeli settlers of Tekoa settlement threw stones at Palestinian cars while crossing the crossroad of the settlement, no injuries were reported.
- The number of Israeli settlers who stormed Al Aqsa mosque increased since the morning to become 36 settlers and divided into two groups, 12 in each group.

### **Confiscation & Razing of lands**

- The Israeli Occupation Bulldozers razed 30 dunums of lands planted with 750 olive and almond trees in Surif town northwest of Hebron city and demolished a water well. The razed lands owned are by Ghnimat and Al Qaddi families in Deir Mussa area west of the town.

### **Israeli Military orders**

- The Israeli Civil Administration related to the Occupation Army served residents of Surif town northwest of Hebron city military orders to halt construction in their structures under the pretext of lacking building permits. The military orders set the date of 29 of February 2012, a date for the hearing session of Israeli Court in Beit Il settlement to look for the demolition of the structures or return the structures to their previous status. The threatened structures are owned by Yousef Abd Al LatifGhnimat, Abd Alah Husien Ghnimat, Mahmud Mohamad Al-Hour,Ibrahim Mohamad Al-Hour and Husien Sliman In'im.

### **House Demolition & Demolition Threats**

- The Israeli Occupation Army demolished 50 meters square house and two water wells with a capacity of 350 cubic meter owned by Ahmad Mussa Othman Dababsa in Al-Injasat area in Beit Ulla town west of Hebron city. The IOA also razed the lands near the house.
