## Israeli Violations' Activities in the oPt

25 February 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- The Israeli Occupation Army suppressed the weekly protest in Yatta town in Hebron city, where the IOA attacked and beat Palestinian protesters among International activists and arrested the two brothers; Ahamd and Tareq Ibrahim Jneida from Yatta town and took them to unknown destination.
- The Israeli Occupation Army attacked the weekly non-violent demonstration against settlements and the segregation Wall in Beit

Ummar town north of Hebron city. The IOA fired tear gas and sound bombs to disperse the protesters, as well as assaulted some participants with gun butts and sticks causing bruises and gas inhalation suffocation. The participants in the protest condemned the Israeli authorities' seizure of Palestinian-owned land for settlement expansion and the Israeli policy to prevent Palestinian farmers from accessing their agricultural land.

- The Israeli Occupation Army shelled at Al-Rais mountain northeast of Al Tuffah neighborhood east Gaza strip, no injuries were reported.
- Palestinian citizen; Ali Ahmad Abd Al –Hamid (25 years old) was injured, after being run over by an Israeli settler in Al Quds-Hebron street near Beit Ummar town north of Hebron city.
- Israeli soldiers opened fire and killed Talat Ramiyeh (25 years old) during demonstrations near Qalandiya checkpoint south of Ramallah city. Protests had also erupted at Qalandyia refugee camp and soldiers manning the checkpoint opened live fire, and shot rubber bullets and tear gas grenades at the Palestinians.
- Two Palestinian citizens were injured in a bombing, which was caused by the Israeli warplanes when shelling at a site west of Rafah city south of Gaza city, causing lots of damages.
- Palestinian residents of the northern Jerusalem town of ar-Ram clashed with Israeli soldiers on the outskirts of the town following a tense night after Israeli soldiers had shot and killed Talat Ramiyeh.

### **Israeli Military orders**

- The Israeli Occupation Authority handed out residents of Nahhlain village southwest of Bethlehem city 4 military orders stating the evacuation of their lands under the pretext of being classified as "State Lands". The military orders are: Military Order No. 347 (8/12): states the evacuation of 20 dunums of lands. Military Order No. 342(3/12): states the evacuation of 10 dunums of lands. Military Order No. 345(6/12): states the evacuation of 20 dunums of lands and Military Order number 346(7/12) and states the evacuation of 4 dunums of lands.
