Israeli Violations' Activities in the oPt

5 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

- The Israeli Occupation Army accompanied with the Israeli Civil Administration raided the area near Al Najma Plastic factory in Beit Jala in an attempt to confiscate the goods placed near the main street which are owned by Elias Diek; owner of the factory and their cost is

estimated at 80 thousand NIS. The IOA also confiscated a small lift machine which costs 89 thousand NIS.

- The Israeli Occupation Army arrested Kayed Al Razem in Bab Al Amud area and took him to the police station in Salah Al-Deen Street in Jerusalem city. The arresting came during a campaign carried out by the IOA to remove the stalls set by Palestinians in Bab Al-Amud area and As Sultan Suleiman and Salah Al-Deen streets, where the Israeli troops attacked Palestinian sellers and their stalls and beat them before confiscating and destroying all the contents of the stalls.
- The Israeli Occupation Army stormed Battn Al-Hawa neighborhood known as Al-Hara Al-Westra in Silwan town in Jerusalem city, conducting military and search operations in a number of Palestinian houses owned by Hamid and Qara'in families before arresting Ibrahim Al'a Qara'in (17 years old) and took him to at Al Maskobiyeh detention center west of Jerusalem.
- The Israeli soldiers raided Hebron city and arrested 2 brothers; Azam (48 years old) and Imad Abd Al-Majeed Yasin Taha (37 years old) after storming their houses and messing with their contents. Also the Israeli soldiers raided Adh-Dhahiriya town southwest of Hebron city and arrested Mahmud Al-Batat after searching his house. Furthermore, The Israeli soldiers conducted military and search operations in several Palestinian houses, including the house of released prisoner; Khalid Al-Batat.
- The Israeli Occupation Army stormed the house of Ayman Mohammad Frokh (30 years old) and searched it in Tuqu' town east of Bethlehem city.
- The Israeli Occupation Army detained Mohamad Amer Abu Salah (13 years old) and Mussa Abu Baker (17 years old) from Ya'bad town southwest of Jenin at the military checkpoint and investigated with them before handing them to the Palestinian liaison office.
- The Al-Aqsa Foundation for Endowment and Heritage revealed that the Israeli Occupation army installed surveillance cameras inside the Al Aqsa mosque specifically at Bab Al-Magharba, from the inside.
- The Israeli occupation Army raided Kifl Haris town east of Salfit to secure the visit of the Israeli settlers to the religious sites in the town.

The Israeli troops spread at many of the roads and main points in the village and erected military checkpoints at the entrance of the town checking in the Palestinian ID cards. Settlers performed provocative dances under the protection of Israeli soldiers.

- The Israeli Occupation Army arrested Ali Abdala Khalil Abu Al Rab (50 years old) and his son; Dajana (20 years old) while on his way to Qabatiya town from Ramallah city at Za'tara checkpoint and took them to unknown destination

Erection of Israeli checkpoints

- The Israeli Occupation Army set up military checkpoint at a number of neighborhoods in Hebron city and at As Samu and Dura towns where they stopped Palestinian cars and checked residents' ID cards.

Home Demolition and Demolition Threats

- The Israeli Occupation Army with along bulldozers demolished Barracks and confiscated all its contents in Al Ezariya town east of Jerusalem city .
- The Israeli Occupation bulldozers demolished 2 houses under the pretext of lacking building permits in Ein Ad Duyuk At Tahta village west of Jericho city. The bulldozers also demolished and destroyed the electricity network.

Confiscation & Razing of Lands

- The Israeli occupation Authorities decided to take over and confiscate 50 dunums of lands of Wadi An-Nis village south of Bethlehem city for the construction of a commercial crossing between the West Bank and Israel. The commercial crossing is to control the entry of goods from Israel into Bethlehem and the rest of Palestinian Territory. The threatened lands are owned by Abu Hamad and Mussa, Khalil and Fawzi families and are located in Sha'b Jom'a" hill and lies about 200 meters from the urban area of the village.

Israeli Military Orders

- Palestinian residents of northwest Jerusalem city were served military orders by the Israeli occupation authorities to confiscate 1161 dunums of land of Beit Duqqu, Beit Surik, Qatanna, Al Qbeiba, Beit Ijza, Biddu, An Nabi Samuil and Beit Ikxa to expand and change the route of the Segregation wall in the area.
