Israeli Violations' Activities in the oPt

8 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Brutality of the Israeli Occupation Army

• The Israeli Occupation Army arrested Raed Mahmud Salim Sabarna (35 years old), Yousef Mahmud 'Alama (25 years old) from Beit Ummar town and conducted military and search operations to their houses. Furthermore, The IOA raided Bahr bakery in the town and destroyed the windows of the bakery and attacked the worker; Zohair Moqbel (40 years old).

Israeli Settlers Violence

- Israeli settlers of Ramat Yeshai settlement under the Israeli protection physically attacked two Palestinian boys; Ibrahim Abu 'Aysha (12 years old) and Walid Abu 'Aysha near Tel Rumeida area in Hebron city.
- Dozens of Israeli settlers attacked the house of Jawdi Abd Al-Jawad Jaber and set fire into his car in Al-Baq'a area east of Hebron city.

Confiscation & Razing of Lands

• The Israeli Jerusalem Municipality will confiscate Palestinian-owned lands in the Jabal Al-Mukaber neighborhood to set up a statue and a mediation center in an area between Jabal Al-Mukaber and Jewish neighborhood of Armon HaNetsiv to build a sttaus of Mahatma Gandi. The Hebrew daily Ma'ariv said the statue will be placed in a garden with a balcony for meditation that is being designed by Argentine architect Roberto Kahanov. The report said that the statue is being contributed by the municipality of Geneva and it will be identical to the one put up by it to honor the symbol of nonviolence.

Home Demolition and Demolition Threats

• The Israeli occupation authorities handed seven Palestinian families in Khirbet Umm al-Khair east of Yatta town in Hebron city orders to demolish their houses under the pretext of lacking building permits. the threatened houses are owned by; Salim Mohamad Khalil, Ikhlas Ali, Adel Salman ,Bilal Salman, Khairi Salman, Maliha Hamad,Khairi Salman and Sliman 'Eid.
