Israeli Violations' Activities in the oPt

17 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

The Israeli Occupation Army arrested Mohammad Ali Jawabra (55 years old) after storming his house in 'Aseira Ash Shamaliya village west of Nablus city and, also arrested Khalil Hashash (20 years old) from Balata refugee camp and Muntaser Ibrahim (16 years old) from Ad Dahiya area in Nablus.

- The Israeli Occupation Army raided 'Azzun town east of Qalqilyah city and arrested 12 Palestinian residents, and released 4 after beating them. The arrested residents are: Ghalib Ahmad Salim, Majdi Samer Sliman, Mohammad Ali Radwan, Adnan Imad Radwan, Ahmad Fakher Haware, Ayman Abdulla Kharfan, Mohammad Rashid and Wissam Rashid Radwan. The 4 released residents are: Abdullah Khader Salim, Mahmud Rashid Radwan, Yousef Salim Shbeta and Mohammad Imad Radwan. The IOF also arrested and attacked Ali Ghalib Ahmad Ibrahim Salim after raiding his house and messing with its contents.
- The Israeli Occupation Army arrested Fared Mohammad 'Alwana from Jab'a village southwest of Jenin city and took him to unknown destination, after raiding his house and messing with its contents.
- The Israeli Occupation Army fired at peaceful demonstration organized by group of protesters in Beit Hanun town north of Gaza strip, the demonstration was in the refuse of the security buffer zone north of the town.

Home Demolition and Demolition Threats

• Israeli Occupation Authorities handed two military orders to demolish 2 Palestinians houses in Khirbet al-Tawil east of Aqraba village south of Nablus city. The threatened families are; Basim Bani Jaber and Abd Al-Fatah Ma'rouf Bani Fadel.
