## Israeli Violations' Activities in the oPt

18 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- The Israeli Occupation Army raided Silat Al-Harithiya town west of Jenin and stormed number of commercial stores, Maher Al-Dahdah is one of the owners of stormed stores, also the IOA prevented the residents from moving and checked their ID cards.

- The Israeli Occupation Army raided 'Awarta village east of Nablus city and stormed number of Palestinian houses also arrested Shadi Salim Shirab (33 years old).
- The Israeli Occupation Army raided Deir Estiya village northwest of Salfit from the western side and arrested 3 Palestinian citizen; Jihad Tawfiq Mohammad Abed Al-Rahman Khalid(26 years old), Issam Bassam Abd Al Karem Mansur(18 years old) and Baha' Khairi Khaid Mansur(17 years old).
- The Israeli Occupation Army raided At Tariqba neighborhood in Beit Ummar town north of Hebron city and arrested Firas Ibrahim Hamid Abu Maria (21 years old) after storming his house and messing with its contents.
- The Israeli Occupation Army arrested Mamdoh Bassem Khader Al-Alami (19 years old) from Wadi Ash Shikeh area in Beit Ummar town, after forcing him and his brother' Khader (16 years old) to get out and take off all their clothes, Meanwhile, the IOA raided the house of his father; Bassem Al-Alami (44 years old) in Za'ita area east of the town, they searched the house and forced its residents to get out from the house, also they beat Bassam and his wife; Khawla(38years old).
- Israeli artillery shelled at Abu Safia area near the memorial statues east of Beit Hanoun town north of the Gaza Strip and opened its heavy gunfire on the area extensively, in addition, Israeli artillery stationed on east of the Gaza border has shelled the same area with at least 10 shells. No injuries or casualties in the attack.
- The Israeli Occupation Army arrested Mashuhor Amr Abd Al Rahman Abu Rab(44 years old) and his brother Ala' (36 years old) after storming their houses and messing with the contents in Jalbun village east of Jenin city .
- Israeli Occupation Army shelled on the Gaza Strip left two Palestinians dead and a third injured. Mohammad Abu Odeh (23 years old) and Ahmad Za'aneen (17 years old) were killed when Israeli artillery targeted areas east of Beit Hanoun, north of the Gaza Strip.

## **Israeli settlers violence**

- Israeli settlers of Pene Hever settlement located east of Bani Na'im town in Hebron Governorate chased and threw stones at Palestinian Shepherd; Ibrahim George and prevented him from reaching his land. Also the settlers dumped garbage and dirt in the water well in Al-Birin area located between Yatta and Bani Na'im towns and uprooted trees owned by Jihad Mawas from Bani Na'im town

### **Erection of Israeli checkpoints**

- The Israeli Occupation Army set up military checkpoint at the entrance of Ya'bad town in Jenin city stopped the Palestinian cars and checked in their ID cards.

### **Home Demolition and Demolition Threats**

- The Israeli Occupation Army handed 3 residents from Khirbet At-Tawil east of Nablus city military orders to demolish their residents. Also the IOA notified citizens near Aqraba town to demolish their residential structures.
- Israeli Police and Jerusalem Municipality workers stormed number of neighborhoods; Al-Sal'a, Wadi Yausul, Aien Al-Luza in Silwan town in Jerusalem city. The Israeli troops put up random roadblocks and issued tickets to Palestinian drivers across the neighborhood without any reason. Also the workers of Jerusalem municipality handed out 10 demolition orders to Palestinian residents in Silwan under the pretext of building without permits. Wafa(January18,2012).

### **Confiscation & Razing of Lands**

- The Jerusalem Municipality issued a decision to confiscate land area of 117 dunums of land Shu'fat, Beit Hanina, in the interest of "street No . " 21 under articles 189 and 190 in construction law and regulation for the year ,1965 and therefore the local committee as planned by M / 3456 A, Under Articles 5 and 7 of the Expropriation Act in the public interest The mayor of the occupation of Jerusalem acceleration process of confiscation of the street mentioned for the following reasons:

1. Provide a colony, “Ramat Shlomo) ”Reches Shuafat) request to expand the building in the colony in question, as it has no colony, only one street to exit and enter
2. The street in question is linked colony “Pisgat Ze’ev” colony “of Ramat Shlomo, as well as the street leading to the Ramot It serves as the main settlements around the area and link them together.
3. The street is a main street in question, an alternative to street Shuafat – Ramallah, the President ,which works to hit the commercial traffic on the street now.
