Israeli Violations' Activities in the oPt 23 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

- The Israeli Occupation Army raided the Red Cross building in Ash Sheikh Jarah in Jerusalem city and arrested Mohammad Tahtoh, a lawmaker and the former Palestinian minister; Khalil Abu 'Arafa.
- Israeli artillery shelled Palestinian areas north of Beit Hanoun and north of the Gaza Strip, near the borders with Israel. No injuries were reported.
- A Group of Israeli Judges conducted visit to a military zone located on the roof of one of the Palestinian buildings in Batn Al-Hawa neighborhood in Silwan city in Jerusalem.

- The Israeli Occupation Army raided Balata refugee camp in Nablus city and arrested Yousef Shara'ya. The IOA also arrested Ali Abd Al-Wahab Hamamra (22 years old) after storming his house in Husan town in Bethlehem city.
- The Israeli Occupation Army arrested Mohamad Atta Mussa (20 years old), Ali Mohamad Nafe' Muser (21 years old) after storming their houses and messed with their contents in Marqa village south of Jenin city. The IOA also raided Deir Abu Da'if village east of Jenin city and conducted military operations.
- The Israeli Occupation Army raided 'Anbta town and arrested 5 Palestinian citizens; Mohammad Mustafa Abd Al-Razeq Najar (20 years old), Ihab Mohammad Rashid (20 years old), Muhammad Ahmd Nour(27 years old), Hani Taysir Abd Al-Daeym (23 years old and Ruslan Mahmud Nour (24 years old).

Home Demolition and Demolition Threats

- The Israeli Occupation Authority handed a number of Palestinian citizens military orders to demolish their residential structures in Khallet Abu Baiyd Al-Jalal in Bani Na'im town in Hebron city. The threatened structures are owned by; 'Atieh Mohamd Ziyada and Shehda Sliman Yacoub Al-Taraera.
- The Israeli Occupation Army demolished 9 commercial structures in Al-'Auja village north of Jericho city under the pretext of lacking valid building permits due to their location in Area C, which falls under the full Israeli control according to OSLO II Interim agreement of 1995.

Others

- Israeli Prime Minister Netanyahu released a statement calling upon the settlers of the Illegal Outpost of Migron to accept his proposal to overcome the Supreme Court ruling in effect offering them to move to another piece of Land deep in the West Bank. This piece of land would be developed especially for the settlers illegally residing in Migron, and only once ready would they move to the new location.
