## Israeli Violations' Activities in the oPt

24 January 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

### Brutality of the Israeli Occupation Army

- The Israeli Occupation Army raided Ar Rafaidiya neighborhood west of Nablus city, searched a number of Palestinian houses and arrested Baker Jamal Mansour (20 years old). The IOA also raided Al-Juneid area west of the city and searched a Library and confiscated a computer device. Furthermore, the Israeli occupation troops raided Balata refugee camp, fired tear bombs and searched several Palestinian houses and destroyed the windows.
- The Israeli Occupation Army arrested Abd Al-Jaber Faqha' (45 years old) after storming his house in Al Maison area in Ramallah city.

- The Israeli Occupation Army arrested Yahiya Kamal Ahmad Fakhori (24 years old) after storming his parents' house and messing with its contents in Jaba' town south of Jenin city.
- The Israeli Knesset will discus a plan to demolish Al Magharbeh Gate in Jerusalem city.
- The Israeli Occupation Army detained 8 Palestinian citizens at Za'tara checkpoint south of Nablus city.
- The Israeli Occupation Army raided Kifil Haris village east of Salfit city, set up military checkpoint at the entrance of the village and stopped Palestinian cars.
- The Israeli warplanes fired three missiles at fields near al-Shaymaa school in the northern town of Beit Lahiya; two missiles hit an open area west of Khan Younis in southern Gaza, and one missile hit Bani Suheila east of Khan Younis.
- The Israeli Occupation Army arrested a young man near Al Ibrahimi mosque in Hebron city after searching him and found a knife. The IOA took him to the Police station for investigation.
- The Israeli occupation troops raided Beit Ummar town, conducted military and search operations in some Palestinian houses, of which, the following where known: Bahjat Shahdi Al-Alami, Mohamad Husien Al-'Alami.

#### Israeli settlers violence

 About 10 Israeli buses carrying 1200 Israeli settlers under the protection of Israeli Occupation Army stormed Joseph tomb in Nablus city and performed rituals and prayers

#### Home Demolition and Demolition Threats

 The Israeli Army Bulldozers demolished 20 square meters house owned by Ahmad Amer Al-Haliyeh in Al Fheidat neighborhood, located near "Anatot" settlement east of 'Anata town in Jerusalem city under the pretext of being built without permits.

- The Israeli Occupation Army demolished 6 bruxes in Wa'er Al Biek area in 'Anata town east of Jerusalem city. The demolished structures are owned by; Jebril Mohamad Sliman Jahalin (5 members), Yousef Mohamad Sliman Jahalin (8 members), Ahmad Mohamad Sliman Jahalin (5 members), Mussa Mohamad Sliman Jahalin (8 members), Jamila Mohamad Sliman Jahalin (50 members), Mariam Khalil 'Ajram Jahalin (5 members). Also the IOA attacked and beat Yousef one of the owners while coming back from his work.
- The Israeli Occupation Army handed out demolition orders to 8 local residents of Al 'Aqba village in Tubas. The demolition orders targets agricultural structures and bruxes under the pretext of lacking building permits. The owners of threatened structures are; Akram Mohammad Saleh Abd Al-Karim, Ma'moun Mustafa Dibk, Ahmad Mahmud Talib, Khaild Mahmud Talib, Iyad Fayad Diebk, Daef Allah Odeh, Na'el Mohammad Abd Al-Karim.
- The Israeli Occupation Army served citizens from Kheleh Abu Baiyda in Bani Na'im town east of Hebron city military orders to demolish Shuhada al-Haram school, and 3 house under the pretext of lacking valid building permits building permits due to its location in area "C". the orders were handed to Haroun Taraera who owns two storeys house and 360 square meters store, the house of Shehda Sliman Yacoub Taraera and is composed of 2 storeys, a store and 4 rooms, and the house of Nafez 'Atieh Ziydat.

#### **Others**

• In a statement by the PLO Department of International Relations said that Israel approved the building of 734 housing units in East Jerusalem settlements and confiscated 1367 dunums of land in and around the occupied city since the beginning of 2012. The statement added that settlement activities in East Jerusalem come in the wake of the Israeli government's policy to Judaize and annex the city and make any political solution impossible. The statement said the international community is overlooking Israeli practices and settlement escalation in Jerusalem, which emboldens the Israeli occupation and measures against Palestinian residents of the city. It demanded the international

community to force Israel to abide by international law when dealing with the occupied territories.
