Israeli Violations' Activities in the oPt

23 March 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- A number of Palestinian citizens from Zabuba village suffered from Gas Inhalation due to the Gas bombs that were fired by the Israeli Occupation Army (IOA) in the village. Th residents are: Zuhriya Jameel Nameq Jaradat (50years) and Muhammad Muhammad Jaradat (10 years). The IOA also raided Industrial workshops in Silat Ad Daher village searching for resident Terfa 'Ali Abu Khader and a number of stores in Al Fanduqimyia and Ya'bad villages.

- The Israeli Occupation Army detained resident Muhammad Mu'ayyed Metani (12 years) from Ya'bad village west of Jenin at Mevo Dotan checkpoint for more than two hours and interrogated him before sending him to the Palestinian Civil Administration Headquarter.
- The Israeli Occupation Army detained two brothers from Ya'bad village southwest of Jenin city for 9 hours in Mevo Dotan settlement illegally established on lands of the village. The detainees are Musa and Sami Abu Baker (20 and 18 years respectively).
- Residents Iz Ad Din Abdel Hafith Al Tamimi (15 years) and Osama Bilal Tamimi (16 Years) were injured during the weekly peaceful demonstration against wall and settlements in An Nabi Saleh village west of Ramallah city.
- Tens of Palestinians were injured during the weekly peaceful demonstration against wall and settlements that was held in Bil'in village west of Ramallah city.
- The Israeli occupation army attacked three Palestinian women participating in Al Ma'sara weekly peaceful demonstration against Wall and settlements and hindered activists from reaching the wall area. Of the attacked women, Fatima Breijiya was known.
- Israeli occupation army set up a sudden military checkpoint at the only road linking Hebron Governorate with the remaining Palestinian Governorate (Jerusalem-Hebron road (Bypass Road 60)) and detained a number of Palestinian cars driving on the road and checked in their ID cards.

Israeli settlers' violence

- Around 100 Israeli settlers of Otniel settlement raided a building in Bir Al Sabe' street in Hebron city after being closed by the Israeli occupation army. The settlers give the building the name "Otniel Ben Kinar Grave" and consider it as a "Holy and sacred Jewish place". It is worth mentioning that the house was inhabited by Palestinians and was occupied by settlers few years ago.

Arrests

- The Israeli Occupation Army (IOA) arrested resident Issa Hammad Sleibi (28 years) from his house and took him to unknown destination.

- The Israeli Occupation Authorities transferred the prisoner Ja'far Iz Ad Din (40 years) from 'Arraba village south of Jenin city to Administrative detention for six months.
- The Israeli occupation army arrested 8 Palestinian residents in the occupied Palestinian Territory, 6 of which are from Bethlehem Governorate and 2 from Hebron Governorate. The Israeli Occupation Army claimed that the arrestees were wanted by the Israeli occupation authorities.

Erection of Israeli checkpoints

- The IOA also set up a number of sudden checkpoints at the entrances of Al Fawwar Refugee camp in the south, An Nabi Younis in the north and Idhna town in the West.
- Tens of Israeli occupation army set up a sudden military checkpoint at Qana's valley entrance in Salfit Governorate and hindered Palestinian land owners' from reaching their lands under the pretext of opening the way for tens of Israeli settlers to tour in the valley and the springs' area.

Home Demolition & Demolition threats

- The Israeli occupation army handed resident Husam Kamal Shakarneh from Nahhalin village southwest of Bethlehem city an order to halt the construction at his 120 square meters house under the pretext of lacking building permits. The house is inhabited by 7 family members and is located in 'Ein Al Balad area opposite to Betar Illit settlement.

Confiscation & Razing of lands

- Hundreds of Palestinian residents from Beit Iksa village southwest of Jerusalem city demonstrated for the third week against the lands threatened of confiscation due to the relocation of the checkpoint at the village's eastern entrance that will cause the isolation of more Lands of Beit Iksa village to Israel's proper.

Others

- Tens of Israeli settlers held a march calling for building the temple in place of Al Aqsa Mosque. The march started from Al Buraq wall southwest of Al Aqsa Mosque and moved towards the streets of Jerusalem's

Old city under the protection of Israeli soldiers and police. The march passed Al Qatanin doors, Al Hadid, Al Nather and Al Asbat, Al-Aqsa's Mosque external gates. Settlers chanted slogans and chants calling for the expulsion and killing of Arabs and building the temple mount in place of Al Aqsa Mosque. Settlers also knocked the doors of Palestinian houses in Al Wad Street and Bab Al Hadeed area.
