## Israeli Violations' Activities in the oPt

13 May 2012

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- A group of protesters demonstrated outside the entrance to Ma'ale Adumim settlement in support of prisoners on hunger strike. Dozens of local, international and Israeli activists carried Palestinian flags and signs in support of prisoners, blocking settlers from entering the area. Israeli border police arrived at the scene and arrested Saed Yaqin and Issam Marar. The protest was organized to protest settlement activity, settler violence and violations against prisoners. ## Israeli Settlers' Violence

- Israeli settlers of Havat Ma'on settlement uprooted tens of Olive Trees in At Tuwani area east of Yatta town south of Hebron city. The uprooted trees are owned by Ribhi Ahmad Jibrin Rib'I and Salman Jibrin Rib'i. Wafa (May 13, 2012).
- Israeli settlers of Beit 'Ayn settlement uprooted Olive and grape trees in Beit Ummer town north of Hebron city belong to Hammad Abdel Hameed Al Sleibi. Wafa (May 13, 2012).

## Others

- The Israeli Central Court in Jerusalem ordered to postpone the evacuation of Israeli settlers from the house they occupied Tel Al Rumeida neighborhood in Hebron city and belong to Al Bakri family until its next session which will be held after few weeks. Al Quds (May 13, 2012).
- Prime Minister Benjamin Netanyahu ordered the evacuation of a Hebron home taken by settlers last month after being informed that the expropriation of Palestinian homes and lands could complicate Israeli officials in war crimes litigation. [Haaretz](#) (May 13, 2012)
- Prime Minister Binyamin Netanyahu blocked a bill to fully extend Israeli law to West Bank settlements, which are now under Israeli military rule. MK Miri Regev (Likud) proposed the bill, which was defeated by 9 votes at the Ministerial Committee on Legislation. Only Tourism Minister Stas Meseznikov (Yisrael Beytenu) voted in favor of the legislation, which would have effectively annexed portions of Area C in the West Bank. [JPost](#) (May 13, 2012).
