

Israeli Violations' Activities in the oPt

6 October 2011

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

• The Israeli occupation Army raided Beit Ummar town north Hebron city and arrested 'Alam Yousef Bader Awad (17 years old), Saber Ibrahim Sabri Awad (15 years old), Malek Naef Hamad Slebi(16 years old) after searching their houses and mess with its contents.

Erections of Israeli Checkpoints

• The Israeli Occupation Army asset up military checkpoint in Al Nabi Youbis area at the northern entrance of Hebron city which obstructed the movement of vehicles.

Israeli settlers Violence Home

- Hundreds of Israeli settlers with the protection of Israeli occupation forces raided Yossef tomb in Nablus city.
- A group of extremist Israeli settlers uprooted 200 olive trees owned by residents of Qesra village south Nablus city. 100 of the uprooted trees owned by Fathallah Abu Reeda, 45 owned by Ghassan Hassan, 25 owned by Rizqallah Abu Reeda, and 22 trees owned by Tawfeeq Abu Hassan.

Demolition and Demolition Threats

- The Israeli occupation Army demolished under construction house owned by Amer Ahmad Hassan Barham in Beit Khael town northwest Hebron governorate The house is one floor with an area 140 square meters, the IOF has notified the house owner to demolish the house several months ago. Furthermore, the Israeli Army destroyed olive trees and the road that lead to the house as well the walls adjacent to the road.
- Israeli occupation forces demolished houses, barns and barracks owned by to Palestinian shepherds in Wadi Al-Maleh and Al-Hamma areas north of the Jordan Valley. The demolished structures owned by Ghaleb Ibrahim and Mahmoud Ayoub.

Israeli Military Orders

 The Israeli occupation Army handed notifications to evacuate and demolish 4 stalls owned by Amer Hassan Abu Zahu, Mohammad Abu Farha, Raek Anis Hassan Sha'ban and Ghasan Al-Deisi from Al Jumla village east Jenin city under the pretext of lacking building permits.

Confiscation and Razing of Lands

• Israeli occupation bulldozers started razing 15 dunmus of agricultural lands planted with olive, almonds trees owned by Khaled Mahmoud Al-'Adam in Beit Ulla village north west Hebron city and destroyed

retaining walls and barbed wire adjacent to the segregation wall. uprooted more than 100 Almond, Olives and figs trees in an attemp to resume wall constructions in the area. The razing process caused the uprooting 250 olive, almonds trees.
