Israeli Violations' Activities in the oPt 10 February 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) stormed Wadi Nanqar aream, west of Hebron city, and took photos for the area and the water wells. (Wafa 10 February 2016)
- Omar Younis Madi (15 years) was killed during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) at the entrance of Al Arroub refugee camp, north of Hebron city. (Wafa 10 February 2016)

- Israeli Occupation Army (IOA) and staff from the Israeli Natural Authority stormed a Palestinian land in Al 'Abbasiya neighborhood in Silwan town in Jerusalem city. The targeted land is owned by Khalid Az-Zeir. (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) raided Beit 'Ur At-Tahta village, west of Ramallah city and fired teargas and stun grenades at Palestinian houses. During the operation, the IOA closed the main entrance of the village. (Maannews 10 February 2016)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Tuqu village, northwest of Bethlehem city. The IOA fired live and rubber bullets, and teargas grenades, causing dozens of suffocation cases and the injury of 7 Palestinians. (RB2000 10 February 2016)
- Israeli Occupation Army (IOA) invaded Nahhalin village, southwest of Bethlehem city, and closed all the entrances. Clashes erupted between Palestinians and the IOA, where the IOA fired rubber bullets and teargas grenades at Palestinians. The IOA also, invaded and searched tens of Palestinian houses. (RB2000 10 February 2016)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Ein Al Louza neighborhood in Silwan town in Jerusalem city. The IOA fired rubber bullets, teargas and stun grenades, causing dozens of suffocation cases. (Maannews 10 February 2016)
- Israeli Occupation Army (IOA) stormed and searched a number of Palestinian houses in Ad-Duheisha refugee camp, south of Bethlehem city. Clashes erupted between Palestinians and the IOA, where the IOA fired live and rubber bullets, and teargas grenades. During the operation, the IOA arrested three Palestinians; identified as: Mohamad Zawahra, Mahmoud As-Switi and Ali Al Taws. The IOA confiscated a banner set up at the entrance of the camp. (Maannews 10 February 2016)

Israeli Arrests

- Undercover Israeli Army kidnapped Mohammad Sobhi Rayan after storming his workplace at the entrance of Beit 'Ur At-Tahta, west of Ramallah city. (Raya 10 February 2016)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming and searching their houses in Nahhalin village, southwest of Bethlehem city. The arrestees were identified as: Mahmoud Mohammad Najajrah (50 years) and his son Kadem (27 years), and Ahmed Jawdat Najajrah (22 years). (RB2000 10 February 2016)

- Israeli Occupation Army (IOA) arrested Iyad Hikmat Balawnah (31 years) after storming Tulkarm refugee camp, north of Tulkarm city and opened fire at him. (RB000 10 February 2016)
- Israeli Occupation Army (IOA) arrested Abed As-Salam Majed Abu Al Hija (40 years) after storming his house in Jenin refugee camp, west of Jenin city. Clashes erupted between Palestinians and the IOA, where the IOA fired metal bullets and teargas grenades at Palestinians. (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) arrested Daoud Salah Abu Halawa after storming his house in Hebron city. (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) summoned Mohammad Khalid Masalmah and Salem Ibrahim Masalmah Al Hroub to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding their houses in Beit 'Awa town, west of Hebron city. (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) arrested four Palestinians from Qalandiya refugee camp, north of Jerusalem city. The arrestees were identified as: Mohammad Azmi Matariya, Rajab Nu'man Matariya, Atef Na'em Matariya and Nassem Yahya Matariya. (Wafa & RB2000 10 February 2016)
- Israeli Occupation Army (IOA) arrested three Palestinians from Sur Baher town, south of Jerusalem city. The arrestees were identified as: Luqman Atwan (25 years), Mus'ab Aliyan (25 years) and Basel Turshan (25 years). (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) arrested four Palestinians from Al Issawiya town in Jerusalem city. The arrestees were identified as: Ahmed Abu Rumi (17 years), Ahmed Abu 'Awis (14 years), Adi Mustafah (15 years) and Adam Abu Shamalah (16 years). (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Hassan Wahesh after raiding his house in Abu Dis town, east of Jerusalem city. (Wafa 10 February 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Hamad from Al Eaziriya town, east of Jerusalem city. (Wafa 10 February 2016)

Home Demolition & Demolition threats

- Israeli Occupation bulldozers demolished three residential structures and an agricultural barracks in Arab Al Ka'abnah community, in Ash-Shuna area in Al Jiftlik village, north of Jericho city. The targeted structures inhabited by 25 Palestinians. (Wafa & Wattan 10 February 2016)

Israeli Military Orders

- Israeli Occupation Army (IOA) handed out orders to raze and close an agricultural road, and to demolish a water well in Qusra village, south of Nablus city. The targeted road established in land owned by: Samir Ibrahim Hassan, Mohammad Shukri Odeh, Abed Al Hakim Ahmed Wadi and Rabee Abed AL Aziz Hassan. During the operation, the IOA confiscated an agricultural tractor owned by Fathalla Abu Zeida. (Wafa 10 February 2016)

Israeli Closures

- Israeli Occupation Army (IOA) closed the farmer market in Beita village, south of Nablus city. and prevented Palestinians from entering it. Also, the IOA handed out a military order to close the market. (Kofia Press 10 February 2016)
