# Israeli Violations' Activities in the oPt 28 May 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats occupied Palestinian territory, in the the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) prevented Palestinians from entering their lands in Marj Ben Amir area, near the Israeli segregation wall at the western part of Al Yamun and Silat Al Harithiya villages, west of Jenin city. (NBPRS 28 May 2016)
- Israeli Occupation Army (IOA) opened fire at Palestinian houses located near the border fence and between Al Burij and Al Magahzi refugee camps in the Gaza strip. (PNN & Wafa 28 May 2016)

## Israeli Arrests

- Israeli Occupation Army (IOA) arrested Rami Hamdi Younis Al Junidi (33 years) after storming and searching his house in Hebron city. (Wafa 28 May 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Ghaleb Abed Al Qader Da'iss (21 years) from Bani Na'im village, east of Hebron city, after stopping him at Al Container military checkpoint. (Wafa 28 May 2016)

# Israeli Settler Violence

• Israeli settlers living in Pedu'el settlement razed Palestinian agricultural land in Deir Ballut village, west of Salfit city. (NBPRS 28 May 2016)

### Home Demolition & Demolition threats

• Israeli Municipality of Jerusalem forced Mohammad Younis Abu Tiyah to demolish his house in Ein Al Louza neighborhood in Silwan town in Jerusalem city. (Wafa 28 May 2016)

### Israeli Military Orders

• Israeli Municipality of Jerusalem handed out administrative orders to demolish two Palestinian houses in Ein Al Louza neighborhood in Silwan town in Jerusalem city. The arrestees were identified as: Mohammad Abu Tayha and Sha'ban Abu Tayha. (RB2000 28 May 2016)
