Israeli Violations' Activities in the oPt

07 December 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near Al Khadouri University campus, west of Tulkarm city. The IOA fired rubber bullets and teargas grenades, causing dozens of suffocation cases and the injury of three Palestinians. (Al-Quds 7 December 2015)
- Israeli Occupation Army (IOA) stormed and searched two Palestinian houses in Abud village, northwest of Ramallah city. One of the

- targeted house is owned by the family of the Palestinian martyr; Abed Ar-Rahman Wajeh Al Barghouthi. (Pal Today 7 December 2015)
- Israeli Occupation Army (IOA) raided and searched a Palestinian house in Silwad town, northwest of Ramallah city, and threatened the residents to demolish their house. The targeted house is owned by the family of the Palestinian martyr: Anas Hamed. (Pal Today 7 December 2015)
- Israeli Occupation Army (IOA) stormed and searched a Palestinian house in Al Mughayyir village, northeast of Ramallah city, and destroyed the house consist. The targeted house is owned by the family of the Palestinian prisoner in the Israeli jail; Bassem An-Na'ssan. During the operation, the IOA arrested Bassel Munir and transferred him to unknown location. (Pal Today 7 December 2015)
- Israeli Occupation Army (IOA) stormed a Palestinian house owned by the family of the Palestinian prsione in the Israeli Jail; Abed Al Azizi Hamad Mara'I, in Qarawat Bani Hassan village, north of Salfit city and notified them that the IOA will demolish their house. (Pal Today 7 December 2015)
- Israeli Occupation warplanes launched missiles at an area in Az-Zaytoun neighborhood, south of Gaza city. (Maannews & RB2000 7 December 2015)
- Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing at As-Sudaniya shore, northwest of Gaza city. (Safa 7 December 2015)
- Israeli Occupation Army (IOA) assaulted and injured Ghadir Ahmed Sharqawi (45 years) and Mohammad Jamal Ash-Shalabi after storming and searching their houses in Jein refugee camp, west of Jenin city. (Wafa 7 December 2015)
- Israeli Occupation Army (IOA) confiscated tools and machine used to construct a road in the Palestinian nature reserve, east of Bethlehem city. (Wafa 7 December 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Beit Hanina town, north of Jerusalem city, after the IOA invaded a house owned by the family of the Palestinian martyr Ameer Iskafi and arrested his father. The IOA fired rubber bullets, and teargas and stun grenades at Palestinians. (Wafa 7 December 2015)

Israeli Arrests

• Israeli Occupation Army (IOA) arrested five Palestinians after storming and searching their houses in Qalqiliyah city. The arrestees were identified as: Abed Al Hadi Ahmed Qashta (18 years), Tareq

- Nehad Abu Mustafah (16 years) and his brother Nabil (24 years), Ahmed Ghazi Qar'an (18 years) and Haitham Diyab Ameer (16 years). (Orient FM 7 December 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming and searching their houses in Al Issawiya town in Jerusalem city. The arrestees were identified as: Nassem Rabah Khalid Muhseen (15 years), Rami Nasser Ismail Muhseen (17 years) and Nassem Amjad Muhseen (17 years). (SilwanIC 7 December 2015)
- Israeli Occupation Army (IOA) arrested Ibrahim Salah Al Julani and Muaz Ash-Shilwadi after raiding their houses in Silwan town in Jerusalem city. (SilwanIC & Wafa 7 December 2015)
- Israeli Occupation Army (IOA) arrested Amran Shqirat (21 years) from Jerusalem city. (SilwanIC 7 December 2015)
- Israeli Occupation Army (IOA) summoned Muhannad 'Amarnah from Yabad town, west of Jenin city, to interview the Israeli Intelligence Police. (ARN 7 December 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searching their houses in Jenin refugee camp, west of Jenin city. The arrestees were identified as: Lutfi Mohammad Abu An-Naser and Mohammad Ash-Shalabi. During the operation, the IOA invaded and searched three houses. The targeted houses are owned by: Rakan Al Ashqar, Ala Abu Khalifah and Al Wadhan family. (Wafa 7 December 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming their houses in Halhul town, north of Hebron city. The arrestees were identified as: Laith Bajes Al Bo (16 years) and his brother Ahmed (13 years), and Rasdhid Ali Abu 'Asbah (13 years). (Wafa 7 December 2015)
- Israeli Occupation Army (IOA) arrested Kayed Mohammad Al Yamini (29 years) after storming and searching his house in Khallit Hadour neighborhood in Hebron city. (Wafa 7 December 2015)
- Israeli Occupation Army (IOA) arrested Aktam Yousif Hassan Akhalil (25 years) after storming his family house in Beit Ummer town, north of Hebron city. (Wafa 7 December 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming and searching their houses in JuraT Ash-Sham'a village, south of Bethlehem city. The arrestees were identified as: Zuhair Fesal Hassan (32 years), Mustafah Mohammad Odeh (25 years) and Waleed Ameen 'Adawiya (22 years). (RB2000 7 December 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding their houses in Qaryut village in Nablus governorate. The arrestees were identified as: Mohammad Suliman Hassan and Ghanem Mahmoud Abdalla. (RB2000 7 December 2015)

- Israeli Occupation Army (IOA) arrested Qatebah Azam after raiding his house in Sabastiya village, northwest of Nablus city. (RB2000 7 December 2015)
- Israeli Occupation Army (IOA) summoned Sharaf Ad-Diyn Yassen Abu Salem (19 years) and Muhannad Ayed Abu 'Akir (35 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding their houses in Ayda refugee camp, north of Bethlehem city. (RB2000 7 December 2015)
- Israeli Occupation Army (IOA) summoned Mohammad Ali 'Abayat (18 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding his family in Al 'Abayat area, east of Bethlehem city. (RB2000 7 December 2015)

Israeli Settler Violence

• Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al Aqsa mosque in Jerusalem city and toured in its courtyard. (Raya 7 December 2015)

Israeli Military Orders

 Israeli Occupation Authorities issued orders to demolish 12 Palestinian houses in An-Naqar neighborhood, west of Qalqiliyah city. (Maannews 7 December 2015)

Erection of Israeli checkpoints

 Israeli Occupation Army (IOA) erected military checkpoints at the northern entrance of Hebron city, and at the main entrance of Sair and Halhul towns, and Al Fawar refugee camp in Hebron governorate. The IOA stopped and searched Palestinian vehicles and checked ID cards. (Wfa 7 December 2015)

Israeli Closures

• Israeli Occupation Army (IOA) closed the main entrance of Ash-Shuhada street in the central of Hebron city. The IOA prevented Palestinians from entering or leaving the area by using the aforementioned entrance. (Pal Today 7 December 2015)
