Israeli Violations' Activities in the oPt

14 May 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Bethlehem city. The IOA fired live bullets and teargas grenades, causing dozens of suffocation cases and the injury of a Palestinian. During the clashes, the IOA arrested a Palestinian. (PNN 14 May 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian farmers while they were working in their land, east of Ash-Shuja'ahiy neighborhood, east of Gaza strip. (Al-Quds 14 May 2015)

- Israeli Occupation Army (IOA) opened fire at Palestinian farmers while they were working in their land, north of Beit Hanoun town, north of Gaza strip. (Al-Quds 14 May 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Nasser Musa Hassan An-Naqib while he was in Askar refugee camp in Nablus city. (Shasha News 14 May 2015)
- Israeli Occupation Army (IOA) arrested Saddam Salem Ali Ka'abnah (25 years) while he was at Frush Beit Dajan village in Nablus governorate. (Al-Quds 14 May 2015)
- Israeli Occupation Army (IOA) arrested Ahmed Hussam Al Faqeh (22 years) from Iraq Burin village, south of Nablus city. (Al-Quds 14 May 2015)
- Israeli Occupation Army (IOA) arrested a Palestinian from Bab Al Amud area in Jerusalem city. (Wafa 14 May 2015)
- Israeli Occupation Army (IOA) arrested three Palestinian from Wadi Al Far'a village, southwest of Tubas city. The arrestees were identified as: Bashar Abed Jabar Barahma, Fares Ibrahim Fayad Salahat and Mohammad Faez Fawzi Hanajrah. (Wattan 14 May 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Deir Samit village in Hebron governorate. One of the arrestees was identified as Mohammad Fadel Abu Hamad (18 years). (Wattan 14 May 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians from Beitillu village, north of Ramallah city. The arrestees were identified as: Wasfi Ismail Bazar, Basel Asad Darwesh and Muhdi Maher Rayan. (Wattan 14 May 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Al-Khader village, southwest of Bethlehem city. The arrestees were identified as: Tareq Al-Jahallen (19 years) and Zeiyad Wael Issa (19 years). (RB2000 14 May 2015)
- Israeli Occupation Army (IOA) summoned Fadi Jihad Adaween (22 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming his house in Al-Azza refugee camp, north of Bethlehem city. (RB2000 14 May 2015)
- Israeli Occupation Army (IOA) arrested Wafa Muayyad Ahmed Qabha (23 years) from Tura Al Gharbiya village, west of Jenin city, after stopping him at sudden checkpoint erected by the IOA near the village. (Mawwal 14 May 2015)
- Israeli Occupation Army (IOA) arrested Farhan Nader Ar-Rajabi (10 years) from the old city Hebron. (Wafa 14 May 2015)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al Aqsa mosque in Jerusalem city, and toured in its courtyard. (ARN 14 May 2015)

Expansion of settlements

- Israeli Minister of Housing and Planning published tenders to construct 85 housing units in Giv'at Ze'ev settlement, north of Jerusalem city, and published tenders to market land in Jabal Al Mukabbir town, south of Jerusalem city, to construct 1500 hotel rooms. (Wafa 14 May 2015)
