## Israeli Violations' Activities in the oPt

03 October 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) after the IOA stormed and searched dozens of Palestinian houses in several areas in Nablus city. The IOA fired live and rubber bullets and teargas grenades, causing dozens of suffocation cases and the injury of 10 people. During the clashes, the IOA stormed Palestinian houses and arrested 12 Palestinians. The arrestees were identified as: Abed AL Karem Muna, Rasem Khatab, Ragheb 'Alyol, Zahi Al Kusa, Samir Al Kusa, Abdalla Al Kusa, Bassam Abu Ghazala, Rashid Abed,

Issa Ghilani, Abed Ar-Rahman Al Haj Hamad and Yahya Al Haj Hamad. (Wafa & Wattan 3 October 2015)

- Israeli Occupation Army (IOA) prevented Palestinians from entrain Al Aqsa mosque in Jerusalem city. (Al-Quds 3 October 2015)
- Israeli Occupation Army (IOA) stormed Huwara village, south of Nablus city and forced Palestinians to close their commercial structures. (Al-Quds 3 October 2015)
- Rani Naim At-Tamimi (8 years) was injured after the Israeli Occupation Army (IOA) fired stun grenades at him while he was at the courtyard of his house in Al Issawiya town in Jerusalem city. (Maannews 3 October 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian houses and land, located near the border fence, east of Al Maghazi refugee camp in the central of Gaza strip. (RB2000 3 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the eastern entrance of Qalqiliyah city. The IOA fired rubber bullets, teargas and stun grenades at Palestinians, causing dozens of suffocation cases and the injury of Amir Zahran (15 years). During the clashes, the IOA arrested two Palestinians, identified as: Kamal Taher Harb (15 years) and Ghazi Ashraf Jalo (13 years). (Wafa 3 October 2015)
- Israeli Occupation Army (IOA) assaulted and injured two Palestinians while they were crossing the Israeli checkpoint erected at the entrance of Beit Iksa village, northwest of Jerusalem city. The Palestinians were identified as: Anas Anwar Zayed and Abdalla Alqam. (Wafa 3 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Ash-Dhaher area in Beit Ummer town, north of Hebron city. The IOA fired teargas and stun grenades at Palestinians and houses, causing dozens of suffocation cases. (Al-Quds 3 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near Al Jalazoun refugee camp, north of Ramallah city. The IOA fired teargas and stun grenades at Palestinians and houses. (Al-Quds 3 October 2015)
- Muhannad Shafeq Halabi (19 years) from Al Bireh city was killed after the Israeli Occupation Army (IOA) opened fire at him while he was near Bab Al Asbat in the old city of Jerusalem. (Al-Quds 3 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the entrance of Khursa village, southwest of Hebron city. The IOA fired teargas and stun grenades at Palestinians, causing dozens of suffocation cases. (Al-Quds 3 October 2015)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in At-Tabaqa village, southwest of Hebron city. The IOA fired teargas and stun grenades at Palestinians. (Al-Quds 3 October 2015)

### **Israeli Arrests**

- Israeli Occupation Army (IOA) arrested Mahmoud Yonis Abu Shamsiya (15 years) from Silwan town in Jerusalem city, while he was in the old city of Jerusalem. (Al-Quds 3 October 2015)
- Israeli Occupation Army (IOA) arrested a Palestinian after stopping him at Za'tara military checkpoint, south of Nablus city. (RB2000 3 October 2015)
- Israeli Occupation Army (IOA) shoot and injured a Palestinian while he was near the border fence, east of the central part of Gaza strip. Then, the IOA arrested him. (Al-Quds 3 October 2015)
- Israeli Occupation Army (IOA) stormed the courtyard of Al-Aqsa mosque in Jerusalem city and arrested 30 Palestinians. (Al-Quds 3 October 2015)
- Israeli Occupation Army (IOA) detained tens of Palestinian vehicles after stopping them at an Israeli military checkpoint erected near Shavi Shomron settlement. (Al-Quds 3 October 2015)

### **Israeli Settler Violence**

- Israeli settlers escorted by the Israeli Occupation Army (IOA) cut a number of olive trees in Kafr Ad-Dik village in Salfit governorate. (Al-Quds 3 October 2015)
- Yosif Bayan At-Tabib (6 years) was injured after an Israeli settler opened fire in Izbat At-Tabib village, east of Qalqiliyah city. (Maannews 3 October 2015)
- Israeli settlers stormed a Palestinian park in Al Karmel village, east of Yatta town, south of Hebron city and assaulted the guard; Jaser Hassan Hazazrah (63 years). (Wafa 3 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at the northern entrance of Sinjil village, north of Ramallah city. as a result, clashes erupted between Palestinians and the IOA, where the IOA fired rubber bullets, teargas and stun grenades at Palestinians, causing dozens of suffocation cases (Al-Quds & Wafa 3 October 2015)
- Israeli settlers torched Palestinian agricultural lands at Al Lahef and At-Tira areas in Huwara village, south of Nablus city. (Wafa 3 October 2015)
- Israeli settlers living in Yetzhar and Bracha settlements escorted by the Israeli Occupation Army (IOA) attacked Palestinian houses and land in

Burin village, south of Nablus city and torched agricultural land planted with olive trees. Clashes erupted between Palestinians and the IOA, where the IOA fired live and rubber bullets and teargas grenades at Palestinians, causing dozens of suffocation cases. (Al-Quds 3 October 2015)

- Israeli settlers hurled stones at a Palestinian vehicle in Huwara village, south of Nablus city. As a result, Sa'da Shahada (42 years) and her daughter Yara (18 years) were injured. (Wafa 3 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at Ramallah-Nablus road, near Al Lubban Ash-Sharqiya village, south of Nablus city.
- Israeli settlers escorted by the Israeli Occupation Army (IOA) attacked two Palestinian houses at the northern entrance of Al Bireh city. The targeted houses are owned by: Al Harini and Mu'awad families. Clashes erupted between Palestinians and the IOA, where the IOA fired rubber bullets, teargas and stun grenades at Palestinians, causing the injury of Ala Alawnah. (Al-Quds 3 October 2015)
- Israeli settlers attacked Palestinian houses in Beitin village, northwest of Ramallah city. a number of the targeted houses were damaged. (Al-Quds 3 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) tried to storm Sarra village, west of Nablus city. Clashes erupted between Palestinians and the IOA. (Al-Quds & Wafa 3 October 2015)
- Two Israeli settlers stormed Kafr Laqif village, east of Qalqiliyah city. (Wafa 3 October 2015)
- Israeli settlers raided Jit villages, west of Nablus city. (Wafa 3 October 2015)
- Israeli settlers living in Kiryat Arba settlement escorted by the Israeli Occupation Army (IOA) demonstrated in the central part of Hebron city and carried out provocative actions. (Wafa 3 October 2015)

### **Israeli Military Orders**

- Israeli Occupation Authorities issued a military order to demolish a Palestinian house in Askar refugee camp, east of Nablus city. The Israeli Authorities notified the family to evacuate their house within the next three days. The targeted house is owned by a Palestinian prisoner in the Israeli Jail Nour Ad-Diyen Khalid Abu Hashiya. (Al-Quds 3 October 2015)

### **Israeli Closures**

- Israeli Occupation Army (IOA) closed Huwara and Za'tara military checkpoints, south of Nablus city. (Al-Quds 3 October 2015)

## Other

- Defense Minister Ya'alon Awards Controversial Church to Settlement Bloc. Army radio reports that the area will be a tourist site — not a settler compound — in the Gush Etzion region. Defense Minister Moshe Ya'alon is awarding a controversial 10-acre church compound to the Gush Etzion settlement bloc in the West Bank, Army Radio reported Thursday. The former Presbyterian church has a strategic location: on Route 60, which runs north-south throughout the West Bank. A key issue is whether settlers would move to the compound, which sits between Hebron and Gush Etzion. Eight buildings dot the site. In late May, sources told Haaretz that a nonprofit group controlled by U.S. businessman Irving Moskowitz had bought the abandoned compound near the Arroub refugee camp between Hebron and Bethlehem. That reportedly happened three years ago, with the help of a Moskowitz ally on the Jerusalem city council, Aryeh King. In recent months, the purpose of renovations at the site was reportedly concealed from the Palestinian laborers. According to Army Radio, Ya'alon had no legal authority to stop the work; in any case, there were no immediate plans for people to move in, the station said. Instead, the site would be a tourist destination. A similar version was given last week to Palestinian news agency Ma'an by attorney Arieh Sokolovsky, but he said the land actually hadn't been sold and reports of a plan by settlers to move in were false. "The church owns the land and we're renovating buildings so that they can serve as a hostel for Jews, Muslims and Christians traveling in the area," he said. ([Haaretz](#) 3 October 2015)
