Israeli Violations' Activities in the oPt

07 October 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) surrounded a Palestinian house in Ras Khames area in Shufat refugee camp, north of Jerusalem city. (Sama News 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Turmus'ayya village, northeast of Ramallah city. The IOA fired live and rubber bullets, and teargas grenades, causing dozens of suffocation cases and the injury of a Palestinian. (Safa 7 October 2015)

- Israeli Occupation Army (IOA) assaulted a number of Palestinians and the family of the martyr; Fadi Aloun, while they were in the mourning tent erected by the family in Beit Hanina town, north of Jerusalem city. The IOA fired teargas and stun grenades at Palestinians. (SilwanIC 7 October 2015)
- Israeli Occupation Army (IOA) invaded and searched a Palestinian house in Battan Al Hawa neighborhood in Silwan town in Jerusalem city and assaulted the residents. As a result Suad Abu Rumoz was injured. (SilwanIC 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Tareq Ben Ziyad junction at the southern part of Hebron city. The IOA fired rubber bullets, teargas and stun grenades at Palestinians and houses, causing dozens of suffocation cases. (ARN 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Beit Einun area, south of Sair town, north of Hebron city. The IOA fired teargas grenades and rubber bullets at Palestinians. (ARN 7 October 2015)
- Two Palestinians were injured during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) in Qatanna village, northwest of Jerusalem city. The IOA attacked Palestinian by firing live bullets at them. (Wafa 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) around Bilal Ben Rabah mosque, at the northern entrance of Bethlehem city. The IOA fired teargas and stun grenades at Palestinians. (Wafa 7 October 2015)
- Israel Occupation Army (IOA) occupied a Palestinian house at Al Hawawra area, north of Halhul town, north of Hebron city, and transformed in to a military base. The targeted house is owned by Fathi Mohammad Mir'eb. Noted that the targeted house is located near the Israeli settlement of Karmeizur. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) raided and searched three Palestinians houses in Nablus city and questioned the residents. The targeted houses are owned by: Karam Rizeq Al Masri, Zied Ziyad Ameer and Yahya Al Haj Hamad. (RB2000 7 October 2015)
- Israeli Occupation Army (IOA) stormed a Palestinian neighborhood in the old city of Jerusalem. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) invaded and searched several areas and neighborhood in Birqin village, west of Jenin city. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) stormed a Palestinian house in Sur Baher town, south of Jerusalem city. The targeted house is owned by the family of a Palestinian girl who was injured after an Israeli settler

opened fire at her at Al Wad Street in the old city of Jerusalem. The IOA searched the house and assaulted the residents. Clashes erupted between Palestinians and the IOA, where the IOA fired teargas and stun grenades. (Maannews 7 October 2015)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near the Israeli settlement of Beit El. The IOA fired live bullets at Palestinians, causing the injury of two, one of them was seriously injured in his head. During the clashes, undercover Israeli Army kidnapped three Palestinian, one of them was identified as: Ahmed Hamed from Surda village, north of Ramallah city. (Maannews 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Budrus village, west of Ramallah city. The IOA fired teargas grenades and rubber bullets at Palestinians, causing dozens of suffocation cases. (Safa 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Ar-Ram town, north of Jerusalem city. The IOA fired rubber bullets and teargas grenades at Palestinians, causing a number of suffocation cases. (Raya 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the entrance of An-Nabi Saleh village, north of Ramallah city. The IOA fired rubber bullets and teargas grenades, causing dozens of suffocation cases. (RB2000 7 October 2015)
- Amjad Al Jundi (17 years) from Yatta town, south of Hebron city, was killed after the Israeli Occupation Army (IOA) opened fire at him. After the operation, the IOA stormed his family house and summoned his father and brother to interview the Israeli Intelligence Police. (Maannews 7 October 2015)
- 11 Palestinians were injured and dozens suffered gas inhalation during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) at Zif area, north of Yatta town, south of Hebron city. The IOA fired live and rubber bullets and teargas grenades at Palestinians. (Maannews 7 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the southern entrance of Jericho city. The IOA fired rubber bullets and teargas grenades, causing tens of suffocation cases and the injury of two Palestinians. (Al-Quds 7 October 2015)
- Israeli Occupation Army (IOA) invaded and toured in areas in Al Fasayil village, north of Jericho city. (Al-Quds 7 October 2015)
- A 30 years old Palestinian was injured after the Israeli Occupation Army (IOA) stationed at Za'im military checkpoint, north of Jerusalem

city, opened fire at him while he was crossing the checkpoint. (Al-Quds 7 October 2015)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the southern entrance of Qalqiliyah city. The IOA fired teargas grenades at Palestinians and houses, causing dozens of suffocation cases. (Al-Quds 7 October 2015)
- Dozens of Palestinians suffered gas inhalation during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) at Jabal Ar-Rahma area in Hebron city. The IOA attacked Palestinians by firing rubber bullets, teargas and stun grenades at them. During the clashes, the IOA stormed a number of Palestinian houses and occupied their roofs. (Al-Quds 7 October 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Ibrahim Ash-Shinar after raiding his house in Nablus city. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming and searching their houses in Al Lubban Ash-Sharqiya village, south of Nablus city. The arrestees were identified as: Abeda Ahmed 'Awes, Mustafah Mohammad 'Awes and Mahmoud Ali 'Awes. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested Hussien Mohammad Ma'rouf from Zawata village in Nablus governorate, after stopping him at Za'tara military checkpoint, south of Nablus city. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested five Palestinians after storming and searching their houses in Al Issawiya town in Jerusalem city. The arrestees were identified as: Diya Jarah, Ahme Atiya, Rami Abed, Qusai Dari and Mahmoud Mustafah. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested Khalid Jadalla after raiding his house in Sur Baher town, south of Jerusalem city. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested five Palestinians after storming and searching their houses in several neighborhoods in Hebron city. The arrestees were identified as: Amir Abu Rumoz (12 years), Adi Sharef Al 'Ajloni (13 years), Nasralla Abu Isninah (18 years), Yaser Abu Isninah (21 years), and Mohammad Anwar Al Atrash (11 years). (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested Ahmed Samir Husniya (21 years) after storming his house in Al Fawar refugee camp, south of Hebron city. (Wafa 7 October 2015)

- Israeli Occupation Army (IOA) arrested three Palestinians from Al Arroub refugee camp, north of Hebron city. The arrestees were identified as: Anan Al Kawamlah, Yousif At-Titi (19 years) and his brother Nasem (13 years). (Wafa 7 October 2015)
- Israeli Occupation Army (IAO) arrested five Palestinians after raiding their houses in Halhul town, north of Hebron city. The arrestees were identified as: Mohamad Al Barbarawi (23 years), Samer Az-Zama'rah (23 years), Adi Al Qawasmah, Mohamad Halmi Aqil and Samer Jamal Medya. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested Mutasem Suliman Ash-Sharawnah (17 years) from Dura town in Hebron governorate. (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested 7 Palestinians after storming and searching their houses in Beit Ummer town, north of Hebron city. The arrestees were identified as: Muhannad Al 'Awadi (26 years), Adi Fakhri Mohammad Ihsan (16 years), Ziyad Bahar (36 years), Basel Abu Hisham (21 years), Ala As-Slabi (26 years), Yousif Abu Hisham (22 years) and Mohammad Al 'alami (21 years). (Wafa 7 October 2015)
- Israeli Occupation Army (IOA) arrested 6 Palestinians during clashes that erupted between Palestinians and the IOA at Al Jalamah military checkpoint, north of Jenin city. Three of the arrestees were identified as: Mohammad Sha'ban, As'ad Qarqash and Thair Farha. (Wafa & Maannews 7 October 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after stopping them at Beit Hanun terminal, north of Gaza strip. The arrestees were identified as: Hamada, Talal and Samir Qasas. (Maannews 7 October 2015)
- Israeli Occupation Army (IOA) arrested a Palestinian during clashes that erupted between Palestinians and the IOA at Ras Al Joura area in Hebron city. (Al-Quds 7 October 2015)
- Israeli Occupation Army (IOA) arrested Faues Fawaz Barqan (15 years) after assaulting him while he was in front of his house in Ath-Thawri neighborhood in Silwan town in Jerusalem city. (Maannews 7 October 2015)

Israeli Settler Violence

- Israeli settlers carried out provocative actions at the main road link to Janba school in Janba village, east of Yatta town, south of Hebron city. (ARN 7 October 2015)
- Israeli settlers gathered at the entrance of Jit village, east of Qalqiliyah city and tried to storm the village, and attacked Palestinian houses. (RB000 & ARN 7 October 2015)

- Bilal M'amun Al Ja'bari (11 years) was injured after an Israeli settler hit him by his vehicle at Jabla Johar neighborhood in Hebron city. (Wafa 7 October 2015)
- Israeli settlers attacked Palestinian vehicles in Ash-Sheikh Jarah neighborhood in Jerusalem city. (Wafa & Wattan 7 October 2015)
- Israeli settlers gathered at Al Wadi street in old city of Jerusalem and closed it, and prevented Palestinians from opening their commercial structures in the aforementioned area. (Wattan 7 October 2015)
- Israeli settlers living in Ramot settlement punctured the tire of a Palestinian vehicle and attacked other in Beit Iksa village, northwest of Jerusalem city. The targeted vehicle is owned by Mohammad Khader Sader. (Wafa 7 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at Qaber Hilwa area, east of Beit Sahour town, east of Bethlehem city. clashes erupted between Palestinians and the IOA, where the IOA and the Israeli settlers fire live and rubber bullets at Palestinians, causing the injury of two Palestinians, one of them was seriously injured and identified as Mujahed Na'im Taha Abu Sarhan (18 years). The Israeli settlers also, hurled stones at Palestinian vehicle traveling near the aforementioned area. (Al-Quds & Wafa 7 October 2015)
- A 18 Palestinian girl was injured after an Israel settler opened fire at her while she was walking at Al Wadi street in the old city of Jerusalem. (SilwanIC & Wafa 7 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed and toured in the courtyard of Al Aqsa mosque in Jerusalem city. (Al-Quds 7 October 2015)
- Israeli settlers gathered at the entrance of Majdal Bani Fadel village in Nablus governorate, closed the entrance and tried to storm the village. Clashes erupted between Palestinians and the Israeli settlers. (Maannews 7 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at Qaber Hilwa area, east of Beit Sahour town, east of Bethlehem city, closed the road, hurled stones at Palestinian vehicles, chanted anti-Palestinian slogans and carried out provocative actions. (PNN 7 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at the entrance of Tuqu village, southeast of Bethlehem city, closed the entrance and hurled stones at Palestinian vehicles (RB2000 7 October 2015)
- Israeli settlers tried to kidnap Nedal Yousif Hamdan Al 'Alami (12 years) while he was at the entrance of Beit Ummer town, north of Hebron city. (Maannews 7 October 2015)

- Israeli settlers attacked Palestinian houses in Tal Ar-Rumidya neighborhood in the central of Hebron city. Clashes erupted between Palestinians and the Israeli settlers. (Maannews 7 October 2015)

Other

- State Won't Revoke Funding of Illegal West Bank Outpost, Despite Attorney General's Instructions. Over \$100,000 was given for infrastructure in Negohot, which has no building permits. 'Funds that were given illegally must be returned, and those responsible for the allocation should be prosecuted,' incensed Meretz chairwoman says. The Justice Ministry will not work to cancel an allocation of hundreds of thousands of shekels to build infrastructure for the Negohot outpost in the western Hebron Hills, even though the funding contravenes the attorney general's instructions as the settlement has no building permits, Deputy Attorney General Dina Zilber has said. Zilber recently informed MK Zehava Galon of Meretz of the ministry's position, although Galon had first protested the 400,000 shekel (\$105,000) allocation two years ago. The funding came from the World Zionist Organization's Settlement Division, which is controlled by the Agriculture Ministry. Zilber said the Justice Ministry would only make sure that such allocations no longer occur. The Justice Ministry decided this year that the WZO's Settlement Division would no longer be allowed to fund third parties and that the government would be the only authorized body to transfer such funding. "Given the binding legal instructions in the legal opinion in general and on the issue of allocations by the Settlement Division in particular, I believe we have resolved the problem you indicate in your query," Zilber told Galon. Galon was incensed. "Funds that were given illegally must be returned, and those responsible for the allocation should be prosecuted," she said. "An absurd situation has emerged in which the sinner is rewarded, and the legal opinions of the attorney general become meaningless. "By ignoring the blatant violation of the law according to the legal opinion that came from his own office, the attorney general is undermining his authority to interpret the law for government agencies," the Meretz chairwoman continued. "Transferring funds from the state to perform work without a permit or master plan is a criminal offense and the attorney general's turning a blind eye makes a mockery of the law". At the same time, another opposition MK, Eitan Broshi of Zionist Union, called on party leader Isaac Herzog to cooperate with Likud in drawing up a clear planning policy in the settlements. According to Broshi, encouraging construction in the settlement blocs, those areas it is assumed will

remain under Israeli control if an agreement with the Palestinians is ever reached, would reduce the Jewish presence in isolated areas that will make it difficult to ever separate into two states. According to Broshi's data, the number of Israelis living outside the blocs rose from 18,000 in 1993 to 110,000 in 2014. During the past six years, the number of housing starts in the isolated settlements has risen to 40 percent of all West Bank housing starts. A policy of containment, he said, would "demonstrate the government's commitment to the two-state solution, reduce the escalating friction, conserve resources and strengthen the Israeli presence in the central blocs".
