Israeli Violations' Activities in the oPt

30 October 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Al Malol area in Yabad town, west of Jenin city. The IOA fired teargas and stun grenades at Palestinians. (Pal Info 30 October 2015)
- Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing at Az-Zudaniya shore, northwest of Gaza strip. (Wattan 30 October 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian farmers while they were working in their land which located near the border

fence, east of Jabaliya refugee camp, north of Gaza strip. (Wattan 30 October 2015)

- Israeli Occupation Army (IOA) invaded and searched the Palestinian houses in Tal Ar-Rumida neighborhood and Ash-Shuhada street in the central of Hebron city, and census the residents. Noted that the IOA declared the aforementioned areas as “closed military areas”. (Maannews & Wafa 30 October 2015)
- Two Palestinian were injured and tens suffered gas inhalation after the Israeli Occupation Army (IOA) attacked the weekly non-violent protest against the segregation wall and settlements in Bilin village in Ramallah governorate. The IOA used live, sponge and rubber bullets, and teargas grenades to attack the participants. (Wafa 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the eastern entrance of Silwad town, northeast of Ramallah city. The IOA fired rubber bullets and teargas grenades, causing dozens of suffocation cases and the injury of three Palestinians. (Wafa 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Al Arroub refugee camp, north of Hebron city. The IOA fired teargas and stun grenades at Palestinians and their houses, causing tens of suffocation cases. (RB2000 30 October 2015)
- Israeli Occupation Army (IOA) forced the owner of commercial structures in the central of Huwara village, south of Nablus city, to closed their structures. (RB2000 30 October 2015)
- Israeli Occupation Army (IOA) tightened its procedures in the old city of Hebron and prevented the Palestinians under the age of 25 years from entering the Ibrahimi mosque. Noted that the IOA fired teargas and stun grenades at Palestinians while they were leaving the mosque, causing a number of suffocation cases. (RB2000 & Maannews 30 October 2015)
- Israeli Occupation Army (IOA) stormed and searched a Palestinian houses in Jenin city, and questioned the residents. The targeted house is owned by Moayyad Abu Samidi. (RB2000 30 October 2015)
- Israeli Occupation Army (IOA) raided and searched a Palestinian in Hebron city and questioned the residents. The targeted house is owned by the family of the Palestinian martyr; Farouq Sider. During the operation, the IOA erected a military checkpoint near the targeted house, stopped and searched Palestinian vehicles and checked ID cards. (RB2000 30 October 2015)
- Two Palestinians were injured and tens suffered gas inhalation during clashes that erupted between Palestinians and the Israeli Occupation Army (IOA) in Al Naqar neighborhood, west of Qalqiliyah city. The

IOA fired rubber bullets and teargas grenades at Palestinians and their houses. (RB2000 30 October 2015)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Al Khader village, southwest of Bethlehem city. The IOA fired teargas grenades and rubber bullets at Palestinians. During the clashes, the IOA fired rubber bullets at a Palestinian Ambulance. (Orient FM 30 October 2015)
- Israeli Occupation Army (IOA) stationed at the eastern part of An-Nabi Saleh village, north of Ramallah city, opened fire at Palestinian houses. (Orient FM 30 October 2015)
- Israeli Occupation Army (IOA) attacked the weekly non-violent protest against the segregation wall and settlements in Kafr Qaddum village, east of Qalqiliyah city. The IOA fired rubber bullets and teargas grenades at Palestinians, causing a number of suffocation cases. (PNN 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near the border fence, east of Khan Younis city, south of Gaza strip. The IOA fired live and rubber bullets and teargas grenades, causing, a number of suffocation cases and the injury of others. (Al-Quds 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) near the border fence, east of Gaza city. The IOA used live and rubber bullets and teargas grenades to attack Palestinians. (Al-Quds 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Beit Hanun terminal, north of Gaza strip. (Al-Quds 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Bethlehem city. The IOA fired rubber bullets and teargas grenades, causing dozens of suffocation cases and the injury of 8 Palestinians. (Wafa & Al-Quds 30 October 2015)
- Israeli Occupation Army (IOA) shoot and killed Qassem As-Saba'nah (20 years) from Qabatiya village, south of Jenin city, and injured Feras An-Na'san (17 years) from Al Mughayyir village in Ramallah governorate, while they were crossing Za'tara military checkpoint, south of Nablus city. (Al-Quds 30 October 2015)
- Israeli Occupation Army (IOA) invaded and searched tens of Palestinian houses in Kharbatha Al Misbah village, west of Ramallah city. (Al-Quds 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Ras Al Joura neighborhood in Hebron city. The IOA fired live and rubber bullets and teargas grenades at Palestinians, causing tens of

- suffocation cases and the injury of 18 people; 7 of them were injured by the live bullets. (Maannews 30 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at Tareq Ben Ziyad area at the southern part of Hebron city. The IOA fired live and rubber bullets, and teargas grenades, causing tens of suffocation cases and the injury of four Palestinians. (Maannews 30 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Beit Ummer town, north of Hebron city. The IOA fired rubber bullets, teargas grenades, and wastewater at Palestinians and their houses, causing dozens of suffocation cases and the injury of 10 Palestinians. During the clashes, the IOA arrested Samer Mohammad Daoud (23 years) after assaulting him. (Maannews 30 October 2015)
 - Israeli Occupation Army (IOA) shoot and killed Ahmed Hamada Qanibi (23 years) from Kafr Aqab village, north of Jerusalem city, while he was at Ash-Sheikh Jarrah neighborhood in Jerusalem city. (SilwanIC & Maannews 30 October 2015)
 - Israeli Occupation Army (IOA) killed Ramadan Mohammad Fesal Thawabta (8 month) after firing a number of teargas grenades at his family house in Beit Fajjar village, south of Bethlehem city, during clashes that erupted between Palestinians and the IOA, where the IOA fired teargas grenades and rubber bullets at Palestinians and their houses, causing tens of suffocation cases and the injury of three Palestinians, two of them were arrested by the IOA. (Wafa & Maannews 30 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Al Ba;o' neighborhood, north of Al Bireh city. The IOA fired live and rubber bullets and teargas grenades, causing tend of suffocation cases and the injury of 37 Palestinians, included 4 journalists and 4 Ambulance officers. Also, an Israel jeep ran over a Palestinian, identified as: Mahir Al Faroukh, and arrested him. The IOA prevented the Palestinian ambulance and medic officers from reaching him and fired paper gas on their faces. The IOA also assaulted a Palestinian journalist, identified as: Muaz Al Khateb, and detained him for a few hours. (Maannews 30 October 2015)
 - Israeli Occupation Army (IOA) isolated As-Salamiah neighborhood in the old city of Hebron, after closing all the entrance of the neighborhood expect one they erected a military checkpoint on it. (Maannews 30 October 2015)
 - Israeli Occupation Army (IOA) intensified its presence between Al Arroub refugee camp and Bani Naim town in Hebron governorate. (RB2000 30 October 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in At-Tur town in Jerusalem city. The arrestees were identified as: Fahed Abu Isbitan and Omar Mu'amar Abu Al Hawa. (SilwanIC 30 October 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after stopping them at an Israeli checkpoint at Ras Al Amoud area in Jerusalem city. The arrestees were identified as: Mahmoud Sufian As-Sayad and Mohammad Al Malhi. (SilwanIC 30 October 2015)
- Israeli Occupation Army (IOA) arrested 6 Palestinians from several areas in Jerusalem city. The arrestees were identified as: Ali Muhessen, Akram Amjad Mustafah, Qusai Dari, Ahmed Kaswani, Ahmed Al Ghouh and Mahir Samer Sarhan. (SilwanIC 30 October 2015)
- Israeli Occupation Army (IOA) summoned Mohammad Abed Al Ghani Nasef Abu Nasef (32 years) from Jenin city, to interview the Israeli Intelligence Police in Salem military base, after stopping him at Al Karam terminal. (RB2000 30 October 2015)
- Israeli Occupation Army (IOA) arrested Hussam Al 'Aloul (41 years) after raiding and searching their houses in Nablus city. (Al-Quds 30 October 2015)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) prevented a Palestinian family (Abu Nab family) from entering their house in Batan Al Hawa neighborhood in Silwan town in Jerusalem city. Abu Nab house located within the houses that the Israeli settlers occupied in the last few months. (SilwanIC 30 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) surrounded a Palestinian house in Ash-Shalalah street in Hebron city. The Israeli settlers occupied the roof of the house and chanted anti-Palestinian slogans. The targeted house is owned by Mufed Ash-Sharbaty. (RB2000 30 October 2015)

Israeli Military Orders

- Israeli Municipality of Jerusalem handed out administrative orders to demolish two Palestinian houses in Jabal Al Mukabir town, south of Jerusalem city. The targeted houses are owned by: the family of the Palestinian martyr; Ala Abu Al Jamal, and his brother Mohammad Abu Al Jamal. (SilwanIC 30 October 2015)

Expansion of settlements

- **IDF legalizes homes in four West Bank settlements. Samaria Regional Council head Yossi Dagan has lobbied for the legalization, since taking office over the summer.** A Civil Administration committee approved retroactive zoning plans for four West Bank settlements, a move which legalized already existing homes in the authorized communities. Two of the settlements, Sansana (97 housing units) and Yakir (377 housing units) are inside the route of the security barrier and the other two, Shiloh (94 housing units) and Itamar (187 housing units) are considered to be isolated settlements outside of the fence. Samaria Regional Council head Yossi Dagan had lobbied for the legalization since taking office over the summer. He made the request during his first phone conversation with Prime Minister Benjamin Netanyahu and he continued to lobby for it, particularly after Palestinian gunmen killed Eitam and Na'ama Henkin as they drove home in his region with their four children on October 1. Dagan was startled when their death was not followed by an announcement of more building. The absence of new settler building approvals was one of the factors that swayed him to pitch a protest tent in front of Netanyahu's office. He was particularly concerned by Netanyahu's failure to authorize a zoning plan for the Itamar settlement in Samaria despite pledging to do so after Palestinians infiltrated that community in 2011 and killed five members of the Fogel family. A source close to Dagan said that he took down the protest tent only after securing a promise from Netanyahu to approve the Itamar zoning plan. On Thursday, Dagan said that the approvals right a small injustice that had been done to the residents of Judea and Samaria, because without the zoning planes, the homeowners lacked full rights with regard to their properties. The buildings fell into a gray legal area because they were constructed in recognized settlements but had not been fully approve because of the absence of a zoning plan. Those who live in Judea and Samaria, "give their all to the State of Israel and deserve the same right" as those who live in Tel Aviv and Ra'anana, Dagan said. Peace Now executive director Yariv Oppenheimer said that, once again, Netanyahu has proved that he prefers settlers to peace. "Once again Netanyahu has caved to the settlers. He approved building just to get rid of one protest tent," Oppenheimer said. ([IPOST](#) 30 October 2015)

Erection of Israeli checkpoints

- Israeli Occupation Army (IOA) erected a military checkpoint at the western entrance of Hebron city. The IOA stopped and searched Palestinian vehicles, checked ID cards and detained Abed Ar-Rahem Imresh. (RB2000 30 October 2015)
- Israeli Occupation Army (IOA) detained a number of Palestinian vehicles at the northern entrance of Beit Einun village, north of Hebron city. (RB2000 30 October 2015)

Israeli Closures

- Israeli Occupation Army (IOA) closed the western entrance of Nablus city. The IOA stopped and searched Palestinian vehicles and detained four Palestinians. (Pal Today 30 October 2015)
- Israeli Occupation Army (IOA) closed the emergency center in Hebron city, and prevented the Palestinians from entering or leaving it. Noted that a number of the center workers were inside it when the IOA closed it, where they prevented them from leaving the center. (Maannews 30 October 2015)
