Israeli Violations' Activities in the oPt 28 February 2015

 \mathbf{T} he daily report highlights the violations behind Israeli home demolitions and demolition threats occupied Palestinian territory, in the the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

- Israeli Occupation gunboats opened fire at three Palestinian fishing boats while they were sailing at As-Sudaniya shore, northwest of Gaza city. (Al-Quds 28 February 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian farmers and land, east of Malaka area and Juhr Ad-Dik town in Gaza strip. (Al-Quds 28 February 2015)
- Israeli Occupation Army (IO) tightened its procedures at Za'tara and Huwara military checkpoints, south of Nablus city. The IOA stopped

and searched Palestinian vehicles and checked ID cards. (Maannews 28 February 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested a Palestinian while he was near the Ibrahimi mosque in the old city of Hebron. The IOA transferred the arrestee to unknown location. (Al-Quds 28 February 2015)
- Israeli Occupation Army (IOA) summoned two Palestinians to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding their houses in Al-Ubidiya town, east of Bethlehem city. (Al-Quds 28 February 2015)
- Israeli Occupation Army (IOA) detained Nu'man Hamdan and Akrama Hamdan while they were working in their land in Al-Jab'a village, southwest of Bethlehem city. (Al-Quds 28 February 2015)

Erection of Israeli checkpoints

• Israeli Occupation Army (IOA) erected military checkpoints at the entrance of Sair and Halhul towns in Hebron governorate. The IOA stopped and searched Palestinian vehicles and checked ID cards. (Al-Quds 28 February 2015)
