Israeli Violations' Activities in the oPt 27 January 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats occupied Palestinian territory, the in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded and searched a Palestinian house in Tubas city, and questioned the residents. The targeted house is owned by Mohammad Abu Muhseen. (Wattan 27 January 2015)
- Israeli Occupation Army (IOA) stormed and searched a Palestinian house in Deir Abu D'aif village, east of Jenin city, and questioned the residents. The targeted house is owned by Othamn Rida Yassen. (Zamn Press 27 January 2015)

- Israeli Occupation Army (IOA) raided and toured in several neighborhoods and areas in Yabad, Qabatiya, Az-Zababida, Misliya, Jalqamus, Al-Mughayyir and Um At-Tut villages in Jenin governorate. (Zamn Press 27 January 2015)
- Israeli Occupation Army (IOA) and bulldozers staged into the eastern part of Rafah city, south of Gaza strip, razed Palestinian land and opened fire at houses. (Al-Quds 27 January 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian houses and land at the eastern parts of Khan Younis city, south of Gaza strip. (Maannews 27 January 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Sameh Yacoub An-Natsha (17 years) from the old city of Hebron city. (Safa 27 January 2015)
- Israeli Occupation Army (IOA) arrested Anas Ash-Shilwadi (13 years) after storming his family house in the old city of Jerusalem. (Safa 27 January 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Silwan town in Jerusalem city. The arrestees were identified as: Bilal Al-'Awar (20 years) and Mohammad Al-Awar (17 years). (Safa 27 January 2015)
- Israeli Occupation Navy arrested four Palestinian fishermen after attacking their boats while they were sailing at Gaza shore. (Pal Info 27 January 2015)
- Undercover Israeli Army kidnapped Mohammad Said Awidat (10 years) while he was in front of his house in Shufat refugee camp in Jerusalem city. (Pal Info 27 January 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searching their houses in Bethlehem city. The arrestees were identified as: Sufyan Khalid Sabarnih (20 years) and Mu'een Mohammad Masalmah (18 years).(Zamn Press 27 January 2015)
- Israeli Occupation Army (IOA) arrested Nedal Hazem Ar-Rimawi (25 years) after storming and searching his house in Beit Rima village in Ramallah governorate. The IOA transferred the arrestee to unknown location. (Maannews 27 January 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians and summoned Hassan Ahmed Sha'lan and his father to interview the Israeli Intelligence Police, after storming and searching their houses in Azun village, east of Qalqiliya city. The arrestees were identified as: Ahmed Mustafah Kharfan (17 years), Malek Maskawi (27 years) and Ahmed Bassem Radwan (25 years). (Maannews 27 January 2015)

Israeli Settler Violence

- Israeli settlers prevented a number of Palestinian farmers from reaching their land in Al-Fureidis village, southeast of Bethlehem city. (Zamn Press 27 January 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Joseph tomb at the eastern part of Nablus city and performed Talmudic rituals. During the operation, clashes erupted between Palestinians and the IOA, where the IOA fired live bullets, teargas and stun grenades, causing dozens of suffocation cases and the injury of Bassem Zakariya Suliman (16 years). (Maannews 27 January 2015)
- Israeli settlers living in Immanuel settlement escorted by the Israeli Occupation Army (IOA) razed Palestinian agricultural land IN Al-Masaheel area in Deir Istiya village, north of Salfit city. (Pal Info 27 January 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al-Aqsa mosque in Jerusalem city and toured in its courtyard. (Pal Info 27 January 2015)

Israeli Military Orders

- Israeli Civil Administration handed out military orders to demolish two sheds and a residential tent in At-Taban area, east of Yatta town, south of Hebron city. The targeted structures are owned by: Nasser Mahmoud Khalil Abu Al-Abed and Samer Mohammad Hassan Al-Hamada. (Al-Quds 27 January 2015)
- Israeli Occupation Authorities handed out military orders to confiscate 500 dunums of Palestinian land in Atus and Al-Makhid areas, west of Beit Ula village, northwest of Hebron city, under the claim that the targeted land classified by the Israeli Authorities as "State land". The targeted land are owned by Al-Amla and Abu Naser families. (Wafa & Maannews 27 January 2015)

• Israeli Occupation Army (IOA) closed with cement blocks the northern entrance of Ar-Ram town, north of Jerusalem city. (Maannews 27 January 2015)
