Israeli Violations' Activities in the oPt 25 July 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats occupied Palestinian territory, in the the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Brutality of the Israeli Occupation Army

- Two Palestinian were injured after the Israeli Occupation Army (IOA) opened fire at them while they were near the Israeli segregation wall, west of Deir Al Ghusun village, north of Tulkarm city. the Palestinians were identified as: Hatim Ash-Shareif and Abed Al Karem Atwa. (HR 25 July 2015)
- Israeli Occupation Army (IOA) opened fire at Palestinian farmers while they were working in their land, east of Al Burij refugee camp in the central of Gaza strip. (HR 25 July 2015)

• Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing at As-Sudaniya shore, northwest of Gaza strip. (Al Quds 25 July 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) summoned Iyad Ahmed Taqatqih (30 years), Amer Azzat Diriya (25 years) and his brother Mohammad (21 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming their houses in Beit Fajjar village, south of Bethlehem city. (RB2000 25 July 2015)
- Israeli Occupation Army (IOA) summoned Iyad Salama Ad-Dibis (31 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming his house in Ayda refugee camp, north of Bethlehem city. (RB2000 25 July 2015)
- Israeli Occupation Army (IOA) summoned Ahmed Salah Jado (28 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding his house in Ad-Doha town in Bethlehem governorate. (RB2000 25 July 2015)
- Israeli Occupation Army (IOA) summoned Khalil Habas Salah to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after raiding his house in Al Khader village, southwest of Bethlehem city. (RB2000 25 July 2015)

Israeli Settler Violence

- Israeli settlers assaulted a Palestinian while he was near Al Ghawanmah gate in the old city of Jerusalem. (Wafa 25 July 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al Aqsa mosque in Jerusalem city, toured in its courtyard and performed Talmudic rituals. (Wafa 25 July 2015)
