Israeli Violations' Activities in the oPt 14 April 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded and toured in several areas and neighborhoods in Beit Jala town, west of Bethlehem city. The IOA also, stormed and searched dozens of Palestinian commercial structures. (Al-Quds 14 April 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Majed Awad Ar-Rashida (26 years) after storming his house in Ar-Rashayida village, southeast of Bethlehem city. (Al-Quds 14 April 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians from Silwan town in Jerusalem city. The arrestees were identified as: Fouad Al Qaq, Ali Dana and Abed Waleed As-Salimah. (SilwanIC 14 April 2015)
- Israeli Occupation Army (IOA) arrested 7 Palestinians after storming and searching their houses in Beit Rima village, northwest of Ramallah city. The arrestees were identified as: Mohammad and Hassan Tamim Ar-Rimawi, Humam and Majdi Munir Ar-Rimawi, Abed Al Qader Al Bargouthi, Jamal Sameh Ar-Rimawi and Taha Jaber Ar-Rimawi. The IOA transferred the arrestees to unknown location. During the operation, clashes erupted between Palestinians and the IOA, where the IOA fired live bullets and stun grenades at houses and Palestinians. (Safa 14 April 2015)
- Israeli Occupation Army (IOA) summoned Shawkat Adnan Mohammad Ar-Rujoub (24 years) to interview the Israeli Intelligence Police, after storming his house in Al-Kum village, west of Hebron city. (Safa 14 April 2015)
- Israel Occupation Army (IOA) arrested three Palestinians from Qalqilyah city. The arrestees were identified as: Salah Daoud, Musa Soiy and Imad Ja'idi. (Safa 14 April 2015)
- Israeli Occupation Army (IOA) arrested Bashar Yousif Abed Al Fatah Shabaro after storming his house in Nablus city. (Raya 14 April 2015)
- Israeli Occupation Army (IOA) arrested five Palestinians after raiding and searching their houses in Al-Arroub refugee camp, north of Hebron city. The arrestees were identified as: Abed Suliman At-Titi (48 years), Musa At-Titi (19 years), Abed Ar-Rahman Taher Sulim, Nadem Al-Badawi (18 years) and Hazem Mahir Ar-Ra'I (15 years). - Israeli Occupation Army (IOA) arrested Ala Ad-Diyn Hassan Ash-Sharwnah (13 years) while he was near the Ibrahimi mosque in the old city of Hebron. (RB2000 14 April 2015)
- Israeli Occupation Army (IOA) arrested Yousif Abed Al-Hadi Masalmah after storming his house Dura town, southwest of Hebron city. (Safa 14 April 2015)

Home Demolition & Demolition threats

- Israeli Occupation Army (IOA) demolished a residential caravan (40 square meters) in Al-Ashqariya neighborhood in Beit Hanina town in Jerusalem city. The targeted caravan is owned by Mohammad Shwiki. (Maannews 14 April 2015)

- Israeli Occupation bulldozers demolished a Palestinian buildings (total area 320 square meters) consist of 4 floors and three apartments in Wadi Al Jous neighborhood in Jerusalem city. Noted that the floor number 4 are ready to be used. (SilwanIC 14 April 2015)

Erection of Israeli checkpoints

- Israeli Occupation Army (IOA) erected sudden checkpoints at the entrances of Hebron, Sair and Halhul towns. The IOA stopped and searched Palestinian vehicles and checked ID cards. (RB2000 14 April 2015)
