Israeli Violations' Activities in the oPt

08 October 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Burdrus village, west of Ramallah city. The IOA fired teargas and stub grenades at Palestinians, causing dozens of suffocation cases. During the clashes, the IOA stormed a school. (Wafa 8 October 2015)
- Israeli Occupation Army (IOA) stormed and searched dozens of Palestinian houses and commercial structures in Beit Furik village, southeast of Nablus city. The IOA questioned the residents and destroyed the houses consists, also they stole money from the targeted

- houses. Four of the targeted houses are owned by: Ma'roud Hinni, Abed Shaher, Nassem Malitat and Ala Hinni. (Wattan 8 October 2015)
- Israeli Occupation Army (IOA) invaded and searched dozens of Palestinian houses in Tell village, west of Nablus city, questioned the residents and destroyed the houses consists. Five of targeted houses are owned by: Mustafah Ahmed 'Asidah and his brothers Abed As-Salam and Jamal, Adi Abed As-Salam 'Asidah and Ahmed Mohammad Ramadan. (Wattan 8 October 2015)
 - Israeli Occupation Army (IOA) and bulldozes staged few meters into the northeastern part of Beit Lahiya town, north of Gaza strip, and razed land. (RB2000 8 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the western entrance of Tuqu village, southeast of Bethlehem city. the IOA fired teargas and stun grenades, causing dozens of suffocation cases. During the clashes, the IOA stormed the office of Tuqu municipality and occupied its roof. (Wafa & RB2000 8 October 2015)
 - Israeli Occupation Army (IOA) invaded and searched five Palestinian houses in Al Khader village, southwest of Bethlehem city and fired teargas and stun grenades at Palestinians and their houses. The targeted are owned by: Mohammad Salah, Ahmed Ayesh, Hassan Qatesh, Abdalla Da'dou and Musa Ayesh. (Wafa 8 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Al Arroub refugee camp, north of Hebron city. The IOA fired live and rubber bullets and teargas grenades at Palestinians, causing dozens of suffocation cases and the injury of 15 people. (Al-Quds 8 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the western part of Tulkarm city. The IOA fired teargas and stun grenades at Palestinians and houses, causing dozens of suffocation cases. (RB2000 8 October 2015)
 - Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Hebron city. The IOA fired teargas grenades at Palestinians and vehicles, causing a number of suffocation cases. (RB2000 8 October 2015)
 - Israeli Occupation Army (IOA) fired wastewater at Palestinian houses and land at Al Balu' area, which located near DCO military checkpoint, in Ramallah city. Clashes erupted between Palestinians and the IOA, where the IOA fired rubber bullets and teargas grenades at Palestinians, causing dozens of suffocation cases and the injury of two people. (Maannews 8 October 2015)
 - Israeli Occupation Army (IOA) occupied an under construction Palestinian building consists of four floors at Ad-Dhahr area in Beit

Ummer town, north of Hebron city, and transformed it to a military base. Noted that the targeted building is located near the Israeli Settlement of Karmeil Zur. The targeted building is owned Omar Jubrail As-Salibi. (Wafa 8 October 2015)

- Israeli Occupation Army (IOA) occupied a number of agricultural structures at Beit Za'ta area, east of Beit Ummer town, north of Hebron city, and transformed it to a military base. The targeted structures are owned by Samir Shahda Al 'Alami. (Wafa 8 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Beit Ummer town, north of Hebron city. The IOA fired live and rubber bullets, and teargas grenades at Palestinians, causing dozens of suffocation cases and the injured of 17 Palestinians one of them was seriously injured. During the clashes, the IOA arrested 9 Palestinians, 6 of them were identified as: Anwar Imad Bader Akhalil (20 years), Mohammad Jamal Jamel Alqam (14 years), Muhannad Braghith, Mohammad Braghith (16 years), Mohammad Sadiq Mohammad Akhalil (17 years) and Muhdi Ibrahim Abed Al Hamed Aby Mariya (11 years). The IOA transferred the arrestees to unknown location. (RB2000 8 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Bethlehem city. (Maannews 8 October 2015)
- Israeli Occupation Army (IOA) stormed Barta'a Ash-Sharqiya village, west of Jenin city and declared it as "closed military area". The IOA closed the entrance of the village, stopped and detained Palestinian vehicles and checked ID cards. (Wafa 8 October 2015)
- Israeli Occupation Army (IOA) razed Palestinian land and closed an agricultural road at Ash-Shila area, south of Azzun Al Atma village, southeast of Qalqiliyah city. (Maannews 8 October 2015)
- Dozens of Palestinians suffered gas inhalation during clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the southern entrance of Qalqiliyah city. (Maannews 8 October 2015)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) at the northern entrance of Azzun village in Qalqiliyah governorate. The IOA fired teargas grenades at Palestinians. causing a number of suffocation cases. (Maannews 8 October 2015)
- Israeli Occupation Army (IOA) erected electronic gates at the all gates of the old city of Jerusalem; Hebron, As-Silsila, Al Jaded, and Al Asbat and at Al Wad street. (Al-Quds 8 October 2015)
- Dobhi Abu Khalifah (19 years) shoot and killed by the Israeli Occupation Army (IOA) in Jerusalem city. the Palestinian martyr from Shufat refugee camp, north of Jerusalem city. As a result, the Israeli Occupation Army (IOA) invaded the camp and tried to reach the house

of the martyr, clashes erupted between Palestinians and the IOA, where the IOA fired Dumdum, live and rubber bullets, and teargas grenades, causing dozens of suffocation cases and the injury of more than 40 Palestinian and Wissam Jamal Taleb Faraj (20 years) shoot and killed. (Al-Quds 8 October 2015)

- Israeli Occupation Army (IOA) handed out the body of the Palestinian Martyr; Muhannad Al Halabi, to his family in Surda village, north of Ramallah city. Noted that the Israeli Authorities detained the body of the Palestinian martyr for about 6 days. (Al-Quds 8 October 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested three Palestinians after raiding and searching their houses in Al Issawiya town in Jerusalem city. The arrestees were identified as: Mohmmad Abed, Atta Darbas and Zakariya Darwish. (SilwanIC 8 October 2015)
- Israeli Occupation Army (IOA) arrested Nizar Atariya from the old city of Jerusalem. (SilwanIC 8 October 2015)
- Israeli Occupation Army (IOA) arrested Mahmoud Abu Nijma while he was at Al Musrara area in Jerusalem city. (SilwanIC 8 October 2015)
- Israeli Occupation Army (IOA) arrested nine Palestinians after raiding and searching their houses in Beit Ummer town, north of Hebron city. The arrestees were identified as: Imad Hamdi Zamil Abu Mariya (37 years), Yazan Imad Mohammad As-Salibi (19 years), Hisham Fathi Khader Zeidan Sabarnah (20 years), Ramzi Mohammad Hamed Abu Mariya (27 years), Mohammad Ibrahim Odeh Sabarnah (24 years), Ahmed Abdalla Izreq Abu 'ayesh (23 years), Imad Bader Mahmoud Akhalil (40 years), Iyad Kamel Musa Bahar (40 years) and Sami Kamel Musa Bahar (24 years). (Wattan 8 October 2015)
- Israeli Occupation Army (IOA) arrested five Palestinians after storming their houses in Halhul town, north of Hebron city. The arrestees were identified as: Mohammad Abu Zalta, Salah Ismail, Bassam Al Wahsh, Ahmed Naser and Abed Al Muhsen Za'amrah. (Wattan 8 October 2015)
- Israeli Occupation Army (IOA) arrested four Palestinians from Hebron city. The arrestees were identified as: Mohammad Falah, Abed Al 'Ajlouni, Mohammad Abu Isninah and Ali Abu Isninah. (Wattan 8 October 2015)
- Israeli Occupation Army (IOA) arrested Muthana Abu 'Ara after storming and searching his house in 'Aqqaba village, south of Jenin city. During the operation, the IOA invaded and searched three Palestinian houses. The targeted houses are owned by: Imad Abu 'Ara, Mureed Abu 'Ara and Faez Abu 'Ara. (Wattan 8 October 2015)

- Israeli Occupation Army (IOA) arrested two Palestinian from Tell village in Nablus governorate, after stopping them at Jaba military checkpoint, north of Jerusalem city. The arrestees were identified as: Khalil Ibrahim Ali Shtiya (20 years) and Muwafaq Hilmi Ramadan (21 years). (Wattan 8 October 2015)
- Israeli Occupation Army (IOA) arrested two Palestinian from Dura town in Hebron governorate. The arrestees were identified as: Ayham Sied Ahmed (15 years) and Mutaz An-Namura. (Pal Info 8 October 2015)
- Israeli Occupation Army (IOA) arrested Milad Imad Ash-Sha'ir (20 years) after raiding and searching his family house in Husan village, west of Bethlehem city. (Wafa 8 October 2015)
- Israeli Occupation Army (IOA) raided a Palestinian house in Khursa village, southwest of Hebron city. The targeted house is owned by the family of the Palestinian martyr Diya At-Talahma, the IOA arrested his brother Mohammad and summoned his father and his brother Mahmoud to interview the Israeli Intelligence Police in Gush Etzion settlement bloc. (Pal Info 8 October 2015)
- Israeli Occupation Army (IOA) arrested Ayman Issa Hamdan (33 years) after raiding and searching his house in Ash-Shawawra village in Bethlehem governorate. (Wafa 8 October 2015)
- Israeli Occupation Army (IOA) arrested four Palestinians after stopping them at Al Hamra military checkpoint, east of Tubas city. (Al-Quds 8 October 2015)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed and toured in the courtyard of Al-Aqsa mosque in Jerusalem city and tried to perform Talmudic rituals. (RB2000 8 October 2015)
- Israeli settlers living in Beit El settlement attacked a Palestinian house located near the settlement, and tried to storm it. The targeted house is owned by Al Harini family. (RB2000 8 October 2015)
- Israeli settlers living in Beit El settlement escorted by the Israeli Occupation Army (IOA) hurled stones at Palestinian houses in Ad-Dahiya Az-Zira'iya area near Al Jalazoun refugee camp, north of Ramallah city. Clashes erupted between Palestinians and the IOA, where the IOA fired teargas and stun grenades at Palestinians and houses. (Wafa 8 October 2015)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) gathered at the entrance of Jit village, east of Qalqiliyah city and tried to attack Palestinian houses. (NBPRS 8 October 2015)

- Israeli Occupation Army (IOA) attacked a Palestinian vehicle traveling near Sarra village, west of Nablus city, at Qalqiliyah- Nablus road. The targeted vehicle is owned by Abed Al Men'em Al Bari. (Maannews 8 October 2015)
- The Palestinian Minister of Technology and Commination; Alam Musa, was injured after the Israeli settlers hurled stones at his vehicle while he was in his way to Nablus city. (Al-Quds 8 October 2015)
- Israeli settlers attacked a Palestinian vehicle near Tell village, west of Nablus city, while it was traveling at Ramallah-Nablus road, as a result the driver was injured. The targeted vehicle is owned by Khalid 'Atiyani. (Al-Quds 8 October 2015)
- Israeli settlers living in Susiya settlement hurled stones at Palestinian tents located near the aforementioned settlement. (Al-Quds 8 October 2015)
- Israeli settlers gathered near the entrance of Kafr Laqif village, east of Qalqiliyah city, at the Qalqiliyah-Nablus road. The Israeli settlers closed the street and hurled stones at Palestinian vehicles. (Al-Quds 8 October 2015)
- Israeli settlers living in Yesh Kodesh outpost escorted by the Israeli Occupation Army (IOA) attacked Palestinian houses at the southern entrance of Qusra village, south of Nablus city. (RB2000 8 October 2015)

Israeli Military Orders

- Israeli Occupation Army (IOA) issued a military order to demolish a Palestinian house in Beit Furik village, southeast of Nablus city. The targeted house is owned by Nimir Al Haj Mohammad, a Palestinian outcast in Gaza strip. (Maannews 8 October 2015)
