Israeli Violations' Activities in the oPt 04 February 2015

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) confiscated an agricultural tractor from As-Samu town, south of Hebron city. The targeted tractor is owned by Shahda Abu Awad. (Wattan 4 February 2015)
- Israeli Occupation Army (IOA) stormed and searched dozens of Palestinian houses in Al-Karmel village, east of Yatta town, south of Hebron city. (Wattan 4 February 2015)
- Israeli Occupation Army (IOA) invaded "Al-Quds gate" protest village in Abu Dis town, east of Jerusalem city and destroyed three tents. The

IOA also, attacked Palestinian activists and fired teargas grenades at them. (ARN 4 February 2015)

- Israeli Occupation Army (IOA) raided Al-Lubba- As Sawiya high school, south of Nablus city, forced the students and the teachers to leave the school and arrested the headmaster of the school. (Maannews 4 February 2015)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Yousif Munif Al-Qazaz (15 years) while he was near the Ibrahimi mosque in the old city of Hebron. The IOA transferred the arrestee to unknown location. (Wattan 4 February 2015)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming their houses in Dura town, southwest of Hebron city. The arrestees were identified as: Mohammad Munqith Abu Atwan (15 years), Qusai Kamel Al-Atrash (15 years) and Ahmed Ihribat (16 years). (ARN 4 February 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their family houses in Beit Ummer town, north of Hebron city. The arrestees were identified as: Ahmed Mohammad Awad (17 years) and Rashid Ali Awad (17 years). (ARN 4 February 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Tammun village, south of Tubas city. The arrestees were identified as: Diya Bani Odeh (20 years) and Khalid Jalal Bisharat (21 years). (Maannews 4 February 2015)
- Israeli Occupation Army (IOA) arrested four Palestinians from Aqbat Jaber refugee camp, south of Jericho city. The arrestees were identified as: Ra'fat Attalla (30 years), Mohammad Eid Ka'abnih (20 years), Mohammad Khames Khalil Baraqa (25 years) and Diya Mahmoud Fahed Bani Odeh (18 years). (Maannews 4 February 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding their houses in At-Tur town in Jerusalem city. The arrestees were identified as: Fesal Abu Al-Hawa (17 years) and Mohammad Afif Abu Al-Hawa. (Maannews 4 February 2015)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Silwan town in Jerusalem city. The arrestees were identified as: Salem Harbi Al-Abbasi (20 years) and Ali Ahmed Al-Abbasi (21 years).

Home Demolition & Demolition threats

- Israeli Occupation Army (IOA) demolished two commercial structures in Idhna town, west of Hebron city. The targeted structures are owned by: Mohammad Ibrahim Azghir and Hussam Ash-Sha'rawi. (Wattan 4 February 2015)

Israeli Military Orders

- Israeli Occupation Army (IOA) handed out military orders to demolish three water wells in Silwad village, north of Ramallah city. The targeted wells are owned by: Nasser Issa, Yasser Salem and Basel At-Tawel. (NBPRS 4 February 2015)

Confiscation & Razing of lands

- Israeli Occupation Army (IOA) razed land and conducted excavation works in "Ein Al-Haniya" area near Al-Walaja village, west of Bethlehem city. (Al-Quds 4 February 2015)
