## Israeli Violations' Activities in the oPt

20 August 2014

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Al-'Araqa village, west of Jenin city. The IOA fired teargas grenades at Palestinians, causing dozens of suffocation cases. (Wafa 20 August 2014)
- Israeli Occupation Army (IOA) stormed a Palestinian house owned by Khalida Jarar; a deputy in the Palestinian Legislative Council, in Ramallah city, and handed her an order to relegate her to Jericho city. (Wafa 20 August 2014)

- Israeli Occupation Army (IOA) invaded and searched several Palestinian houses in Burin village, south of Nablus city. (RB2000 20 August 2014)

## **Gaza Strip**

- Seven Palestinians; included three children, were killed after the Israeli warplanes launched missiles at a Palestinian house in Deir Al-Balah city in the central of Gaza strip. The targeted house is owned by Al-Louh family. (Maannews 20 August 2014)
- Israeli Occupation warplanes launched missiles at a Palestinian house in Rafah city, south of Gaza strip. Ten Palestinians were injured. The targeted house is owned by Madi Family. (Maannews 20 August 2014)
- Three Palestinians were killed and 45 others were injured after the Israeli Occupation warplanes launched missiles at a Palestinian house owned by Ad-Dalo family, in Ash-Sheikh Radwan neighborhood in Gaza city. The house was completely destroyed. After few hours, Palestinian medical crews found the bodies of three Palestinian martyrs under the rubble of Ad-Dalo house. (Maannews & Wafa 20 August 2014)
- Omar Mohammad Jarghon died of wounds he sustained during the Israeli assault on Gaza strip. (Wafa 20 August 2014)
- A Palestinian killed and three others were injured after the Israeli Occupation warplanes launched missiles at several areas and a group of Palestinians in Beit Lahiya town, north of Gaza strip. (Wafa 20 August 2014)
- Israeli airstrikes attacked Palestinians houses in Aabdeen and Abu Hmidan areas and Jabaliya refugee camp in Gaza strip. 20 Palestinians were injured. (Wafa 20 August 2014)
- Two Palestinians; included a child Nour Mohammad Abu Husirah (2 years), were killed and seven others were injured after the Israeli warplanes launched a missile at a store in Az-Zaytouin neighborhood in Gaza city. (Wafa 20 August 2014)
- Israeli Occupation warplanes launched missiles at a group of Palestinians in Abraj Al-Muqawasi area, northwest of Gaza city. A Palestinian was killed and other was injured. (Wafa 20 August 2014)
- A Palestinian was killed after the Israeli Occupation warplanes launched missiles at agricultural land, north of Gaza strip. (Wafa 20 August 2014)

## **Israeli Arrests**

- Israeli Occupation Army (IOA) arrested Hazem Hassan Mahmoud Jawabrih (20 years) after storming his house in Al-Aroub refugee camp, north of Hebron city. (RB2000 20 August 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding their houses in Al-Fawar refugee camp, south of Hebron city. The arrestees were identified as: Munir Attala At-Titi (27 years) and Younis Khalil As-Sarhana (21 years). The IOA transferred the arrestees to unknown location. (RB2000 20 August 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searching their family houses in Beit Ummer town, north of Hebron city. The arrestees were identified as: Muhab Jawdat Nadi Adi (18 years) and Sabri Ibrahim Sabri Awad (19 years). (RB2000 20 August 2014)
- Israeli Occupation Army (IOA) arrested Shakir Abd Al-Wahab (20 years) from Husan village, west of Bethlehem city, while he was interviewing the Israeli Intelligence Police in Gush Etzion settlement bloc. (RB2000 20 August 2014)
- Israeli Occupation Army (IOA) summoned Ismail Mahmoud Sabah (50 years) to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming his and searching his house in Tequ village, southeast of Bethlehem city. (RB2000 20 August 2014)
- Israeli Occupation Army (IOA) detained and questioned Awad Azmi Abu Bakir after stopping him at Dotan military checkpoint near Yabed town in Jenin governorate. (Wafa 20 August 2014)
- Israeli Occupation Army (IOA) arrested three Palestinians after stopping them at Jaba checkpoint, east of Jerusalem city. As a result, clashes erupted between Palestinians and the IOA, where the IOA fired teargas grenades. At Jaba checkpoint, the IOA stopped and detained dozens of Palestinian vehicles. (Maannews 20 August 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians from An-Nabi Saleh village, north of Ramallah city, after assaulting them. The arrestees were identified as: Qusai Mahmoud At-Tamimi (10 years) and Mahmoud Wajeh At-Tamimi (19 years). Clashes erupted between Palestinians and the IOA, where the IOA fired live bullets. (Wafa 20 August 2014)
- Israeli Occupation Army (IOA) summoned Said Abu Al-Rob from Qabatya village, south of Jenin city, to interview the Israeli Intelligence Police in Salem military base, after stopping him at a sudden checkpoint erected by the IOA south of Jenin city. (Wafa 20 August 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in Silat Ad-Dhahr village, southwest of

- Jenin city. The arrestees were identified as: Jamel Kamel Musa (17 years) and Mamdouh Adel Musa (20 years). (Wafa 20 August 2014)
- Israeli Occupation Army (IOA) arrested four Palestinians from Jerusalem city. The arrestees were identified as: Ahmed Al-Hashlamun, Waheed Al-Bakri, Musa 'Ajluni and Muaz Idris. (Wafa 20 August 2014)
  - Israeli Occupation Army (IOA) arrested Murad Khalil from Tubas city. (Wafa 20 August 2014)
  - Israeli Occupation Army (IOA) arrested a Palestinian near Nablus city. (Maannews 20 August 2014)

### **Israeli Settler Violence**

- Israeli settlers escorted by the Israeli Occupation Army (IOA) attacked Palestinian shepherds and farmers in Kisan village, east of Bethlehem city, and prevented them from reaching to their land. The Israeli settlers also, razed a 300 dunums of Palestinian land in the village. (Mawwal 10 August 2014)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al-Aqsa mosque in Jerusalem city and toured in its courtyard. During the operation, the IOA arrested Ibrahim Abu 'Arar. (NBPRS 20 August 2014)

### **Home Demolition & Demolition threats**

- Israeli Occupation Army (IOA) demolished four Palestinian houses in Khirbet At-Tawel in Aqraba village, southeast of Nablus city. The targeted houses are owned by: Mohammad and Anwar Sidqi Saleh. (Maannews 20 August 2014)
- Israeli Occupation Army (IOA) demolished four residential barracks in the Bedouins committee, east of At-Tayba village, northwest of Ramallah city. The targeted barracks are owned by: Yousif Musa Ahmed Ka'abna and Musa Yusif Ka'abna. (Maannews 20 August 2014)
- Israeli Occupation Bulldozers demolished three residential barracks in the Bedouins committee in Mekhmas village, east of Ramallah city. (Maannews 20 August 2014)
- Israeli Occupation Army (IOA) demolished two Palestinian houses in Al 'Aqaba village, east of Tubas city. The targeted houses are owned by: Deif Alla Al-Faqir and Ziyad Khairalla. (Wafa 20 August 2014)

### **Israeli Military Orders**

- Israeli Municipality of Jerusalem escorted by the Israeli Occupation Army (IOA) handed out administrative orders to demolish a house and a building consists of four apartments in Ein Al-Louza neighborhood in Silwan town in Jerusalem city. The targeted building and a house are owned by Hamuda and Mahran Siyam. (Maannews 20 August 2014)

### **Erection of Israeli checkpoints**

- Israeli Occupation Army (IOA) erected sudden checkpoints at the entrance of Sair and Halhul towns and at the northern entrance of Hebron city. The IOA stopped and searched Palestinian vehicles and checked ID cards. (RB2000 20 August 2014)
