## Israeli Violations' Activities in the oPt

24 November 2014

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

# Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded and searched a Palestinian house owned by Ahmed Al-Haj Ali (80 years) in Nablus city, and tried to arrest the owner of the house. During the operation, the arrested Adel Dwikat. (Al-Quds 24 November 2014)
- A Palestinian was injured and two others were arrested after the Israeli Occupation Army (IOA) attacked them while they were near Karm Abu Salem terminal, east of Rafah city, south of Gaza strip. (Maannews 24 November 2014)

- Israeli Occupation Army (IOA) invaded and toured in several neighborhoods in Hebron city. (Wafa 24 November 2014)
- Israeli Occupation Army (IOA) invaded and searched two Palestinian houses in Jabal Al-Mukabbir town, south of Jerusalem city. The targeted houses are owned by the families of two martyrs; Adi and Ghassan Abu Al-Jamal. Clashes erupted between Palestinians and the IOA, where the IOA fired rubber bullets and teargas grenades at Palestinians and houses. (Maannews 24 November 2014)
- Israeli Occupation Army (IOA) stormed and searched the headquarters of the Football Association in Ar-Ram town, north of Jerusalem city. (Wafa 24 November 2014)

#### Israeli Arrests

- Israeli Occupation Army (IOA) arrested three Palestinians after storming their houses in Beit 'Awwa town, west of Hebron city. The arrestees were identified as: Waleed Abu Ghalasi, Yousif Al-Jamal and Adi Masalmah. The IOA transferred the arrestees to unknown location. (Wafa 24 November 2014)
- Israeli Occupation Army (IOA) arrested Tharwat Tareq Hamamrih (29 years) and summoned Mohammad Bassem Hamamrih to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming their houses in Husan village, west of Bethlehem city. (Wafa 24 November 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding their houses in Al-Issawiya town in Jerusalem city. The arrestees were identified as: Mahmoud Abdalla Dari and Adi 'Awri. (Pal Info 24 November 2014)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming their house in Jabal Al-Mukabbir town, south of Jerusalem city. The arrestees were identified as: Zaid Yasir Abed Rabbo (22 years) and Omar Hassan Hijazi (21 years). (Pal Info 24 November 2014)
- Israeli Occupation Army (IOA) arrested Hassan Samer Khalfawi (18 years) from the old city of Jerusalem. (Pal Info 24 November 2014)
- Israeli Occupation Army (IOA) arrested Majd Ghaith from Silwan town in Jerusalem city. (Pal Info 24 November 2014)

#### Israeli Settler Violence

• Israeli settlers assaulted and injured Basil Mohammad Al-'Amareen from Al-Arroub refugee camp, north of Hebron city. (Shasha News 24 November 2014)

- Israeli settlers attacked and injured Munther Ziyada from Hebron city. (Shasha News 24 November 2014)
- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al-Aqsa mosque in Jerusalem city and toured in its court yard. (NBPRS 24 November 2014)
- Israeli settlers living in Pisgat Zeev settlement assaulted and seriously injured a Palestinian from Beit Hanina town, north of Jerusalem city, while he was in his work place in Jerusalem city. (Al-Quds 24 November 2014)
- Israeli settlers living in Ariel settlement pumped wastewater at Ein Wadi Al-Fawara spring in Kafr Ad-Dik village, west of Salfit city. (Al-Quds 24 November 2014)

### Israeli Military Orders

• Israeli Occupation Authorities handed the Municipality Qaffin of a military order to demolish and remove a public park in Qaffin village, west of Jenin governorate. The targeted park area about 600 dunums of agricultural land. (Wattan 24 November 2014)
