Violation of the right to Housing- Home demolition

The occupation's municipality demolishes two barracks in Al-Eizariya and uproots 60 fruitful trees:

Israeli Forces on March 10, 2015 demolished two agricultural barracks in the area of Al-Eizariya on the claim of "unlicensed construction". The structures, which were gifted by the EU after having previous barracks demolished on the same claim two years ago, belong to Citizen Adel Dari.

Adel told a researcher from Land Research Center the following:

"I built an agricultural barrack three years ago to use it as storage. Israel Nature Authority came to the place, photographed the structure and delivered me a demolition order on the claim of "unlicensed construction"; the order was then implemented by the occupation's municipality. The EU gifted me two agricultural barracks as kind of support for Jerusalemites and I prepared the structures and provided them with plants and equipments to start up the work. Noteworthy, the barracks were 16 and 20m² in area. Shortly after, Israel Nature Authority came and went through the same process until my structures were demolished by the municipality on March 10, 2015. Also, around 60 fruitful trees were uprooted in the process.

The demolition came on the claim that the land is classified as part of a Talmudic park to be opened soon."

The Israeli occupation dozers ravage vast areas from Al-Isawiya and demolish barracks

Israeli dozers on March 10, 2015 ravaged vast area from the lands of Al-Isawiya, northeast Jerusalem. The force was accompanied by a number of machineries, which embarked on demolishing the surroundings and ravaging the land.

Citizen Mohammad Abu Al-Humus told a researcher from Land Research Center the following:

"Policemen with dozers raided the area on Tuesday and embarked on ravaging lands from the eastern side of the village. The lands belong to the families of Abu Al-Humus, Obeid, Abu Asab and Badriyeh. The reason behind this attack is to leave the lands unused so that the occupation takes them for the so-called National Park.

The force also demolished three agricultural barracks owned by citizens Ahmad Obeid and Adel Dari, not mentioning other structures that were leveled during the process"

He also added:

"The ravaging was implemented for the sake of establishing the so-called National Park on the lands of Al-Isawiya and Al-Tur. What is more important is to open playing grounds and clubs for kids of the villages"

The Israeli occupation dozers demolish structures in the Jerusalem village of Beit Iksa

The dozers of the Israeli occupation on March 11, 2015 demolished three barracks for livestock and some tents in the village of Beit Iksa, northwest Occupied Jerusalem. A massive force from the Israeli police and a staff from the Civil Administration were reported to raid the area at the early hours of morning and to demolish the aforementioned structures, which belong to Citizen Abu Dawood Al-Badawi. Noteworthy, the structure was built years ago to be used as storage for fodder and animals.

The chairman of Beit Iksa village told Land Research Center the following:

"This is not the first demolition Beit Iksa witnesses; such measures aim at harassing the residents through setting up the apartheid wall and checkpoints and demolishing structures. Noteworthy, this is the second time Al-Badawi gets his structures demolished on the claim of "unlicensed construction". Tens of structures were demolished on the same claim in the area"

Beit Iksa is one of the Palestinian villages that the occupation isolated from the villages of northwest Jerusalem. In addition, the occupation set up a checkpoint at its entrance and surrounded it by the wall, turning it into a big prison of 2000 people. All structures fall targets for the occupation to fight the stability of residents in the area.

Kifah Da'na self-demolishes part of his house

Kifah Da'na on March 29, 2015 self-demolished part of his house in the Old City of Jerusalem to avoid paying "high fines" to the occupation municipality.

Da'na explained that he built a kitchen and a bathroom 15 years ago that are only 10 square meters in his house near Al-Silsileh Gate. Six years ago, he received a demolition order from the municipality under the pretext of building without a permit.

He also added that he was able to postpone the demolition all those years and he paid more than 60 thousand NIS in fines; he was forced to execute the municipality's order on Sunday to avoid paying the municipality's demolition costs.

Da'na explained that he was able to obtain a permit to renovate his house due to the continuous problems in the infrastructure and the humidity in the walls. He explained that the municipality and the "Antiquities Authority" imposed many conditions and restrictions before giving him the permit to renovate his house.

Demolition wave in Wad Al-Juz neighborhood in Jerusalem

The occupation bulldozers on March 31, 2015 demolished residential establishments and others used for raising horses in the neighborhood of Wad Al-Juz in Jerusalem without prior notice.

It is reported that the municipality's bulldozers raided and surrounded the neighborhood and closed some of the roads leading to the targeted area (Bridge area) which is only few meters away from Lions Gate (one of Al-Aqsa Gates).

Demolishing an establishment that has been built since many years

Witnesses explained that the demolition targeted establishments owned by Amro family and other establishments used for raiding horses owned by Totah family; the demolition was executed without prior notice.

Amro family explained that the occupation raided the their house and detained all family members in one room and then started demolishing parts of their house (a room, a balcony, storage area and walls); note that the total area demolished was 80 square meters.

Dr. Jamal Amro explained that the occupation assaulted his two brothers (Nour Eddin and Sharif) and pushed them, and the police chased two children who were holding Palestinian flags and attempted to arrest them.

Amro added that the room was used for "Ablutions" by the bus drivers who transfer the Palestinians from the 1948 lands to Al-Aqsa Mosque.

Amro explained that the establishments demolished on Tuesday were established before the occupation of Jerusalem.

Demolishing 5 rooms built 25 years ago

The occupation bulldozers also demolished 5 rooms owned by Hani Totah in which four of the five rooms were used for raising horses and the fifth was used as a play area for his children.

Hani Totah explained that the 80-square meters rooms were built from bricks and were roofed with tin plates. He also explained that the municipality carried out the demolition without prior notice and without the existence of a demolition order against the rooms that were licensed by the municipality 25 years ago.

Demolishing the foundations of houses

The occupation bulldozers on March 31, 2015 also demolished the foundations of three houses owned by Abbasi family in the village of Jabal Al-Mukabber under the pretext of building without a permit. Saeed Abbasi explained that the family started building the foundations of the houses only four months ago so that two of his sons and his brother can move and live in the new houses (nearly 20 individuals).

He explained that the family knew about the demolition order which was hung on the foundations of the houses last Saturday. They tried to postpone it but the bulldozers executed the demolition process.

Violation of the right to Housing- demolition threats

Administrative demolition orders on five residences:

A group of employees from the occupation's municipality accompanied by policemen on March 22, 2015 hung administrative demolition orders on five residences, some of which were still under construction where another was build since 45 years ago. A deadline of 30 days was given to the affected to object to the orders.

The orders reached out the areas of Ein Al-Luzeh, Beir Ayyoub and Silwan. Photos of the affected houses and neighborhoods were taken by the employees. The family of Walid Abdilrazzaq had their house notified despite being built 45 years ago and that no construction was annexed to it lately. The residence is home for 9 members. One house was reported to be under construction since 4 years where the other three are inhabited.

Mu'amar Abu Al-Hawa (40) and his family are afraid that the municipality will come anytime and demolish their house, which was built 30 years ago in the area of Al-Tur, east Jerusalem.

Abu Al-Hawa was shocked on March 2015 to receive an administrative demolition order on the claim of "unlicensed construction". Noteworthy, the residence is home for 7 members and is composed of two three rooms only.

Abu Al-Hawa said:

"A month ago, a staff from Israel Civil Administration raided my dwelling and delivered me a demolition order on my 100m² residence. I tore up the paper at time and told them to do whatever they want for I am not moving out"

He also added:

"Every time the village is raided, we get scared that our house will be demolished. All of my kids get traumatized; especially Mohammad, who suffer from hormones disorder"

One time, Mohammad fainted down and was moved to the hospital to receive medical care due to the sounds of the military forces and machineries in the village.

The Israeli occupation municipality threatens a building of demolition in Al-Sheikh Jarrah

Israeli Municipality of Jerusalem on March 04, 2015 issued an administrative order to demolish "As-Sumud" building in Ash-Sheikh Jarrah neighborhood in Jerusalem city. The targeted building (5 floors) is inhabited by 35 families totaling 150 members. The families sought refuge in this building 20 years ago after getting their residences demolished in different neighborhoods of Jerusalem. At time, the families grouped in the area of Al-Suwwana and set up tents but the Israeli occupation displaced them. The poor families then moved to the building's location, which is owned by Islamic Cultural center, and were allowed to stay there despite that the building was not fully constructed from the inside.

Residents of the building asserted that the municipality did not deliver them any eviction or demolition order previously but it recently hung an administrative demolition on the building on the claim of "unlicensed construction". The order is believed to be served due to the following two reasons:

- 1. Residents of the building annexed new rooms to the building and some new stores
- 2. The Israeli police raid the building on the claim that children pelt colonists with stones from there on their way to a cave known as "Sham'on the friend".





Violation of the right to Housing- seizures

Colonists seize a property and two lands in Silwan

Elad colony organization seized on March 18, 2015 the property of Al-Malhi family and two lands in the neighborhood of Wadi Hilweh in Silwan south of Al-Aqsa Mosque through "leaking" property and falsifying documents.

It was reported that the occupation forces along with the colonists and their guards raided on Wednesday morning Al-Malhi family property and immediately seized three residential apartments after one family member falsified the property's documents which enabled Elad organization from raiding the houses and seizing the property as they claimed ownership.

Elad organization claimed that Al-Malhi family is an unprotected tenant and the house is owned by the "guardian of absentee property"; note that the property was originally owned by Abbasi family which has been living abroad for many years. One family member falsified the documents of the property which enabled the settlers to seize it after buying it.

In a related matter, dozens of armed colonists along with occupation forces seized a 500meters land owned by Abbasi family in the neighborhood of Wadi Hilweh which was used by the children of the neighborhood as a playground; colonists immediately started building a room from tin plates on the land.

Also, colonists seized a 1200-meters land owned by Sha'ban family in the neighborhood of Wadi Hilweh.

Colonial organization attempt to take over Sub Labban property in Jerusalem:

The family of Sub Labban, residing in the neighborhood of Aqabat Al-Khalidiya- Jerusalem Old City, waits for the fate of their threatened of takeover house by a colonial association that claims its ownership of the property.

The family faught a very long tribunal war in Israeli courts to restore their residence. During that period of time, members of the family were constantly harassed by the colonists of the adjacent outpost.

A member of the family Ahmad Sub Labban told a researcher from Land Research Center the following:



"Ghiath family leased the structure from the Jordanian government in 1954 but since Israel occupied East Jerusalem in 1967, the property has fallen under the control of the Israeli Guardian of Absentee Property. Ghiath family has succeeded in obtaining a legal status of "protected tenant" on the property in 2001 after a long tribunal war that started back in mid eighties"

Ahmad also said:

"Ever since, the colonial association attempted bribe the owners to leave the residence but never succeeded. Colonists have been constantly harassing the family; the residence that is located in the Islamic quarter has gotten its gate closed by colonists as well. Also, colonists tried three times to take over the property by force".

That changed in 2010, when the Israeli Guardian of Absentee Property transferred ownership of the Sub Labban home to the settler group Ateret Cohanim. The group then assigned the management of the place for the godfather of the colonization Eli Itay; it is then when the association filed an eviction case against Ghaith family.

The family sought help from attorney "Abraham Gorn" who later died in 2012. Thus, Palestinian bodies assigned a new attorney for the case named Mohammad Dahla. Ghaith family lost the case on September 14, 204 but was never informed about this but on October 28, 2014.

On November 18, 2014, the family underwent an eviction following a decision made by the Magistrate court. Colonists then changed the locks on the residence's door and informed the family that the magistrate's decision must be executed since it was not objected to within the legal deadline, which as a matter of fact was over, taking into account the decision was made

on September 14, 2014.

On March 16, 2015, a big number of fanatic colonists tried to take over the property but people of the area stood up for them. Also, attorney Dahla



obtained a one day deadline to appeal to the eviction order in Israel Supreme Court.

Attacks on lands

Israeli dozers ravage vast area of lands from Qalandiya and Kfar Aqab areas

A massive force from Israel Police and army troops on March 11, 2015 raided the neighborhood of Kfar Aqab and some areas from Qalandiya, north Occupied Jerusalem and ravaged vast area of lands on the claim of "security purposes". The ravaging act was implemented to increase the area of Qalandiya checkpoint and to create a buffer zone of 10m for the apartheid wall in the area.

It should be marked that the dozers started, at early hours, to ravage the area along with the wall. Also, the dozers reached out a carwash belonging to Citizen Ahmad Shahut from Qalandiya camp.

Ahmad told a researcher from Land Research Center the following:

"I built the carwash years ago and I live off of it. Dozers of the occupation came at 1:30 a.m. and leveled the structure without any previous warning. My losses reached 50,000 NIS"

Also, clashes erupted between young Palestinians and the army soldiers, who shot live and rubber coated ammunitions and teargas canisters towards protesters. Three young men were reported injured with live ammunitions. A unit of snipers took a place on the roof of one house to provide protection for other troops.

The Israeli occupation authorities pursue to annex more lands and isolate Palestinian communities from each other. Not only Israel stole lands for the establishment of the wall but it also confiscated more lands to create buffer zones for the wall itself, causing huge loss of lands.

Lands confiscations

Colonists take over some lands from Silwan:

Dozens of armed colonists along with occupation forces seized a 500-meters land owned by Abbasi family in the neighborhood of Wadi Hilweh which was used by the children of the neighborhood as a playground; colonists immediately started building a room from tin plates on the land.

Also, colonists seized a 1200-meters land owned by Sha'ban family in the same neighborhood.

Colonial plans

Ratifying the construction of colonial units:

The Israeli National Committee on March 11, 2015 ratified the construction of 49 residential units in the colony of Ramot that is located in eastern Jerusalem.

According to the Israeli WALA website, the construction will be implemented on 2 dunums from the colony, which confiscated from the lands of Beit Iksa, northwest Occupied Jerusalem.

Intentions to implement two plans for colonies in Occupied Jerusalem:

Israeli resources on March 27, 2015 revealed two colonial plans that are to be implemented in Jabal Abu Ghneim and Beit Horon colonies, northwest Occupied Jerusalem. The plans include the construction of 131 residential apartments (77 for Abu Ghneim and 54 for Beit Horon).

In a similar context, a plan to establish a new cemetery in Mishour Adummim colony was revealed on March 28, 2015. Noteworthy, the plan will be implemented on lands confiscated from Al-Khan Al-Ahmar, southeast Occupied Jerusalem.

Closures

The occupation bans a human rights activist from entering the West Bank

Israeli Intelligences Services "Shabak" on March 26, 2015 delivered Citizen Salah Al-Hamouri an order banning him from entering the West Bank for six month on the claim of "security purposes".

Hamouri told Land Research Center the following:

"I work as a field researcher at Al-Damir organization, which is concerned about the affairs of Palestinian detainees in Israeli prisons. My area of research is Jerusalem where I document cases of detentions and arrests".

He also added:

"I received a phone call from someone who introduced himself as Captin Fowad from Al-Maskoubia Detention Center. Fowad asked me to be present at the center to deliver me the order but I told him I cannot be there because I was leaving Jerusalem to Kfar Aqqab where I live. I was then given two chances to whether go there on March 27 or 29, 2015. On Friday, March 27, 2015, I went to Al-Maskoubia Center and waited for half an hour before an officer came out in civil dress and delivered me the order in two copies: Arabic and English".

The order includes banning me from entering the areas of Judea and Samaria "West Bank" staring from March 24, 2015 until September 24, 2015 on the claim of maintaining security. Noteworthy, the order was signed by the commander of the army Mitsan Yalon.

I then headed to the French consulate in Jerusalem since I a hold French citizenship in addition to a Jerusalem ID to help me with the military order.

This is not the first time I get banned from entering the West Bank. I was once banned for three months from December 12, 201 until March 12, 2012. Noteworthy, I was freed on 18/12/2011 within the second group released within the "Shalit" deal.

For now, I will not be able to continue my studies since I study at AL-Quds University in Ramallah, taking into account that I am senior. Also, I will not be able to go to my work since Al-Damir organization is founded in Ramallah too.

Colonists' attacks

Colonists assault an elderly in Jerusalem:

A group of colonists on March 07, 2015 assaulted the 63-year old Ahmad Mahmoud Al-Qaq and severely beat him at Al-Sharaf neighborhood in the Old City of Jerusalem.

Al-Qaq's family explained that four colonists gathered around Hajj Ahmad while he was walking in Al-Sharaf neighborhood in the Old City of Jerusalem heading towards his house in Silwan after finishing the Afternoon Prayer at Al-Aqsa Mosque. The colonists threw several punches towards Hajj Ahmad's face and then ran away when other Jerusalemites approached the area.

Al-Qaq's family added that Hajj Ahmad was injured with bruises in his face and under his eye.

Colonists assault a Jerusalemite and injure him:

Citizen Ahmad Abu Ta'a on March 13, 2015 sustained injuries in the face and bruises in the neck after being attacked by two colonists in the area of Jabal Al-Masharef also known as the French Hill in Jerusalem.

Ahmad's father said that the colonists attacked Ahmad from the back when he was nearby his house; one colonist hit him on the leg while the other tried to stab him. Fortunately, the knife only hit Ahmad's nose after he defended himself. The attackers then fled the scene towards the colony of the French Hill.

Ahmad was then moved to Hadasa hospital in Al-Isawiya. The hospital reports showed that Ahmad sustained injuries, bruises and swollen face in addition to a severe bleeding due to the knife attack.

After the attack, more colonists walked down the area cursing the residents using profanity and discriminative language as a provocation.

Colonists assault isolated women from Al-Aqsa mosque and pour hot tea on them:

Colonists on March 22, 2015 assaulted a group of women who are isolated from Al-Aqsa Mosque and insulted them verbally as well as pouring hot tea on them.

The isolated women explained that two colonists approached them while they were near Al-Silsileh Gate after the colonists finished their tour inside Al-Aqsa courtyards. They also verbally assaulted the women and then one colonist poured hot tea on the women and ran away.

Attacks on religious sites

The policy of Judaizing Al-Aqsa mosque: Colonists' break-ins:

The Israeli occupation authorities kept on its policy of breaking into Al-Aqsa mosque and pushing colonists to tour the courtyards of the mosque under intensive protection of Israel Police.

During March 2015, the break-ins on Al-Aqsa mosque and its compound came as follows:

- March 01, 2015: groups of colonists break into Al-Aqsa compound through Dung Gate with police protection
- March 03, 2015: Israeli Forces detain the IDs of worshipers at Al-Aqsa entrance and allow colonist to tour the compound
- March 04, 2015: the occupation detains a number of women when exiting Al-Aqsa mosque and isolate them from the mosque for two months
- March 11, 2015: tens of colonists break into Al-Aqsa compound through Dung Gate and tour the courtyards.
- March15, 2015: groups of colonists (84) break into Al-Aqsa compound through Dung gate
- 6. March 15, 2015: Israel Police detained 8 buses from Sur Baher village, south Jerusalem. The idea was to gather people to go on tours in Al-Aqsa by 12 buses but police set up checkpoint since early morning and stopped 8 buses from completing the journey.
- March 17, 2015: Israel policemen assault citizens inside the compound after fighting colonists who broke into Al-Aqsa.
- March 19, 2015: Israeli forces detain the IDs of worshipers at entrance of Al-Aqsa and allow tens of colonists to tour the compound

- 9. March 22, 2015: Israel Police detain a female citizen at time of entering the mosque and isolate her from Jerusalem for two month. In the same day,127 colonists broke into Al-Aqsa and toured the compound
- 10. March 24, 2015: tens of colonists break into Al-Aqsa compound through Dung Gate and tour the courtyards under police protection.
- March 25, 2015: colonists break into Al-Aqsa compound calling to open the mosque for the Jews only.

Isolation policy and detention from Al-Aqsa mosque:

Isolating Jerusalemites from Al-Aqsa mosque is escalating and becoming a common means to harass Palestinians. The following table shows information about the isolated Jerusalemites:
