Violation of the Right to Housing- Home demolitions

Israeli authorities demolish two homes in East Jerusalem

On November 04, 2014 ,Israel demolished two homes in Silwan, south of Al-Aqsa Mosque in East Jerusalem, claiming they were constructed without a license.

It was reported that "a large bulldozer belonging to the Israeli municipality arrived at Wadi Yasoul in Silwan accompanied by Israeli police and army forces who later surrounded the home of the released prisoner Khalil Abu Rajab and demolished it before demolishing Assem Abu Subaih's home."

Abu Subaih's home is a two-story house that consists of three rooms where he lived in with his five family members including one handicapped person. Abu Subaih said that he built the house 5 months earlier to settle down in it and that he moved to live in the 120m² apartment. The house was later torn down after police came to the place and executed the demolition order

As for Abu Rajab's home, it is a two-story house (170m² and 150m²) that consists of three apartments where the families of his two brothers and him lived. The total number of people residing the building is 17 including minors, report said. In less than 24 hours on serving the demolition order, the house was brought down by two bulldozers.



Blowing up the house of the Martyr Abdulrahman Shallodi:

At the early hours of dawn of November 19,2014, a huge force of the occupation army exploded the residence of martyr Abdulrahman Shallodi who was claimed to run over settlers in Jerusalem during the past month. Noteworthy, the severely injured Shallodi was lynched after being arrested.

The Israeli occupation spread its troops over the entrances and in the roads of Silwan neighborhood, where the martyr house is located. A massive force broke into the family house and evicted its interior, witnesses said. The building in which the Shallodi's house is founded was fully evacuated from the 8 families residing in it and Shallodi's apartment was blown up causing damages in the neighboring apartments.

It should be marked that demolition decision was only made after pressure on the court responsible from Israel Security Agency known as Shabak.

Amer Shallodi asserted the following:

The Israeli authorities evacuated the residents of the Shallodi family and three neighboring families and forced them to leave and detained them in a tent in Silwan for several hours despite the cold weather. A huge explosion shook the town of Silwan and the neighboring areas around 4 a.m. after the Israeli forces blew up the house using dynamite.

He also added:

After the residents went back to their apartments, they were surprised to find out that the contents of their apartments were searched and damaged. Not only that , our houses smelled like urine , which we later found out that soldiers urinated on our own belongings. Now, the martyr family resides we us in my house.

The policy of home demolition in the occupied Jerusalem comes within a deeply rooted Israeli policy aiming at indigenous displacement and ethnic cleansing that is carried out against Jerusalemites following the popular unrest and revolt since July

2014. Jerusalemites' reaction only came as a response of colonists violations and attacks on people and the city itself.

Demolishing a building that is still under construction in Al-Tur

The occupation municipality's bulldozers demolished on Wednesday morning a building that is still under construction and owned by "Abu Shu'ayb Al-Hadreh" in Al-Tur east of the walls of the old City of Jerusalem.

It was reported that a massive force of special units accompanied by a staff from the municipality broke into the place and bulldozers embarked on demolishing the structure claiming it unlicensed; the family confirmed that the demolition process was done with prior notice and without a demolition order.

Al-Hadreh family started the construction of this building 4 months ago and the grand floor which is nearly 850 square meters and will be used as a parking lot.

The mayor of Israel occupation has lately activated a policy of "home demolition and chasing the unlicensed structure".

On the other side, same bulldozers torn down a barrack owned by citizen Mohammad Abu Jijmeh, who used it for agricultural affairs.

Violation of the Right to Housing- demolition threats

In a series of collective punishment: Israel serves the families of Abu Al-Jamal Martyrs demolition orders

The families of Ghassan and Odai Abu al-Jamal were delivered demolition orders on their homes located in the area of Jabal al- Mukabbir, south of east Jerusalem following the killing operation in a synagogue that is located in Givat Sha'ol. Noteworthy, Givat Sha'ol is the Palestinian village of Deir Yassin, whose people were slaughtered in a collective massacre in 1948 by Zionist gangs.




Photo to the right: an attached aerial photo of the location

The demolition orders mentioned that demolition will be inflicted on Odai Abu al-Jamal residence in the area of Jabal al-Mukabbir same as on Ghassan's house also located in Jabal l-Mukabbir as a punishment on shooting 7 and killing 5 people in Torah synagogue in the neighborhood of Har Nov.

The order spoke of itself as a deterrent for whoever thinks of similar attacks in the future. Finally, the order ended up giving people a chance to appeal in a period until November 22, 2014 as maximum.

The house of martyr Odai is a one-story house the is of 132m² in area. The place is home for 8 members including 2 minors, the grandmother Fatima(107 years) and her daughter Zahia (64). It is worth mentioning that this premises was built in 1967, which in other words means before the Israeli occupation on Jerusalem.



The family has evicted the house fearing that the authorities of the occupation might blow up the house in any minute. The family now resides with relatives as a result.

The Israeli police requested the wife of the Martyr Ghassan Abu Al-Jamal, Nadia Abu Al-Jamal, to go to Al-Maskobyeh on Sunday morning November 11, 2014 to formally inform her of the decision made by the Israeli Minister of Interior to cancel her “application of residency”.


The family of Abu al-Jamal suffer a bad financial situation given that the father doesn't currently work and is suffering from heart disease. Noteworthy, Six heart operations were ran on the father lately. Ghassan's mother said that he worked once in awhile as the case with martyr Odai Abu al-Jamal.

The Israeli authorities are still keeping the bodies of the 31-year old Ghassan Abu Al-Jamal and his 22-year old cousin Odai Abu Al-Jamal and refuse to give them to the their families to bury them. The Israeli Minister of Internal Security announced on the day of their Martyrdom that they will be buried outside Jerusalem in the cemetery of "Numbers" . An Israeli official said: “not releasing the bodies is to deter others from committing similar operations.”

Having all the above-mentioned inflicted on Abu al-Jamal family, Israel has practiced all kinds of illegal violations of human rights against them. The fact that the residency permit of Ghassan's wife will be withdrawn is destructive for the mother and her three kids Waleed(4), Salma(3) and Mohamad (2).

Administrative demolition order on two residences belonging to Abbasi family :¹

The staff of the occupation municipality delivered on Monday, November 11, 2014 an administrative demolition order on two apartments belonging to Abbasi family from the neighborhood of Jabal al-Mukabbir under the pretext of unlicensed construction. Citizen Abbasi said that the municipality staff raided the family house and hanged the



orders on the walls. The notified apartments are owned by Islam and Iman Abbasi. Abbasi also pointed out that the homes were built three months earlier on a land relative to Arab al-Sawahra area and that each apartment is of 80m² in area. It should be noted that the houses are home for 12 members.

Serving demolition orders in Silwan and arresting three young men:²

The staff of the occupation municipality delivered on November 12, 2014 administrative demolition orders in Silwan area under the pretext of unlicensed construction.

Eye witnesses said that a staff from the occupation municipality raided the neighborhoods of Silwan and served a number of demolition orders on residences. At time, verbal altercations took place between some young men and police, who in this regard pepper-sprayed them and arrested them.

From another side, Israeli forces arrested citizen Anan Baydon after raiding his house in the neighborhood of Wadi Hilweh under the pretext of establishing his home on a land belonging to the Authority of Antiquities.

Issuing construction fines on Palestinian residences in al-Bustan neighborhood/

Silwan :

A massive force of Israel border police and special unit troops accompanied by a staff from the occupation municipality raided al-Bustan area and delivered financial fines on houses in addition to construction fines on more than ten families.

Disturbing administrative demolition orders in Silwan neighborhood³:

Joint crews from the Jerusalem municipality and Special Forces raided on Monday the town of Silwan and distributed demolition orders for several houses, commercial stores and barracks.

Wadi Hilweh Information Center was informed that the municipality crews took pictures of the residential establishments and commercial stores in some of the neighborhoods and alleys of Silwan.

Daoud Siam explained that the municipality hung an administrative demolition order on a building owned by his family in the neighborhood of Bi'er Ayoub in Silwan.

Daoud also explained that the demolition order is for the third and fourth floors of a building that consists of 5 floors and that is owned by him and his brothers Maher and Ayoub. Each floor consists of two rooms, a living room and their facilities and they were built in 1995. Ayoub, his wife and their children (10 individuals) live in one of the floors and Maher, his sister and her children (10 individuals) live in the other; note that the area of both floors is 260 square meters.

Daoud pointed out that several demolition orders were issued against those two floors by the Jerusalem municipality and he had appealed the decisions and paid more than 850 thousand NIS in violation fines. In the last two months, he had paid more than 50 thousand NIS for the lawyers and engineers.

The municipality crews also handed a demolition order to a parking garage owned by Eyad Ramadan Siam and a grocery store owned by the family of Abu Hadwan in Wadi Hilweh. They also took pictures of the house of Jawad Siam, director of Wadi Hilweh Information Center, and the neighborhoods of Silwan.

The joint crews also handed a demolition order to a parking garage in Ein Al-Lozeh which should be executed within 30 days.

The occupation municipality imposes a big fine on Ahmad Siam

A staff from the occupation's municipality accompanied by special forces raided the area of al-Bustan neighborhood in Silwan on November 23, 2014 and proceeded imposing financial fines on houses and shops for not paying the taxes.

Among those affected, the municipality imposed a fine of 20 thousand NIS on Ahmad Siam or actual imprisonment for 100 days under the pretext of building without a permit.

Siam explained that he was surprised by the municipality's decision and explained that the building has been established 20 years ago. He pointed out that he tried to obtain a permit for his apartment but to no avail.

Land expropriation

A military order stating extension on land grab from Beit Iksa and Biddou villages:

The authorities of the Israeli occupation served on November 08, 2014 a military order indicating extension on the confiscation of 31 dunums from the lands of Beit Iksa within the natural block no. 7 and the village of Biddu within the natural block no. 3. The extension order came under the pretext of security reasons and mentioned that the confiscation shall be extended until 31/12/2017 or 3 years in other words.

According to the military order entitled " extension and amendment C/05/212" and signed by Israel army commander Nitzan Alon, it is noted that the occupation authorities are intending to establish a apartheid wall on the two sides of the road leading to Beit Iksa in addition to confiscating a plot near the checkpoint set up at the village's entrance. If implemented , the village will be trapped and people's movement will be limited with complex procedures on exit and entry to the village.





Three year extension on a confiscation order

The authorities of the Israeli occupation served on November 09, 2014 a military order indicating extension on the confiscation of 1500m² from the lands of Um Laison within the natural block no. 7 and the area of Lail al-Nada within the natural block no. 6. The extension order came under the pretext of security reasons and mentioned that the confiscation shall be extended for 3 years.

Noteworthy, the military order entitled " extension C/47/03" was signed by Israel army commander Nitzan Alon. Also, the order gave the lands' owners a 10 day objection period on the plan in Israel Civil Administration starting from the date of its issuance.



The confiscation extension order

Advertising the confiscation of 35.1 dunums from Beit Hanina :

Israeli authorities delivered on Wednesday an order to the town of Beit Hanina to the north of Jerusalem indicating their seizure of 35 dunums of Palestinian land.

According to the Israeli 0404 news website, the seizure order was signed by the Israeli military commander in the occupied West Bank, Nitzan Alon.

The order stated that 35.1 dunum-sized land belonging to Beit Hanina will be seized for 'special security reasons', citing as a pretext the 'latest events' and 'local security needs'.

It further stated that Palestinian landowners may file an application to obtain compensations.

Colonial Plans


Ratifying the establishments of hundreds of new colonial units on Israeli colonies :

The office of Israel Prime Minister said on 18/12/12 that they are planning on going ahead with an extension to the colony Ramat Shlomo in North Jerusalem and the colony Har Homa founded on lands from Jerusalem and Bethlehem.

Prime Minister Netanyahu, has lately approved , master plans for colonies in an unprecedented step taken against Palestinians as a collective punishment. This step came to show the contradiction between the complications the Palestinian building is going through and the facility given to Israelis in this regard.

On November11, 2014 Prime Minister Netanyahu ratified the following :

1. Plan no.11094: it indicates adding 660 colonial units in Ramat Shlomo at the expense of 174 Palestinian dunums from the lands of Shu'fat and Beit Hanina. The Planning Committee relative to the occupation municipality conducted on November04, 2014 a meeting ,through which the establishment of new 500 colonial units were approved within the plan ratified by Netanyahu a day earlier.



2. Plan no.13308: the plan was also known as "Western Har Homa" ,which approved on the annexation of 400 new colonial units on lands owned by Palestinians. Noteworthy, the colony is founded on lands form Bethlehem and parts of Jerusalem.

In a meeting for the Planning Committee relative to the occupation municipality on November 05, 2014, the following colonial plans were approved :

- Plan no.TPS8186: it indicated the expansion of Ramot colony that is founded on lands form Beit Iksa and Samuel through annexing 216 units within three buildings.
- Plan no.TPS6576: it indicated the annexation of 28 colonial units in Ramot within one building .
- Plan no. TPS10310: it indicated the expansion of Har Homa through annexing 62 colonial units within two buildings.

Closures

Israeli occupation authorities set up checkpoints and roadblocks in Jerusalem neighborhoods:

The authorities of the occupation practiced the policy of closures on Palestinian neighborhoods of Jerusalem through setting up checkpoints and roadblocks. This step came within the collective punishment on Jerusalemites and included the following neighborhoods (Al-Eisawaya, Al-Thawri, Jabal al-Mukabbir, Sur Bahir, Silwan, Ras al-Amod and al-Ram).

For example, troops of the occupation army set up a checkpoint at the entrance of al-Eisawaya town and proceeded to check cars and citizens who pass through it. As a result, high fines were imposed on cars.

As for Sur Bahir, Jabal al-Mukabbir and al-Thawri, Israeli occupation authorities set up roadblocks (cement blocks) and firmly shut down all entrances to deny Jerusalemites access to Jewish neighborhoods in a clearly discriminative way to separate both.

It should be marked that such closures caused citizens huge losses for kids were not able to go to school same with workers heading to their jobs; the distance to the area bus station now doubled which will hinder people from being at time to their destinations.

Harassingly, police along with a staff from the municipality issued fines on cars parking on sides of the roads starting with 250 to 500 INS. This step was taken to keep people away and hindering them from praying in al-Aqsa mosque especially on Friday.

Colonists attacks

1. Nov Tzion colonists attack Jerusalemites in Jabal al-Mukabbir:

On November 08, 2014 a group of right-wing extremists from Nov Tzion threw rocks on people , cars and residences in the area of Jabal al-Mukabbir, southeast of occupied Jerusalem. Another 25 colonists organized a provocative rally under heavy protection of the Israeli police marching from Beit Orot colony that is located on confiscated lands from al-Tur neighborhood.

2. Fanatic colonists try to attack citizen Daoud Siam in Wad al-Juz neighborhood:

On November 10, 2014, extreme colonists attacked citizen Daoud Siam while driving his car. Resources said that a car driven by colonists stopped by Siam's car on the traffic light leading from Wad al-Juz and Ramat Eshkol colony to the road no.1. Colonists yelled at Siam and stepped off the car trying to open his car and assault him but he managed to flee. The side mirror was broken as a result.

3. Fanatic colonists attack cars from Beit Safafa :

On November 11,2014 a group of colonists wrote discriminative slogans against Arabs in the area of Beit Safafa and flattened the tires of 5 cars belonging to (al-Kahleh, al-Mukhtar, Ibrahim, and Khalil families). Colonists also wrote " No for cars, No for terror attack" in reference to the ramming operations in Jerusalem. Residents of the area said it's the fourth time they got their vehicles attacked.

4. Lynching citizen al-Ramoni from Jerusalem :

At dawn of November 17, 2014, a group of extreme colonists lynched citizen Yousef Ramoni (32) using a rope to hang him up. The killing happened when Ramoni was at work driving a bus relative to an Israeli transportation company.

5. Beating the young man Fadi Radwan up in Jaffa street :

The 22-year old Fadi Jala Radwan was injured in his back and right leg after being stabbed by four extremist colonists in Jaffa Street in West Jerusalem. Colonists stopped him asking for a lighter just to make sure that he is an Arab and then they proceeded their attack.

6. Colonists run over a woman in Shu'fat with the intent to kill her :

A colonist ran over the Jerusalemite woman, Suzan Al-Kurd(34), on Friday November21, 2014 while she was walking in the main street of Shu'fat heading to the Mosque. As a result, Suzan sustained several injuries in her lower part of the body.

7. Colonists assault the young man Ahmad Yacoub Al-Ghoul

Three settlers assaulted on Friday November21,2014 the 22-year old Ahmad Yacoub Al-Ghoul and hit him on his eye while he was in a car with two of his friends in the area of the Damascus gate/ Jerusalem.

8. An extremist colonist break into a house in Silwan and assault Ne'ma Abu Hadwan

The 57-year old Ne'ma Abu Hadwan was injured with severe burns in her face and neck after she was sprayed with pepper gas by an extremist colonist that broke into Abu Hadwan's house in Dung Gate while she was sleeping. The attacker then ran towards the Wailing Wall through Dung Gate.

9. A colonist runs over kid Khalil Kiswani with the intent to kill him :

A colonist intentionally ran over the 14 years old Khalil Khames Al Kiswani with his car and dragged him until he suffered from several fractures in his left leg.

Khalil said the following to an Land Research Center observer :

On November 11,2014 I was in the company of the truck driver Mohamad Burghal ,who works with my father, heading the area of Romena to move some constriction materials. After we asked for directions in a gas station we stopped at , we arrived to the place where we are supposed to download the materials in when suddenly a car hit me from the back in my left leg throwing me a distance of 2 meters ; the colonist tried to run me over again but I hided under the truck. Looking at the colonist face, I recognized that he was following me from the gas station.

He also added:

The truck driver took me to Hadasa Medical Centre to receive medical care in al-Eisawaya area after the ambulance and police came half an hour late . After running different tests, doctors said I had a severe fracture in the leg; and before discharging me, police took my testimony.

Khamis Kisawani who is the kid's father said that he will submit a complaint for police and ambulance took so long to come to the scene and provide help to his son.

10. Assaulting the young man

Mahmoud Obaid in al-Eisawayya :

The 19-year old Mahmoud Isam Obeid was injured with bruises in his leg after five settlers attacked him near the settlement of “French Hill”.

The young man was on his way to the village of Eisawayya when a car with five settlers



inside stopped near him. One settler asked him for a “lighter” and the young man responded that he did not have one. According to Mahmoud, the settler got out of the car and pushed Mahmoud who pushed the settler back.

Mahmoud added that four other settlers got out of the car and attempted to attack him with sticks, knives and screwdrivers that they had with them but he managed to run away.

The young man’s father took his son to Al-Maqased hospital and he was injured with bruises in his left leg.

11. Colonists assault young man Islam Obaid

in the area of Deir Yassin:

A group of 7 colonists has attacked the 25 years old Islam Obaid on November 25, 2014 through assaulting him from behind with sharp tools on his neck while he was at work in Deir Yassin.



12. Colonists attack young man Majdi Najib

Several colonists assaulted on Sunday morning November 30, 2014 the 26-year old Majdi Majed Najib and severely beat him while he was at the light rail station near Damascus Gate in Jerusalem.



13. Assaulting the young man Akram Ouaidah in al-Eisawayya town :

On November 30, 2014, three guard at the light rail station attacked citizen Akram Ouaidah (23) while he was present at the "French Hill" station, north of the old city of Jerusalem. The young man sustained injuries and bruises on his shoulder and neck.

Attacks on religious sites

Al-Aqsa mosque is still witnessing continuous yet frequent break-ins :

The Authorities of Israeli occupation continued applying its policy in targeting al-Aqsa mosque through letting hundreds of extreme colonists inside the mosque. This is to impose sovereignty on al-Aqsa claiming it the Temple Mountain. Despite the popular revolt in the city of Jerusalem, the occupation went on implementing its plans, which aim at dividing al-Aqsa mosque chronologically and spatially.

The number of raids and break-ins has notably increased during November 2014. This came after heads of religious parties called on Jews to mount the Temple Mountain. Not only that, those people called to demolish the current mosque and establish the so-called Temple especially after the Jewish rabbi Yuda GLik was injured in an assassination attempt.

Break-ins on al-Aqsa mosque were documented as follows :

1. November 02,2014: a number of colonists broke into al-Aqsa mosque and dishonored its compound
2. November02,2014: the Israeli occupation let colonists into al-Aqsa mosque and deny Muslims access.
3. Novembe03,2014: Israeli troops set up checkpoints at the roads leading to al-Aqsa mosque, detained the ID's of worshipers, and allowed colonists inside the mosque to perform prayers.
4. November 04,2014: al-Aqsa broken into by colonists and Muslim worshipers banned from praying

5. November 04,2014: a staff from the ministry of Endowment discovered a hole –opened by strangers- in al-Rahmeh cemetery that leads into al-Aqsa mosque.
6. November 06,2014: Israeli troops and intelligences break into a;-Aqsa mosque compound amidst of Muslim chanting Allah is Great
7. November 10,2014: the Israeli occupation deny Muslims access to al-Aqsa mosque and allow colonists in.
8. November 11m2014: the Israeli occupation allows colonists inside al-Aqsa mosque amidst of intense protection of the police,
9. November 12, 204: Israeli troops assault people stationing at al-Aqsa mosque and allow colonists inside of it.
10. November 17, 214: colonists break into al-Aqsa mosque amidst intense protection of Police
11. November 18, 2014: colonists break into al-Aqsa mosque through Dung Gate and wander around in the compound
12. November 19, 2014: Israeli police detain worshipers' IDs at al-Aqsa gates and deny women entry to it.
13. November 20, 2014: Israeli police assault women protesting at al-Aqsa gates and deny them entry to it.
14. November 23, 2014: Colonists break into al-Aqsa mosque again
15. November 27,2014: Israeli police troops deny Muslims entry to al-Aqsa mosque and allow colonists inside of it.
16. November 30, 2014: the occupation authorities ban women from entering al-Aqsa mosque and assault them where colonists are welcomed inside.
