Israeli Violations' Activities in the oPt 03 May 2014

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded and searched several Palestinian houses and shops in Asira Al-Qibliya village, south of Nablus city. 8 of the targeted houses are owned by: Ahmed Yasir, Ayman Wassef, Akram Wassef, Abd Al-Hafid Suliman, Abu Abdalla Ash-Shami, Bassam Jouda and Abd Al-Karem Al-Mukhtar. Clashes erupted between Palestinians and the IOA, where the IOA fired teargas and stun grenades at Palestinians and houses, causing dozens of suffocation cases. During the operation, the IOA detained for few

hours a number of Palestinians. During the operation, the IOA closed all the entrances of the village, and prevented Palestinians from leaving or entering the village. (Al-Quds 3 May 2014)

- Israeli Occupation Army (IOA) stormed and toured in several areas in Nablus city. (RB2000 3 May 2014)
- Israeli Occupation Army (IOA) and Israeli settlers invaded and toured in An-Naqura village, northwest of Nablus city. (RB2000 3 May 2014)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Bashir Hamid Ziyada (31 years) from Madama village, south of Nablus city, after stopping him at Huwara military checkpoint, south of Nablus city. (Maannews 3 May 2014)
- Israeli Occupation Army (IOA) arrested Yazan Issa Abd Al-Muti (18 years) after raiding his family house in Beita village, south of Nablus city. (Maannews 3 May 2014)
- Israeli Occupation Army (IOA) arrested Faiz Ahmed At-Mizi (36 years) after storming and searching his house in Idhna town, west of Hebron city. (Wafa 3 May 2014)
- Israeli Occupation Army (IOA) arrested Sa'd Mohammad Haroun Haliqa (27 years) after storming his house in Shuyyukh Al-Arroub village, north of Hebron city. (Wafa 3 May 2014)
- Israeli Occupation Army (IOA) detained two Palestinian children; Saleh Abbas Mahmoud and Waleed Imad Ahmed, from Silat Al-Harithiya village, northwest of Jenin city, while they were playing in their family land in the village. (Wafa 3 May 2014)
- Israeli Occupation Army (IOA) summoned Ala' At-Titi, a Palestinian journalist, to interview the Israeli Intelligence Police in Gush Etzion settlement bloc, after storming his house in Al-Arroub refugee camp, north of Hebron city. (Safa 3 May 2014)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) uprooted 50 olive trees in Al-Jamjum area in Nahhalin village, west of Bethlehem city. The targeted trees are owned by: Abd Al-Mutaleeb Fanun, Na'em Abd Al-Rahman Fanun, Daoud Fanun and Mohammad Taha Fanun. (Al-Quds & PNN 3 May 2014)
- Israeli settlers razed Palestinian land, north of Salfit city, to establish an Israeli cemetery in the northern part of the city. (RB2000 3 May 2014)

Erection of Israeli checkpoints

- Israeli Occupation Army (IOA) erected military checkpoints at the entrances of Sa'ir, Yatta, and Halhul towns and Al-Fawar refugee camp in Hebron governorate. The IOA stopped and searched Palestinian vehicles and checked ID cards. (Wafa 3 May 2014)
