Israeli Violations' Activities in the oPt

01 August 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) invaded Bab Ar Rahma cemetery in the old city of Jerusalem. (Wafa 1 August 2016)
- Israeli Occupation Army (IOA) stormed and searched dozens of Palestinian houses in Al Kum village, west of Hebron city. (Safa 1 August 2016)
- Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing near Rafah city shore, southwest of Gaza strip. (Wafa 1 August 2016)

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Ad Duheisha refugee camp, south of Bethlehem city. The IOA fired live bullets and teargas grenades, causing tens of suffocation cases and the injury of a Palestinian. During the clashes, the IOA arrested Mustafah Al Hasnat (23 years) and Yazan Al Ja'diya (23 years). (Maannews 1 August 2016)
- Israeli Occupation Army (IOA) stormed and searched a number of structures in Qalqiliyah city. Clashes erupted between Palestinians and the IOA, where the IOA fired teargas and stun grenades at Palestinian and their houses, causing the torch of the courtyard of a Palestinian house owned by Musa Swileh. (Maannews 1 August 2016)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Mahoub Qanaze' (44 years) after storming his house in Nablus city. (Maannews 1 August 2016)
- Israeli Occupation Army (IOA) arrested Khalil Idres after storming his commercial store in Baqa village, south of Qalqiliyah city. (Maannews 1 August 2016)
- Israeli Occupation Army (IOA) arrested Adballa Yousif Al Badan from Tuqu village, southeast of Bethlehem city. (Safa 1 August 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Ibrahim Abed Al Hadi Al Hour after storming his house in Surif village, northwest of Hebron city. The IOA transferred the arrestee to unknown location. (Safa 1 August 2016)
- Israeli Occupation Army (IOA) detained a number of Palestinians after stopping them at Al Hamra military checkpoint in the northern of Jordan valley. The IOA closed the checkpoint and opened fire at Palestinian vehicles. (RB2000 1 August 2016)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in Barta'a Ash Sharqiya village, west of Jenin city. The arrestees were identified as: Kamal Abed Huseen Qabha (40 years) and Sufian Abed Al Latif Mar'I (30 years). (Al-Quds 1 August 2016)
- Israeli Occupation Army (IOA) summoned Mohammad Ameen Hussen Al Khateb to interview the Israeli Intelligence Police in Gilo 300 military checkpoint, after raiding his house in Hindaza village, southeast of Bethlehem city. (Al-Quds 1 August 2016)
- Israeli Occupation Army (IOA) arrested 15 Palestinians after storming and searching their houses in Dura town, southwest of Hebron city. The arrestees were identified as: Mohammad Ismail Al Faqeh (40 years), Hussen Jabarah Ahmed Al Faqeh (34 years), Kayed Mohammad Al Faqeh (57 years) and his two sons; Firas (19 years) and Mohammad

(27 years), Badir Ziyad Abu Hilal and his brother Iyad, Ahmed Abed Al Majed 'Amirah, Mufed Musa Abed Al Majed Shaded, Anas Ibrahim Abed Al Majed Shaded, Haitham Ismail Suliman At Talahma (34 years), Ashraf Mohammad Khalil Amro (23 years), Khalid Ali Suliman Tabesh, Shaher Abed Al Majed Barboush and his brother Majed. The IOA transferred the arrestees to unknown location. (Wafa 1 August 2016)

- Israeli Occupation Army (IAO) arrested three Palestinians after storming and searching their houses in Sair town, north of Hebron city. The arrestees were identified as: Di'a Issa Musa Tarirah, 'Azam Izzat Sha'ban Shalalda and Diyab Issa Tarwa. (Maannews & Wafa 1 August 2016)
- Israeli Occupation Army (IOA) arrested Taha Abu Khdair from Jerusalem city. (Maannews 1 August 2016)
- Israeli Occupation Army (IOA) summoned Hussam Abu Sninah and Samer Abu Qwadir from Jerusalem city to interview the Israeli Intelligence Police. (Wafa 1 August 2016)
- Israeli Occupation Army (IOA) detained a Palestinian after opened fire at him while he was at the entrance of Kiryat Arba settlement in Hebron city. (Ramallah News 1 August 2016)
- Israeli Occupation Army (IOA) arrested 'Adi Iyad Malah (22 years) and his brother Mohammad (21 years) after storming and searching their commercial store in Jenin city, and confiscated their vehicle. (RB2000 1 August 2016)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al Aqsa mosque in Jerusalem city and toured in its courtyard. (Wafa 1 August 2016)

Home Demolition & Demolition threats

- Israeli Occupation Army (IOA) informed two Palestinian families living in Yatta town, south of Hebron city, that the IOA will demolish their houses during the next 2 days. The targeted houses are owned by the families of the two Palestinian prisoners in the Israeli jail: Mohammad and Khalid Makhamrah. (Safa 1 August 2016)

Israeli Military Orders

- Israeli Civil Administration (ICA) issued a military order to demolish an under construction house in Deir Musa area in Surif village,

northwest of Hebron city. The targeted house is owned by Zahir Ghnemat. During the operation, the ICA took photos for two houses owned by Salah Ghnemat and Omar Ghnemat. (RB2000 1 August 2016)
