Israeli Violations' Activities in the oPt

03 November 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Navy opened fire at Palestinian fishing boats while they were sailing at As Sudaniya shores, northwest of Gaza city, causing the damage in two boats. (Wafa 3 November 2016)
- Israeli occupation Army (IOA) invaded and searched a number of Palestinian houses in Nour Ash Shams refugee camp in Tulkarm governorate, and questioned the residents. One of the targeted houses is owed by the family of the Palestinian prisoner in the Israeli Jail; Adi Sha'ban. (Safa 3 November 2016)

- Israeli Occupation Army (IOA) raided and searched dozens of Palestinian houses in Beit Za'ta area, east of Beit Ummer town, north of Hebron city. Four of the targeted houses are owned by: Ahmed Odeh Sabarnah and his brother Mahmoud, Mohammad Abed Al Qader Sabarnah and Mohammad Hussen Sabarnah. (Wafa 3 November 2016)
- Israeli Occupation Army (IOA) stormed and searched a Palestinian house in Al Jalda neighborhood in Hebron city, and assaulted the residents. The targeted house is owned by the family of the Palestinian prisoner in the Israeli Jail; Jad Sultan. (Safa 3 November 2016)
- Israeli Occupation Army (IOA) raided and searched a number of Palestinian houses in Hizma town, north of Jerusalem city. (Wafa 3 November 2016)
- Israeli Occupation Army (IOA) assaulted Abed Ar Rahman Ahmed 'Atarah (10 years) after storming his family house in Zabuba village, northwest of Jenin city. During the operation, the IOA occupied the roof of a house owned by Issam Sha'abnah after fired teargas grenades at Palestinians. (Wafa 3 November 2016)
- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Qabatiya village, south of Jenin city, after the IOA stormed and searched a number of Palestinian houses. The IOA fired teargas and stun grenades, and rubber bullets causing tens of suffocation cases. (Wafa 3 November 2016)
- Israeli Occupation Army (IOA) surrounded Al 'Am'aro refugee camp, south of Ramallah city, and closed all the entrances. Clashes erupted between Palestinians and the IOA, causing tens of suffocation cases and the injury of others. During the operation, the IOA stormed a Palestinian house owned by Abu Shosha family and arrested 8 family members, identified as L Zuhdi Diyab Abu Shosha and his wife Jihad, and sons Mahran, Ihab, Mohammad Fadi, Baha and Diyab. (Maannews 3 November 2016)
- Clashes erupted between Palestinian students and the Israeli Occupation Army (IOA), while they were leaving As Sawiya –Al Lubban school in As Sawiya village, south of Nablus city. The IOA fired teargas and stun grenades, causing dozens of suffocation cases and the injury of Arij Bassam Rabee (15 years). During the clashes, the IOA arrested two Palestinian students. (Wafa 3 November 2016)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Ahmed Suliman Abu Sundos after storming his house in Abu Al 'Asja village, west of Hebron city. after storming and searched their (Safa 3 November 2016)

- Israeli Occupation Army (IOA) arrested two Palestinians after storming their houses in Dura town, west of Hebron city. The arrestees were identified as: Yousif Nassar and Mohammad Yousif Shaheen. During the operation, clashes erupted between Palestinians and the IOA, where the IOA fired teargas and stun grenades. (Safa 3 November 2016)
- Israeli Occupation Army (IOA) arrested 6 Palestinians after storming and searching their houses in Hebron city. The arrestees were identified as: Bashir Al Jabaly, Dirar Sultan, Abdalla At Tawel and his sons Hazem (29 years), Hamza (16 years) and Mohammad (22 years). (Safa & Wafa 3 November 2016)
- Israeli Occupation Army (IOA) arrested the Palestinian activist and journalist Khalid Ma'ale after raiding and searching his house in Salfit city. (Safa 3 November 2016)
- Israeli Occupation Army (IOA) summoned a number of Palestinians to interview the Israeli Intelligence Police in Salem military base, after storming their houses in Al Yamun village, northwest of Jenin city. (RB2000 3 November 2016)
- Israeli Occupation Army (IOA) arrested Mus'ab and Muhannad Ma'zouz Dalal after raiding their house in Qalqiliyah city. (Maannews 3 November 2016)
- Israeli Occupation Army (IOA) arrested four Palestinians after stopping them at Al Hamra military checkpoint, east of Tubas city. The IOA transferred the arrestees to unknown location. (Al-Quds 3 November 2016)
- Israeli Occupation Army (IOA) arrested three Palestinians after storming their houses in Ash Sheikh Said village, south of Jerusalem city. The arrestees were identified as: Mohammad and Mujahed Ali 'Awisat and Mohammad Daoud Abdo. (Maannews 3 November 2016)
- Israeli Occupation Army (IOA) arrested Hamed Ahmed Hamidat (25 years) in Al Jalazoun refugee camp, north of Ramallah city. (Wafa 3 November 2016)
- Israeli Occupation Army (IOA) arrested two Palestinian students while they were leaving Dar Al Aytam school in the old city of Jerusalem. (Wafa 3 November 2016)

Israeli Settler Violence

- Israeli settlers opened fire at a Palestinian house in Beitin village, northeast of Ramallah city. The targeted house is owned by the family of the Palestinian martyr; Saji Darwish. (Safa 3 November 2016)
- Israeli settler demonstrated in front of the house of Nir Barakat; the Mayor of Jerusalem city, against the sound of the prayer from the

mosque in Jerusalem city, and chanted anti-Palestinian slogans. (Wafa 3 November 2016)

Home Demolition & Demolition threats

- Israeli Occupation bulldozers demolished a water tank and a fence surrounded land in Qusra village, south of Nablus city. The targeted tank and fence are owned by: Mahmoud Ibrahim and Ziyad Odeh. (Wafa 3 November 2016)
- Israeli Occupation bulldozers demolished three commercial stores in Beita village, south of Nablus city. The targeted stores are owned by: Mohammad Riziqalla 'Aqtesh, Issam Mahmoud An Najjar and Mohammad Abed Ar Rahman Odeh. (Wafa 3 November 2016)

Israeli Military Orders

- Israeli Occupation Army (IOA) handed out military orders to demolish a house, three agricultural room and an agricultural water well in Qusra village, south of Nablus city. The targeted structures are owned by: Qousi Zayda, Ziyad Odeh, Hani Ismail and Musbah Salah. (Wafa 3 November 2016)
- Israeli Civil Administration issued demolition orders that targeted 10 residential tents and agricultural structures in Al Mu'arajat area, east of Ramallah city. (Al-Quds 3 November 2016)

Expansion of settlements

- Jerusalem Approves Construction of 181 Housing Units Beyond the Green Line. U.S. State Department says Israel's actions raise questions as to its commitment to a negotiated settlement with the Palestinians. The Jerusalem Municipality confirmed that it had approved construction in Gilo, a Jerusalem neighborhood beyond the Green Line, leading to a rebuke by the U.S. State Department. The Jerusalem Local Planning and Building Committee approved on Wednesday the construction of 181 new housing units in the neighborhood. The approval was part of a procedure for granting building permits, the last stage of approval before the actual start of construction. U.S. State Department spokesman John Kirby condemned the decision on Wednesday evening, saying that the United States strongly opposes construction in settlements, and accused Israel of actions that "risk entrenching a one-state reality." Such actions, he added, raise questions as to the Israeli commitment to a negotiated settlement with the Palestinians. Infrastructure work at the Gilo site began over a year ago,

but was delayed for several months after ancient graves were discovered there, leading ultra-Orthodox figures to exert pressure to stop construction. In the end, additional funds were invested, and the plan was changed in an effort to move farther away from the site of the graves. Seven hundred housing units, intended mainly for the ultra-Orthodox community, are planned for at the site. The new area of construction, called "Gilo Slopes," slightly extends the neighborhood toward the valley that separates it from the Palestinian village of Wallajah. ([Haaretz](#) 3 November 2016)

Israeli Closures

- Israeli Occupation Army (IOA) closed with cement blocks the southern entrance of Marah Rabah village, south of Bethlehem city. (Wafa 3 November 2016)
- Israeli Occupation Army (IOA) closed a landfill dump site (for Soil and rock) in Wadi Al Baqar area in Husan village, west of Bethlehem city, and handed out the owner a closure order. The targeted site is owned by Ahmed Salem Hamamrah. (Wafa 3 November 2016)

Other

- Court grants more time to opponents of state's bid to protect outpost. Petitioners have until beginning of next week to respond to government's request for 7-month stay on Amona evacuation. The High Court of Justice on Thursday granted an extension to Palestinian landowners and human rights groups to respond to a state request to push off the mandated dismantlement of a controversial West Bank outpost. The state on Monday had asked the court to grant it an extra seven months to carry the court-ordered evacuation later this year of Amona, which is built on private Palestinian land. Responses to the state's petition were originally to be filed by Thursday afternoon. Petitioners will now have until Sunday to file their response to the state's request, the court decided Thursday. The High Court, after over a decade of legal wrangling, ruled in 2014 that Amona, which lies east of Ramallah, was built on private Palestinian land and must be demolished by December 25. The impending evacuation has threatened to destabilize Prime Minister Benjamin Netanyahu's coalition, which relies heavily on the pro-settlement right. Pro-settler lawmakers have tried to find a legal loophole to keep the outpost in place, but Attorney General Avichai Mandelblit has warned that attempting to legislate approval for the seizure of private lands would be unconstitutional. Amona is the largest of about 100 West Bank

outposts built without permission but generally tolerated by the government. These are in addition to 120 legal settlements. ([Time of Israel](#) 3 November 2016)
