Israeli Violations' Activities in the oPt

06 November 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) tightened its procedures at 'Atara military checkpoint, north of Ramallah city. The IOA stopped and searched Palestinian vehicles and checked ID cards. (ARN 6 November 2016)
- Israeli Occupation Army (IOA) invaded and searched a Palestinian house in Bab Huta neighborhood in the old city of Jerusalem. The targeted house is owned by Nasser Malhas. (RB2000 6 November 2016)

- Israeli Occupation Army (IOA) intensified its presence at Bab Al Amoud area in Jerusalem city. The IOA stopped and searched Palestinians and checked their ID cards. (RB2000 6 November 2016)
- Israeli Occupation Army (IOA) invaded and searched three Palestinian houses and a print shop in Beit Ummer town, north of Hebron city. The targeted structures are owned by: Hassan Faraj, Ahmed Murshed Zashed Awad, Ayesha Awad and Mohammad Awad. (Wafa 6 November 2016)
- Israeli Occupation Navy opened fire at Palestinian fishing boats while they were sailing at Al Waha and As Sudaniya shores, northwest of Gaza strip. (Wafa 6 November 2016)
- Israeli Occupation Army (IOA) attacked a number of Palestinian farmers while they were harvesting olive trees in their land in Kafr Qaddum village, east of Qalqiliyah city, and forced them to leave the area. As a result, Abed Al Muhdi Hikmat (16 years) and Qusi Aqil (20 years) were injured. (Al-Quds & Wafa 6 November 2016)
- Israeli Occupation Army (IOA) prevented Palestinian farmers from Qaryut village, south of Nablus city, from reaching their land which is located near the illegal Israeli settlement of Eli, to harvest olive trees. (Al-Quds 6 November 2016)

Israeli Arrests

- Israeli Occupation Army (IOA) arrested Said Fauiz An Natsha (23 years) after stopping him at a sudden checkpoint erected by the IOA at Wad Sair area in Sair town, north of Hebron city. The IOA transferred the arrestee to unknown location. (Raya 6 November 2016)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searched their houses in Qabatiya village, south of Jenin city. The arrestees were identified as: Suliman Ahmed Khazimiyah (37 years) and Nasser Sobehi Tazaz'ah (25 years). During the operation, the IOA seized a Palestinian vehicle. (Wafa 6 November 2016)
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in Birqin village, west of Jenin city. The arrestees were identified as: Osama Yasser Sobeh (22 years) and Tareq Attalla Sabah (23 years). (Wafa 6 November 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Jamal Ta'amrah (16 years) after storming his family house in Tuqu village, southeast of Bethlehem city. (Wafa 6 November 2016)
- Israeli Occupation Army (IOA) arrested two Palestinians after storming and searching their houses in Hebron city. The arrestees were identified as: 'Ashour Mohammad Abed Ar Rahem 'Aj'louni and Khalid Mansour An Natsha and (Wafa 6 November 2016)

- Israeli Occupation Army (IOA) arrested five Palestinians after storming and searching their houses in the old city of Jerusalem. The arrestees were identified as: Nour Abed Al Latif (60 years) and her son Mahmoud (25 years), Mutasem Hajaj, Jihad Nasser Qous and Qamar Badawi (36 years). (RB2000 & Wafa 6 November 2016)
- Israeli Occupation Army (IOA) arrested Mohammad Abed Al Hamed Hamed after raiding his house in Silwad town, northeast of Ramallah city. (Wafa 6 November 2016)
- Israeli Occupation Army (IOA) arrested Ahmed Matar from Al Issawiya town in Jerusalem city. (SilwanIC 6 November 2016)

Israeli Settler Violence

- Israeli settlers escorted by the Israeli Occupation Army (IOA) stormed Al Aqsa mosque in Jerusalem city, and toured in its courtyard. During the operation, the IOA stopped and questioned Palestinians and detained their ID cards. (Wafa 6 November 2016)

Israeli Military Orders

- Israeli Occupation Authorities issued a military order to demolish a room in An Naqar neighborhood, west of Qalqiliyah city. The targeted room is owned by Ayman Hantash. (RB2000 6 November 2016)

Erection of Outposts

- A Second Unauthorized Settlement Outpost Sprouts in Northern Jordan Valley. Staff from the U.S. consulate in Jerusalem who had been due to visit the area were told by the Israeli Civil Administration not to come, in part due to army exercises there, but witnesses said no exercises were taking place. A new, unauthorized West Bank settlement outpost has been under construction in recent days near an Israel Defense Forces' training area in the northern Jordan Valley. About two months ago, a group of Israelis built a hut in the Megamat Netzah area and then left. But according to residents of the area and members of the Jewish-Arab Ta'ayush organization, on the night between Wednesday and Thursday of last week, the Israelis returned, cleared land and began new construction activity. A spokeswoman for the Israeli Coordinator of Government Activities in the Territories confirmed that the construction was illegal and had been carried out without the authorities' approval. "The [Israeli] Civil Administration will act to stop the work and, if necessary, tools will be confiscated," she said. This is the second unauthorized outpost that Israelis have

begun building in the area in the past six weeks. The first outpost was built on privately owned land near the long-standing Givat Salit outpost, from where some of the buildings were relocated to a hilltop overlooking the site. The new site contains an animal pen, large wooden shed, water tank and water pipeline running down the hill. Two weeks ago, the COGAT spokeswoman told Haaretz that stop-work orders were issued against the first outpost, in an area known as Khalet Hamed, adding that further steps would be taken if necessary “based on professional and operational considerations.” The settlers at the site have been stopping the Palestinian shepherds from accessing the hilltop in the area. The shepherds have used the hill for decades as a livestock-grazing site. In late September, several days after the first outpost was established, the Civil Administration demolished the shepherds’ residential structures, including restroom facilities, water tanks and livestock pens, saying they were built without a permit. Last Tuesday, the Israeli army carried out training exercises in the area and the shepherds were ordered to vacate the area as a result. Two days later, members of the U.S. consulate staff in Jerusalem had been scheduled to visit the area, accompanied by women from the Machsom Watch group (which monitors the conduct of soldiers at checkpoints). A Civil Administration unit told them not to come, on the grounds that the visit had not been coordinated in advance, and it was claimed that military exercises were again scheduled there. Members of Machsom Watch who visited the area in any event told Haaretz that no military exercises were taking place, and that the army presence in the vicinity was actually lighter than usual. Erection of Israeli checkpoints

- Israeli Occupation Army (IOA) erected a military checkpoint between Jayyus and Azun villages, east of Qalqiliyah city. The IOA stopped and searched Palestinian vehicles and checked ID cards. (RB2000 6 November 2016)
- Israeli Occupation Army (IOA) erected military checkpoints at the entrances of Ad Dhahiriya town, Al Fawar refugee camp, and the southern entrance of Hebron city. The IOA stopped and searched Palestinian vehicles and checked ID cards. (Wafa 6 November 2016)
