## Israeli Violations' Activities in the oPt

30 November 2016

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Israeli Occupation Army (IOA) notified more than ten families in Kherbit Ar Ras Al Ahmar, east of Tubas city, to evacuate their homes under pretext of performing a military trainings. (Wafa, 30 November 2016).
- Israeli Occupation gunboats opened fire at Palestinian fishing boats while they were sailing at As Sudaniya shores, northwest of Gaza city. . (HR, 30 November 2016).

- Clashes erupted between Palestinians and the Israeli Occupation Army (IOA) in Abu Dis village, east of Jerusalem city. The IOA fired rubber bullets and teargas grenades, 50 Palestinians were injured during clashes. ( Maannews,30 November 2016).

## **Israeli Arrests**

- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in Hebron city. The arrestees were identified as: Ramadan saead Abu Rmooiz (53 years), Shaaban Abu Rmooiz (50 years). (Wafa, 30 November 2016).
- Israeli Occupation Army (IOA) summoned a Palestinian woman, from Qatanna village northwest of Jerusalem, is calling for investigation today. (Wafa, 30 November 2016).
- Israeli Occupation Army (IOA) arrested three Palestinians after raiding and searching their houses in Al 'Arrub Refugee camp, north of Hebron city. The arrestees were identified as: Sharaf Wael Ballasi (15 years), Hamza al-Sharif (16 years) and Youssef al-Sharif (15 years). (HR, 30 November 2016).
- Israeli Occupation Army (IOA) arrested Bahaa El Din Nazmi Jayyousi (35 years), after raiding and searching his house in Tulkarm city. (HR, 30 November 2016).
- Israeli Authorities renewed the arrest of 21 Palestinian administrative arrestees to periods vary from 2 to 6 months, and 6 others were sentenced for the first time to periods vary from 2 to 6 months. (HR, 30 November 2016).
- Israeli Occupation Army (IOA) arrested Mohamed Moussa Yassin, after raiding and searching his house in Jenin city. (HR, 30 November 2016).
- Israeli Occupation Army (IOA) arrested five Palestinians after raiding and searching their houses in Deir Nidham village in Ramallah governorate. Mohammed Nassar Amir (12 years), Rami Theeb Saleh (12 years), Loay Theeb Saleh (12 years), Khader Abdel-Hafiz al-Tamimi (19 years) and Mohammed Jamal al-Tamimi (21 years). (HR, 30 November 2016).
- Israeli Occupation Army (IOA) arrested two Palestinians after raiding and searching their houses in Ramallah city. The arrestees were identified as: Luay Abdul Rahman Solh (24 years), and Imad Wajih Saleh (27 years). (HR, 30 November 2016).
- Israeli Occupation Army (IOA) arrested Mohammed Dare, after raiding and searching his house in Jerusalem city. (HR, 30 November 2016).

### **Israeli Settler Violence**

- The Israeli settlers continued their attacks on Palestinian citizens in 'Ein As Sakout area in the northern of Jordan Valley. The settlers are continuing tilling lands in in order to grab and cultivate it. (Wafa, 30 November 2016).

### **Israeli Closures**

- The Israeli Occupation Army (IOA) closed the main road between Silwad and 'Ein Yabrud with cement blocks, and thus impose full closure on the two villages. (HR, 30 November 2016).
