Israeli Violations' Activities in the oPt 10 July 2017

 \mathbf{T} he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Israeli Arrests

- Israeli occupation Army (IOA) detained two young Palestinian men from the Gaza Strip after they passed the border fence between the besieged coastal enclave and Israel. The IOA monitoring the border spotted two Palestinians after they crossed the fence. (Maannews 10 July 2017)
- Israeli occupation Army (IOA) stormed al-Duheisha refugee camp in the southern occupied West Bank Governorate of Bethlehem, around dawn, and broke into several homes after bursting open their front

doors. Israeli soldiers showered the camp with rubber-coated steel bullets and tear gas. Before they left, the IOA detained 22-year-old Haidar Izzat Abu Dayya, 18-year-old Yazan Yousif Manna, and 23year-old Muhammad Yousif Milhem. (Mannews 10 July 2017)

• Israeli occupation Army (IOA) detained Palestinian boys aged 11 and 12 years old, during a military raid in the village of al-Judeira in the Jerusalem Governorate of the occupied West Bank. The IOA raided the village and detained 11-year-old Khattab Muhammad Barjas and 12-year-old Hindi Nasser al-Hindi while the two were playing in front of their house. (Mannews 10 July 2017)

Israeli Settler Violence

• Israeli settlers attempted to take over a tract of land belonging to a Palestinian family in the occupied East Jerusalem neighborhood of Silwan, claiming that it had been owned by Yemenite Jews prior to the creation of the state of Israel. Rafaat Basbous, the owner of the land in the Batn al-Hawa area of Silwan, located just south of the Al-Aqsa Mosque in Jerusalem's Old City, said that 20 workers escorted by Israeli occupation Army (IOA) and settlers raided the land adjacent to his family's home and started delimiting the area with barbed wire. The settlers told Basbous that they had obtained a court order stating that the land belonged to Jews. The land was located in a five-dunam (1.23 acre) area that settler organization Ateret Cohanim had been planning to take over, claiming that six tracts of land in Batn al-Hawa had been owned by Yemenite Jews since 1881.
