Israeli Violations' Activities in the oPt

11 July 2017

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

Brutality of the Israeli Occupation Army

• A 13-year-old Palestinian from the occupied East Jerusalem town of Issawiya lost his eye after Israeli occupation Army (IOA) fired a sponge-tipped bullet at the teenager during clashes between Palestinians and the IOA in the town. The injured boy was identified as the 13-year-old Nour Hamdan and was struck by a sponge-tipped bullet when playing with other children on the second-floor balcony of their home. Israeli Arrests

- An Israeli military court at Israel's Ofer detention center in the central occupied West Bank sentenced two Palestinian brothers from the village of Surif in the southern Hebron Governorate to five years in prison for charges related to activities "against Israel." Rafi Jibril Abu Fara, 30, and his 22-year-old brother Alaa were both sentenced to five years in prison and seven years of probation for activities centered on "resisting Israel," In addition, the family has been ordered to pay a 8,000 shekel fine (\$2,240) for Rafi and 2,000 shekels for Alaa (\$560). The brothers were detained in June last year from their home in Surif during an Israeli military raid. (Maannews 11 July 2017)
- Israeli occupation Army (IOA) raided several areas in the southern occupied West Bank district of Bethlehem and detained Yousif Mahmoud al-Sheikh, 24, from Marah Rabah, Hussein Hmeid Taqatqa, 21, from Beit Fajjar, and Akram Adawi from al-Azza refugee camp. (Maannews 11 July 2017)
- The Israeli occupation army (IOA) <u>raided</u> the southern occupied West Bank village of Tuqu to interrogate the brother of a Palestinian man who was shot and killed for allegedly carrying out a vehicular attack. (Maannews 11 July 2017)
- Nine Palestinians were detained in the central occupied West Bank Governorate of Ramallah. They were identified as Ghasan Muhammad Ata, Muhammad Nimir Ata, Udayy Issa Zahran, Abdullah Hamdan Ata, 17-year-old Mahmoud Suleiman Ibrahim, 21-year-old Amin Muhammad Rabee, Yazan Muhammad Rabee, Ayid Abed Ankoush, and Muath Rasmi Abu Alia. - In the village of Sabastiya in the northern occupied West Bank Governorate of Nablus, Israeli occupation Army (IOA) "abducted" 14year-old Muhammad Azim on Monday night after violently beating him in the village. (Maannews 11 July 2017)
- In the Nablus Governorate, Israeli occupation Army (IOA) detained Firas Fayiz Hamid Mansour, 41, from Kafr Qalil. (Maannews 11 July 2017)
- Israeli occupation Army (IOA) detained the 35-year-old Fadil Farajallah in the city of Tulkarem in the northern occupied West Bank "after he was shot and injured. (Maannews 11 July 2017)
- Israeli ccupation Army (IOA) opened fire on a Palestinian vehicle near Shufat refugee camp in occupied East Jerusalem, Riddling it with bullets because the Palestinian, who was later detained, was allegedly driving erratically. The IOA stormed the area and fired heavily at a

Palestinian vehicle before they cordoned off the street. (Maannews 11 July 2017)

Israeli Settler Violence

Clashes broke out between young Palestinian men and Israeli occupation Army (IOA) who stormed the village of Kifl Haris in central occupied West Bank Governorate of Salfit to escort hundreds of Israeli settlers on a visit to pray at a Jewish holy site. Israeli troops closed all of the village's entrances and restricted the movement of residents. The Israeli army had organized the entry of "1,000 Jewish worshipers to visit the tomb of Joshua. (Mannnews 11 July 2017)

Home Demolition & Demolition threats

 Israeli occupation Army (IOA) demolished a four-story, underconstruction building in the occupied East Jerusalem town of Al Issawiya despite its Palestinian landowner having a schedule meeting with Israeli authorities to postpone the demolition. Owner of the building was identified as Hanan Mahmoud. Construction of the fourfloor building -- comprised of six apartments, with the ground floor planned to be used as shops -- started about a year ago. (Maannews 11 July 2017)
