# Israeli Violations' Activities in the oPt

12 July 2017

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

## Brutality of the Israeli Occupation Army

• Israeli occupation Army (IOA) shot and killed two young Palestinians - one 17-year-old and one 20-year-old -- and injured at least two others after a violent military raid into Jenin refugee camp in the northern occupied West Bank erupted into clashes. The two were identified as the 17-year-old Aws Muhammad Youssif Salameh and the 20-year-old Saad Nasser Hassan Abd al-Fattah Salah was shot and killed by the IOA at the scene of the clashes. Meanwhile, the two injured Palestinians, one was injured with an expanding "dumdum" bullet

- lodged in his leg, and the other was injured by shrapnel. (Mannews 12 July 2017)
- A group of officers from Israel's special forces "raided" the Al-Aqsa Mosque compound in the Old City of occupied East Jerusalem. A group of officers from Israel's special forces raided the compound, as one of the officers had an Israeli flag draped over his shoulder in an "obvious attempt to provoke Al-Aqsa guards. Officers' behavior was "dangerous," as they were aiming to "send a message about the sovereignty of Al-Aqsa Mosque and that (Israel) can do anything it wants with the site." (Mannews 12 July 2017)
- Palestinians have long feared that Israel has been attempting to shake up the status quo at the holy site, in the shape of routine Jewish incursions on the site and right-wing Israeli calls to demolish the mosque and replace it with a third Jewish temple. (Mannews 12 July 2017)

### Israeli Arrests

• An Israeli military court sentenced Palestinian Legislative Council (PLC) member Khalida Jarrar to six months of administrative detention -- imprisonment without charge or trial, after the feminist and human rights activist was detained from her home at the start of the month during an Israeli overnight raid. A hearing will be held on July 17 at Israel's Ofer military court in the central occupied West Bank to affirm the administrative detention sentence. The Israeli occupation Army (IOA) detained Jarrar, a long-serving PLC member from the leftist faction the Popular Front for the Liberation of Palestine (PFLP), on July 2 after raiding her home in Ramallah in the central West Bank, 13 months after Jarrar was released from Israeli prison on June 3, 2016 after serving more than a year, one month of which was under administrative detention. #### Home Demolition & Demolition threats

- The Israeli army delivered a punitive demolition order to Ibrahim Saleh family in the village of Deir Abu Meshaal in the central occupied West Bank Governorate of Ramallah in a predawn military raid. The family was given 72 hours to appeal the demolition order. (Maannews 12 July 2017)
- Israel's Jerusalem municipality enforced the demolition of three buildings, which included two homes, in the East Jerusalem towns of Jabal al-Mukabbir and Silwan. In Jabal al-Mukabbir, Israeli bulldozers raided the town of Jabal Al Mukkabir around dawn time and razed the

house of Musa Obidat to the ground for being built without a permit. Obidat was away from his home when the demolition was carried out, and was informed by his neighbours of the raid. The house was built in 2012 and expanded in 2016 to become 200 square meters. Musa Obidat his wife and three children were forced to leave the house after they received a demolition order five months ago. Israeli Municipality also carry out demolitions in the Palestinian community of Silwan, in the Bir Ayoub area. Israeli bulldozers escorted by armed Israeli forces raided the area in the early morning hours and proceeded to demolish a house owned by Salih Shweiki for the second time, after he was forced to demolish it himself in February. Meanwhile, Israeli bulldozers demolished a car wash and its office in Bir Ayoub area. Israeli forces fired rubber-coated steel bullets at a youth in the area, who was then physically assaulted and detained. (Maannews 12 July 2017)
