## Israeli Violations' Activities in the oPt

8 July 2017

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Brutality of the Israeli Occupation Army

• An 18-month old Palestinian infant died, some two months after suffering from tear gas inhalation when Israeli occupation Army (IOA) shot tear gas at Palestinian homes in the village of Abud in the central occupied West Bank Governorate of Ramallah. The infant was injured after clashes broke out across the occupied West Bank on May 19 in support of some 1,300 Palestinian prisoners who were undergoing a mass hunger strike to demand better treatment and conditions in Israeli prisons. At the time, the IOA haphazardly shot tear gas at

Palestinian homes, which caused many residents, including Abd al-Rahman, to suffer from tear gas inhalation. (Maannews 8 July 2017)

- Several Palestinians suffered Gas inhalation as the Israeli occupation Army (IOA) raided Beit Rima village northwest of Ramallah city. (WAFA 8 July 2017)
- A Palestinian construction worker from the southern occupied West Bank village of al-Khader fractured his feet after Israeli occupation Army (IOA) opened fire at him while he was attempting to pass over Israel's separation wall and jumped off of it to escape the bullets. The 41-year-old Hazim Abu al-Sheikh Mousa was trying to traverse the wall in the Wadi al-Hummus area in southern Jerusalem near Sur Bahir, in order to get to work inside Israel along with a group of other workers, who did not have permits needed to pass through the Israeli-controlled border crossings separating the occupied West Bank from occupied East Jerusalem and Israel. After he climbed the wall, the IOA who were on the other side started to fire gunshots, prompting him to jump back. (Maannews 8 July 2017)
- The Israeli occupation Army (IOA) summoned a Palestinian from Al Ubeidiya village east of Bethlehem city for interrogation at the Gush Etzion detention center after raiding his house and searching it. The Palestinian was identified as Hamza Abdullah Al Asa, 35. (WAFA 8 July 2017)

## Israeli Settler Violence

• Israeli settlers attacked Palestinian vehicles passing the Israelicontrolled Bartaa military checkpoint in the northern occupied West Bank Governorate of Jenin. Dozen Israeli settlers hurled rocks at Palestinian vehicles passing through the checkpoint, and broke one Palestinian's car windshield. The Israeli Occupation Army (IOA) did not intervene in the incident, and instead watched the attack on the side. A vehicle belonging to Ibrahim Kabha was damaged in the attack. (Maannews 8 July 2017)
