Israeli Violations' Activities in the oPt 15 December 2018

 \mathbf{T} he daily report highlights the violations behind Israeli home demolitions and demolition threats occupied Palestinian territory, the in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian violence civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Brutality of the Israeli Occupation Army

• Israeli gunboats chased a Palestinian fishing boat, which was sailing within 9 nautical miles in Gaza Valley area, and opened fire at it. As a result, a fisherman, Mohammed Falah abu Riyalah (19), from al-Sadr area in Gaza, was wounded. The Israeli gunboats surrounded the fishing boat mentioned above, and the Israeli Occupation Army (IOA) detained the injured fisherman, Abu Riyalah, and another fisherman,

Mohammed Salah Abu Riyalah (27), from Gaza City, and detained their fishing boat. (IMEMC 15 December 2018)

- Israeli gunboats chased a fishing boat sailing within 8 nautical miles off Gaza Valley shore manned by fishermen Mohammed Saleh Abu Riyalah (28) and 'Atef Saleh Abu Riyalah (16), from Gaza city. The Israeli naval forces ordered both fishermen to stop fishing, arrested them and detained their fishing boat.
- The Israeli Occupation Army (IOA) suppressed the weekly Bil'in march, west of Ramallah city, in the central occupied West Bank. (IMEMC 15 December 2018)
- A Palestinian teenager was killed by Israeli occupation Army (IOA) in the occupied West Bank city of Ramallah. The teen was identified as the 17-year-old Mahmoud Nakhleh, who was shot in the abdomen with live bullets during a protest, in the al-Jalazoun refugee camp. Several people were also injured in confrontations which erupted between Palestinians and invading IOA during protests in Ramallah, against the Israeli settlement construction and the seizure of their lands. (IMEMC 15 December 2018)
- In the village of al-Lubban al-Gharbiyeh near Nablus, a Palestinian youth was injured with a rubber-coated steel bullet to his eye. (IMEMC 15 December 2018)
- Protests took place in the Tequ' village east of Bethlehem and in Hebron's Old City, where dozens suffered from tear gas inhalation and sustained wounds from rubber-coated bullets. (IMEMC 15 December 2018)
- In Gaza, 85 Palestinians were injured during anti-occupation protests along the border between the Gaza Strip and the Israeli-occupied territories. (IMEMC 15 December 2018)
- Dozens of Israeli Occupation Army (IOA) invaded the Campus of Kadoorie Technical University, west of Tulkarem, in the northern part of the occupied West Bank, after surrounding it. The IOA surrounded the campus, and invaded it from the western area, near the Annexation

Wall. The IOA provocatively roamed in the campus, and some of its facilities, before withdrawing. (IMEMC 15 December 2018)

- The Israeli Occupation Army (IOA) stationed in the military tower at the main entrance of the al-Arroub refugee camp, north of Hebron, fired several gas bombs and concussion grenades at local protesters, in addition to many homes. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) injured at least seventeen Palestinians with live fire and rubber-coated steel bullets, and caused many to suffer the effects of teargas inhalation, in several areas of Nablus governorate, in northern West Bank. The Palestinians were protesting near Huwwara military roadblock, south of Nablus, in addition to the towns of al-Lubban ash-Sharqiya, Orif and Beita. Two Palestinians, who were shot with live rounds al-Lubban ash-Sharqiya, and six others were shot with rubber-coated steel bullets. Furthermore, two Palestinians were injured by fragments from Israeli bullets IN Nablus and seven others were shot with rubber-coated steel bullets. One of the wounded Palestinians was also hospitalized after being shot with a rubber-coated steel bullet in his eye. At least nine other Palestinians suffered the effects of teargas inhalation. Many Palestinians also suffered the effects of teargas inhalation in Orif and Beita, and several others suffered cuts and bruises. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) shot a young Palestinian man during protests in the al-Fawwar refugee camp, south of Hebron, in the southern part of the West Bank. The young man, 19 years of age, was shot with live rounds in the abdomen. Several Palestinians suffered the effects of teargas inhalation. (IMEMC 15 December 2018)

Israeli Arrests

• The Israeli Occupation Army (IOA) detained four Palestinians, including a former political prisoner and a child, in occupied East Jerusalem. The IOA ambushed a former political prisoner, identified as Rami al-Fakhouri, in Wadi al-Jouz neighborhood, in the Old City. The IOA also detained Mohammad Mousa Abu al-Hummus, Mohammad Ashraf Abu al-Hummus and a child, identified as Sami Anwar Abu Obeid, 14, from the al-'Isawiya town, in the center of Jerusalem. (IMEMC 15 December 2018)

- The Israeli Occupation Army (IOA) stormed and violently searched the home of Lu'ay Mohammad Gheith in Hebron, causing excessive damage, before detaining him. The IOA invaded many neighborhoods in Hebron city, and were heavily deployed in various streets and alleys, before obstructing Palestinian traffic. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) invaded homes in Beit Awwa town, southwest of Hebron, and summoned Mohammad Jamil Masalma, 26, for interrogation. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) detained two Palestinian siblings, after stopping them at a military roadblock, in the southern area of Hebron city, in the southern part of the occupied West Bank. The IOA installed a sudden military roadblock in the southern area of Hebron city, before stopping and searching dozens of cars, interrogated many Palestinians while inspecting their ID cars, and abducted the two siblings. The detained Palestinians have been identified as Shadi Bassam al-Jamal, and his brother, Hamza; they were cuffed and blindfolded, before the soldiers took them to an unknown destination. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) stationed in the military tower at the main entrance of the al-Arroub refugee camp, north of Hebron, fired several gas bombs and concussion grenades at local protesters, in addition to many homes.
- The Israeli Occupation Army (IOA) shot a young Palestinian man during protests in the al-Fawwar refugee camp, south of Hebron, in the southern part of the West Bank. The young man, 19 years of age, was shot with live rounds in the abdomen. Several Palestinians suffered the effects of teargas inhalation. (IMEMC 15 December 2018)
- The Israeli Occupation Army (IOA) detained two Palestinian siblings, after stopping them at a military roadblock, in the southern area of Hebron city, in the southern part of the occupied West Bank. The IOA

installed a sudden military roadblock in the southern area of Hebron city, before stopping and searching dozens of cars, interrogated many Palestinians while inspecting their ID cars, and detained the two siblings. The two detained Palestinians have been identified as Shadi Bassam al-Jamal, and his brother, Hamza; they were cuffed and blindfolded, before the IOAtook them to an unknown destination. (IMEMC 15 December 2018)

Home Demolition & Demolition threats

- Israeli occupation authorities ordered several Palestinian families from the village of Ebzeiq, in the northern Jordan Valley region of the occupied West Bank, to leave their homes and make way for Israeli military training, in the area. Israeli army served notices to 14 families, ordering them to leave their homes on December 16, 23, 26 and 31, from 6:00am to 2:00pm (local time), on some days, and from 12:00am to 6:00am on other days, to make way for the training. (IMEMC 15 December 2018)
- Dozens of Israeli occupation army (IOA) invaded the home of Abu Hmeid family, in the al-Am'ari refugee camp, south of al-Biereh city, in the Ramallah and al-Biereh Governorate, in the central West Bank, in preparation to demolish a four-story building, and engaged in the excessive use of force against the family, and many other Palestinians. The Israeli military stationed sharpshooters on the tops of all the buildings around the home, and ordered all the families from the neighborhood to evacuate from their homes. An estimated 450 Palestinians were forced out of their homes. The families that were ordered to leave their homes were not allowed to take any blankets or covering with them, or food, they were simply ordered from their homes into the cold winter night. Most of the hundreds of people forced out of their homes went to a nearby outdoor football field at the al-Bireh School to wait for the army to allow them back to their homes. The military broke the windows of the al-Bireh School and caused damage to the school building. (IMEMC 15 December 2018)

Erection of Israeli checkpoints

• The Israeli Occupation Army (IOA) installed many military roadblocks at the main entrances of Sa'ir and Halhoul towns, north of Hebron, in addition to ath-Thaheriyya, Yatta, as-Sammoa' towns, and the al-Fawwar refugee camp, south of the city. The IOA stopped and searched dozens of cars, and interrogated many Palestinians while inspecting their ID cards. (IMEMC 15 December 2018)
