## Israeli Violations' Activities in the oPt 4 December 2018

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

### Brutality of the Israeli Occupation Army

- Dozens of Israeli Occupation Army (IOA) invaded Tulkarem refugee camp, and Tulkarem city, in northern West Bank, killed a mentally disabled Palestinian, and injured several others. The IOA killed Mohammad Husam Abdul-Latif Habali, 22, from Tulkarem city, and injured another young man, after shooting them with live fire. The IOA shot Mohammad, who was mentally disabled, from a very close range, and that he died almost instantly, from gunshot wounds to his head

and limbs. The IOA also injured several Palestinians with rubber-coated steel bullets, and caused many others to suffer the effects of teargas inhalation. Dozens of IOA, many of them in jeeps and others on foot, invaded several neighborhoods in the refugee camp, and Tulkarem city, especially in the Western Neighborhood, and fired dozens of live rounds and gas bombs, during ensuing protests. The IOA invaded and ransacked many homes, causing excessive damage, and interrogated several Palestinians while inspecting their ID cards. (IMEMC 4 December 2018)

### **Israeli Arrests**

- In Nablus, in northern West Bank, The Israeli Occupation Army (IOA) detained Mohammad Keewan, Sobhi Keewan, Ghazi Sha'er, Amro Shehada, Zohdi Theeb Qawareeq, Nasseer Abu Thabet, and Abada Nizar al-Jamal. The Palestinians were taken from their homes in Nablus city, in addition to the towns of Awarta, 'Asira ash-Shamaliya and Beit Dajan. The army also summoned for interrogation, a former political prisoner, identified as Samir Salim Sharab, from Awarta. (IMEMC 4 December 2018)
- In Bethlehem governorate, the Israeli Occupation Army (IOA) invaded Beit Sahour city. (IMEMC 4 December 2018)
- The Israeli Occupation Army (IOA) invaded Ad Doha and al-Khader towns, and fired many gas bombs and concussion grenades, during ensuing protests. (IMEMC 4 December 2018)
- The Israeli Occupation Army (IOA) detained Mohammad Fayez Salhab, 18, from his home in the al-Karkafa area, in Bethlehem. (IMEMC 4 December 2018)
- In Hebron city, in southern West Bank, the Israeli Occupation Army (IOA) detained Mohammad Abdul-Athim Abu Turki, 34, Jawad Shafiq Abu Aisha, Ibrahim Zeidan Rajabi, and Salim Rajabi. (IMEMC 4 December 2018)

- The Israeli Occupation Army (IOA) detained a Palestinian, identified as Mahmoud Abdul-Afo al-Emla, from his home in Beit Ola town, northwest of Hebron. (IMEMC 4 December 2018)
- The Israeli Occupation Army (IOA) detained two former political prisoners, identified as Abdul-Nasser Nasser Abu Maria, 20, and Qussai Ahmad Abu Hashem, 18, in addition to Amro Arafat Za'aqueq, 16, and Majdi Mirshid Awad, 14, all from Beit Ummar town, north of Hebron, before moving them to Karmie Tzur illegal colony, south of the town. (IMEMC 4 December 2018)
- In Tubas, in northeastern West Bank, the Israeli Occupation Army (IOA) detained Yousef Walweel and Zakariya Oleyyan, from their homes in the al-Far'a refugee camp, south of the city. (IMEMC 4 December 2018)
- In Salfit, in central West Bank, the Israeli Occupation Army (IOA) detained a young woman, identified as Tha'era Mousa Qassoul, 24, at the entrance of the nearby Kifl Hares town, while she was on her way to work. (IMEMC 4 December 2018)
- In occupied Jerusalem, the the Israeli Occupation Army (IOA) detained four Palestinians, identified as Tha'er Abu Khalil, Jaber Ahmad Salaheddin, 'Assem Nassif Sa'id and Abdul-Rahman Osama Khatib, from their homes in Hizma town, northeast of the city. (IMEMC 4 December 2018)
- In Ramallah, in central West Bank, the Israeli Occupation Army (IOA) detained Mohammad Fawzi Shalabi, from his home in the al-Mazra'ash-Sharqiya town, northeast of the city. (IMEMC 4 December 2018)

### **Israeli Settler Violence**

- [Ultra-Orthodox American-born rabbi and Knesset member Yehuda Glick](#), along with dozens of Israeli settlers entered the Al-Aqsa Mosque compound in occupied East Jerusalem for the Jewish holiday of Hanukkah. The heavily armed Israeli occupation Army (IOA) escorted Glick along with dozens of Israeli settlers through the Moroccans Gate into the compound. Glick and the Israeli settlers performed prayers

while under the armed protection of Israeli forces and police, who were deployed across the compound. (IMEMC 4 December 2018)

### **Home Demolition & Demolition threats**

- The Israeli Occupation Army (IOA) demolished residential buildings and sheds while looting sums of money from Bedouin Palestinian citizens, in the northern Jordan Valley. The IOA demolished military structures and sheds in Al-Fasayel village of Al-Aghwar, owned by a number of Bedouin families living there. The IOA also stormed a number of houses, looting a financial amount of 50 thousand shekels. (IMEMC 4 December 2018)
- Three Palestinian families were ordered, by the Israeli occupation army, to demolish their homes made of tin, in the Yatta-area village of Umm al-Khair, in the southern West Bank. The army served the three residents, from the Hathalin family, with demolition notices for construction without permit. The homes are located in Area C of the West Bank, which is under full Israeli military control. The IOA invaded the western area of Hares village, west of the central West Bank city of Salfit, and demolished five agricultural and commercial structures. Dozens of IOA invaded the village, before using their armored military bulldozers in demolishing the five commercial structures, owned by his brothers. The demolished structures are owned by brothers Fadi, Nadi and Saleh Suleiman. The IOA claimed they were built without a permit from the Israeli Civil Administration Office. The demolished structures were an agricultural hothouse, a laundromat, a carpentry, a blacksmith and aluminum workshops. Israel issued the demolition orders just a week ago, informing the brothers that they “have one month to file appeals,” however, the IOA demolished the properties within seven days.
