Israeli Violations' Activities in the oPt

5 December 2018

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

The daily report does not necessarily reflect ARIJ's opinion.

Brutality of the Israeli Occupation Army

- The Israeli Occupation Army (IOA) invaded Hebron city and several surrounding towns, in the southern part of the occupied West Bank, violently searched homes, before abducting five Palestinians, including two siblings, and confiscated a car. The IOA detained Nouredin Mohammad Salhab and Eyad Naji al-Atrash, from Hebron city, in addition to Hamza Badawi, from the al-'Arroub refugee camp, and Lu'ay as-Sa'ada, along with his brother, Mahmoud, from Halhoul

town. The IOA conducted violent searched of many homes, causing property damage, and interrogated several Palestinians while inspecting their ID cards. Owners of some of the invaded homes have been identified as Adnan Abu Tabbana, legislative council member Mohammad at-Tell, in addition to former political prisoner Khaled al-Battat. The IOA also confiscated a car, owned by the Khaled al-Battat's son. (IMEMC 5 December 2018)

Israeli Arrests

- The Israeli Occupation Army (IOA) invaded and searched many homes in the al-'Arroub refugee camp, north of the Hebron, and detained Issa Emad at-Teety, 14, and Khaled Badran Jawabra, 19. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) invaded and searched homes in Halhoul town, north of Hebron, and detained a former political prisoner, identified as Maher al-Atrash, 45, before confiscating his car. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) detained Atef Ali Rabba', from Yatta town, south of Hebron, after stopping him at the Container military roadblock, east of Bethlehem. (IMEMC 5 December 2018)
- Dozens of Israeli Occupation Army (IOA) invaded Salfit city, and nearby Iskaka town and Qarawat Bani Hassan village, in Central West Bank, searched many homes and detained four Palestinians. In Salfit city, Israeli Occupation Army (IOA) invaded several neighborhoods, searched homes, and detained Aziz Fattash. The IOA also abducted a former political prisoner, identified as Husam Anis Harb, 58, from his home in Iskaka village, east of Salfit. In addition, the IOA detained Sa'ad Mer'ey, from his home in Qarawat Bani Hassan, west of Salfit. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) invaded Deir Nitham village, northwest of the central West Bank city of Ramallah, searched homes and detained three Palestinians. Several armored military jeeps invaded the village, before the IOA stormed and ransacked many homes, and interrogated a few Palestinians. The IOA detained

Mahmoud Kheir Khatib, 18, Osama Firas Tamimi, 18, and Walid Nassar Ahmad Nassar, 18. (IMEMC 5 December 2018)

- In Bethlehem governorate, the Israeli Occupation Army (IOA) invaded the al-Azza refugee camp, north of the city, detained Rami Firas Abu Sh'eera, 24, from his home. (IMEMC 5 December 2018)
- In Bethlehem, the Israeli Occupation Army (IOA) invaded the al-Khader town, south of the city, and summoned Qussai Abdullah Issa, 24, for interrogation in Etzion military base, after searching his home in the Old City. (IMEMC 5 December 2018)
- In Tubas, in northeastern West Bank, the Israeli Occupation Army (IOA) searched many homes and detained a former political prisoner, identified as Rami Ayman Shareeda, in addition to Salaheddin Talal Daraghma. (IMEMC 5 December 2018)
- In Qalqilia, in northern West Bank, the Israeli Occupation Army (IOA) detained Mohammad Waddah Enaya and Yasser Nofal, after invading and ransacking their homes. (IMEMC 5 December 2018)
- In Hebron, in the southern part of the West Bank, the Israeli Occupation Army (IOA) detained a child, identified as Issa Emad at-Teety, in addition to Khaled Yazan Jawabra, from the al-'Arroub refugee camp. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) detained and a former political prisoner, identified as Maher al-Atrash, 45, from Halhoul town north of Hebron. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) detained Atef Ali Rabba', from Yatta town, south of Hebron, after stopping him at the Container roadblock, east of Bethlehem. (IMEMC 5 December 2018)
- In Tulkarem, in northern West Bank, the Israeli Occupation Army (IOA) detained Mo'men Raslan Areed, from his home in Shweika area, north of the city, and confiscated surveillance recordings from a restaurant in the Western Neighborhood, after invading and searching it. The Restaurant overlooks the street where the killed a mentally

disabled young man, identified as Mohammad Husam Halabi, 22. (IMEMC 5 December 2018)

- The Israeli Occupation Army (IOA) detained Mahmoud Kheir Khatib, Osama Firas Tamimi and Walid Nassar Ahmad Nassar, from Deir Nitham village, northwest of the central West Bank city of Ramallah. (IMEMC 5 December 2018)

Israeli Settler Violence

- An elderly woman was injured, south of the West Bank city of Bethlehem, after a speeding illegal Israeli settler rammed her with his car. The woman has been identified as Fatima Issa, 70, from Jouret ash-Sham'a village, south of Bethlehem. She was rammed by a speeding settler near the junction of Efrat illegal colony, built on Palestinian lands, south of Bethlehem. The wounded woman suffered a dislocated shoulder, in addition to various cuts and bruises. (IMEMC 5 December 2018)

Home Demolition & Demolition threats

- The Israeli Occupation Army (IOA) destroyed a Palestinian family home in Occupied East Jerusalem. A large number of Israeli police officers and Israeli Occupation Army (IOA) stormed the town of Jabal Al-Mukkaber, surrounded and blockaded the house, preventing residents from approaching, and restricting movement of others. The home was still under construction, and the reason given for the demolition was a lack of an Israeli issued permit, seldom awarded to Palestinians. The IOA assaulted the Palestinian family physically and verbally. The physical assault on Palestinians by IOA were caught on video and posted on social media. (IMEMC 5 December 2018)
- The Israeli Occupation Army (IOA) invaded, the Sammoa' town, south of Hebron, in the southern part of the occupied West Bank, and demolished a Palestinian school. The IOA surrounded Seemia area, north of the Sammoa' town, and declared it a closed military zone, preventing the Palestinians from entering it. The IOA then used their armored bulldozers to demolish the Tahadi 13 small school of several classrooms and their facilities. The school was sponsored by the

Palestinian Ministry of Education through European funding, with a total cost of 40.000 Euros, and was supposed to open in two days. (IMEMC 5 December 2018)
