Israeli Violations' Activities in the occupied State of Palestine

30 May 2020

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and/or news sources.

The text is not quoted directly from the sources but is edited for clarity.

Violations of the Israeli occupation Army

- The Israeli Occupation Army (IOA) shot and injured a 31-year-old Palestinian man at Jabara military checkpoint south of the northern West Bank city of Tulkarem. (Wafa 30 May 2020)
- The Israeli occupation Army (IOA) detained two boys from the city of Hebron, in the southern West Bank. The IOA raided the old town of Hebron, and detained Mahmoud Nihad Jaber, 16, and Muhannad Al-Natsheh, 17, after searching their homes and tampering with their contents. (Wafa 30 May 2020)
- A photojournalist was among the five Palestinians injured, when Israeli Occupation Army (IOA) opened fire at protestors, during the weekly protest in the village of Kufur Qaddoum in the northern West Bank. The IOA responded to the peaceful protest by firing rubber-coated steel rounds and tear-gas canisters. Nedal Shtayyeh, a photojournalist with the Chinese Xinhua News Agency was among the five injured, all of whom were treated in the field. (IMEMC 30 MAY 2020)
- The Israeli occupation Army (IOA) detained a young man called Jihad Turkman at the eastern entrance to Ya'bad town in Jenin and confiscated his motorcycle. (PALINFO 30 May 2020)
- The Israeli occupation Army (IOA) detained four young men and seized the car they were aboard near Sebastia town in the north of Nablus province. The IOA set up a makeshift checkpoint at the main entrance to the town and intercepted a car carrying four young men before rounding them up and confiscating the car. (PALINFO 30 May 2020)
- A Palestinian youth with special needs was shot to death by the Israeli police in the Old City of Jerusalem. Israeli police opened fire at a Palestinian youth with special needs near al-Asbat Gate in the Old City, instantly killing him. The Israeli police first claimed the deceased Palestinian was carrying a suspicious object and attempted a stabbing attack, but it later transpired that he was unarmed. The Israeli police

closed off the area and prevented Palestinian citizens from entering or leaving the city. (PALINFO 30 May 2020)

- The Israeli Occupation Army (IOA) heavily opened fire at a Palestinian car near Nabi Saleh village in Ramallah, killing the driver Fadi Samara, 41. (PALINFO 30 May 2020)

Israeli Settler Violence

- Israeli settlers protected by a military escort attacked with stones and empty bottles Palestinian civilians' homes in the Old City quarter, in the occupied West Bank city of Hebron. The Jewish settlers accompanied by soldiers forced their way into the area, attacking homes and terrifying their residents, especially children. The settlers also performed provocative tours across the markets of the Old City, terrorizing store-keepers and passengers and threatening them, with the military doing nothing to stop the assaults. Around 800. (Wafa 30 May 2020)

Home Demolition & Demolition threats

- The Israeli occupation authority (IOA) displaced one Jerusalemite families after forcing them to demolish their own homes in Jabel Mukaber belonged to the brothers Imad and Ahmed Mashahera, who had to raze it after the IOA threatened to make them pay an exorbitant sum of money if its municipal crews carried out the demolition. The IOA justified the measure by claiming the house was built with no license. (MEMC 30 May 2020)
- In Silwan in occupied East Jerusalem, citizen Fares al-Khales was forced to demolish his own house under the pretext that his house was built with no license. (PALINFO 30 May 2020)

Confiscation & Razing of lands

- The Israeli occupation Army (IOA) appropriated a Palestinian-owned agricultural land in Ya'bad town, southeast of Jenin in the West Bank. An Israeli army officer phoned a Palestinian citizen from the family of Abu Bakr and notified him of a decision to seize 3.5 dunums of agricultural land belonging to him near a military checkpoint and the settlement of Mevo Dotan.
