

Israeli Violations' Activities in the occupied State of Palestine 1 September 2020

he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Violations of the Israeli occupation Army

- Confrontations erupted after the Israeli police invaded al-'Isawiya town in occupied East Jerusalem and opened fire with tear-gas canisters, towards Palestinian youths. Several youths in al-'Isawiya town, protested the police invasion by throwing stones and Molotov-cocktails at their vehicles. The Israeli police tightened the restriction of movement on the Palestinian civilians in the Old City of Jerusalem and surrounding areas, blocking the entrances leading to Silwan town. (IMEMC 1 September 2020)
- Undercover Israeli agents, detained senior Palestinian official, Husam al-Razza, who belongs to the Popular Front for the Liberation of Palestine (PFLP). The plain-clothes Israeli agents detained Razza, a former detainee, after they ambushed him when he was in Huwara town, south of Nablus, in the northern occupied West Bank. Recently, the IOA dressed as municipal workers detained Razza's son, Bader, also a former prisoner, from his home in Nablus city. (IMEMC 1 September 2020)
- undercover Israeli troops, also known as Musta'ribeen, ambushed and detained a young Palestinian man, identified as Yaser Walid Khzemiya, in the northern occupied West Bank city of Jenin. (IMEMC 1 September 2020)
- The Israeli occupation Army (IOA) imposed a curfew on Kisan village in eastern Bethlehem and physically assaulted local residents. A large number of Israeli troops stormed Kisan, spread through its streets and announced a curfew over megaphones. The stopped local residents in the village's streets, detained him for long hours and physically assaulted them. (PALINFO 1 September 2020)

Israeli Settler Violence

• A horde of settlers organized a provocative march inside the village and The Israeli occupation Army (IOA) attacked local shepherds and prevented them from approaching a road near their village. (PALINFO 1 September 2020)

• At least 62 Jewish settlers escorted by police forces stormed the Aqsa Mosque and desecrated its courtyards. Students of religious institutes and intelligence officers were among the settlers who toured the Mosque's plateaus. Some of the settlers performed Jewish prayers during the morning tours, while an Israeli soldier provocatively broke into the Mosque's Bab al-Rahma prayer hall without removing his shoes and photographed the place. During the presence of settlers inside the Mosque compound, entry restrictions are imposed on Muslim worshipers at the entrances leading to the Mosque and their IDs are seized until they leave the holy place. (PALINFO 1 September 2020)

Home Demolition & Demolition threats

- Two Palestinian brothers in the Jerusalem Town of Beit Hanina, began demolishing their homes, in order to avoid having the Israeli municipality of West Jerusalem demolish it. The Israeli municipality ordered the demolition of the house, under the standard pretext of the lack of a building permit. The Israeli municipality will demolish the house and then force the owner of the home to pay a substantial fine. The two 65 square meter homes were home to 9 people, who have now been displaced by the state of Israel. (IMEMC 1 September 2020)
- Several Palestinian residents of Kufr al-Dik village, east of the northern West Bank city of Salfit, have received stop construction orders against their homes from the Israeli military government. A military force left the orders in the village that affect seven residents and which say they have to halt the construction under the pretext they were building without a permit. (WAFA 1 September 2020)
- Israeli occupation Army (IOA) seized a large quantity of construction material from Tuqu town, southeast of Bethlehem, in order to prevent a local Palestinian from proceeding with building his house. A large Israeli military force escorted two forklifts into the western part of the town, known as al-Halqum, where they seized 15 bundles of brick and 15 others of building stone intended for the construction of a house purportedly for being built without a license.
