## Israeli Violations' Activities in the occupied State of Palestine

6 September 2020

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

## Violations of the Israeli occupation Army

- Two Palestinian brothers suffered injuries from live rounds fired by Israeli troops, in the Jenin refugee camp, in northern West Bank. A large force of Israeli occupation Army (IOA) with a special undercover unit, invaded the camp and stormed the al-Jad'oun home, amid intensive gunfire. The IOA shot the two brothers, identified as Ahmed and Mohamed al-Jad'oun, whom both suffered multiple gunshot wounds inflicted by the IOA. The IOA opened fire at the two Palestinians, striking one of them in his neck and abdomen, before they carried the injured men away. Local youths confronted the army as they withdrew from the refugee camp. The IOA opened live fire at the al-Jad'oun brothers, injuring them both and transferring them by stretcher to an army ambulance. (IMEMC 6 September 2020)
- Three Palestinian workers were shot, by Israeli occupation Army (IOA) near Habla town, south of Qalqilia city in the northern West Bank. The three workers were heading home from work when the IOA opened fire and shot them. (IMEMC 6 September 2020)
- A number of Palestinians suffered the toxic effects of tear-gas during confrontations between youths and the Israeli army, in Deir Abu Misha'al village, in the central occupied West Bank. Israeli troops stormed the village, located west of Ramallah, firing rubber-coated steel rounds, tear-gas, and stun grenades towards the protesting civilians and homes, adding that several citizens choked on toxic tear-gas. (IMEMC 6 September 2020)
- The Israeli occupation Army (IOA) stormed Wadi al-Hariya area in al-Khalil city and detained two citizens identified as Jalal Abu Sneh and Naseem al-Atrash from their homes. The IOA also raided homes in Hebron city and Deir Sammit town, without making arrests, and set up a makeshift checkpoint at the main entrance to al-Arroub refugee camp in northern al-Khalil. - In Bethlehem, Israeli occupation Army (IOA) detained a 17-year-old kid called Nour al-Hasanat, a resident of al-Deheisha refugee camp, at the Container checkpoint. (PALINFO 6 September 2020)
- In Jenin, the Israeli occupation Army (IOA) stormed al-Muhandeseen neighborhood in Jenin city and confiscated a parked car. (PALINFO 6 September 2020)

### **Israeli Settler Violence**

- Israeli settlers smashed the windshields of several Palestinian-owned vehicles in the village of Huwara, to the south of the occupied West Bank city of Nablus. Settlers attacked the vehicles, smashing their glass windshields and causing damage to them. (Wafa 6 September 2020)

### **Israeli Closures**

- Israeli occupation Army (IOA) shut down the entrance to al-Jalazon refugee camp, to the north of the city of Ramallah in the occupied West Bank. The IOA placed large cement cubes at the entrance to the camp and at the adjacent Nablus-Ramallah road, banning the movement of Palestinian traffic at the said road. Drivers and commuters were forced to find alternative and longer roads as a result of the closure. (Wafa 6 September 2020)
