

Israeli Violations' Activities in the occupied State of Palestine 19 September 2021

 ${f T}$ he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Violations of the Israeli occupation Army

- Israeli occupation authorities have ordered the expulsion of the wife of a Palestinian citizen of occupied Jerusalem, under the pretext of not holding the status of a permanent citizen of the city. Mariam Ajlouni, the wife of Mohammad Jabr Ajlouni, a Palestinian citizen of the occupied city, was told by Israeli occupation police that she had two weeks to appeal against the order or that she will have to leave the city. Ajlouni, a mother of four children, is one of many Palestinian citizens of occupied Jerusalem facing the risk of expulsion by the occupation authorities, whose discriminatory rules ban the reunion of wives married to Palestinian citizens from the occupied city. - The Israeli occupation police handed two Jerusalemite citizens orders banning their entry to the Aqsa Mosque for several months. Isam Amaira and Rafat Najeeb received police verdicts ordering them to stay away from the Aqsa Mosque for six months, pay a fine of 5,000 shekels each and come back again for further questioning next Thursday. Police officers detained Amaira and Najeeb in the afternoon at the Asbat Gate of the Mosque on allegations of their presence illegally in the area. A week ago, the Israeli police ordered a young man called Ibrahim al-Natsha not to enter the Mosque for one week and come back again for questioning and to receive a renewed entry order. Two young men identified as Rawhi Kulgasi and Yaqoub ad-Dabbagh also received a similar no-entry order last Wednesday from the police. (PALINFO 19 September 2021)

Israeli Settler Violence

- Israeli bulldozers uprooted 200 trees in the town of Bidya, west of Salfit. The uprooted trees vary between olives, figs, grapes, peaches, lemons, and fruit and perennial almonds. The owner of the trees is Salim Khalil. A number of those trees are up to 20 years old. The Israeli occupation forces had uprooted more than 200 olive trees in the town of Derastia, northwest of Salfit, two months ago. (IMEMC 19 September 2021)
- A group of Israeli settlers escorted by Israeli Occupation Army (IOA) wreaked havoc on Palestinian-owned swaths of land and agricultural

property in Biddya town to the west of Salfit. The settlers stormed the areas of Khilat Aliyan and Khilat Hassan under military protection and went on the rampage through Palestinian property — destroying olive and fig trees and grape vines, removing stone fences and demolishing agricultural warehouses.
