Brutality of the Israeli Occupation Army

- In Tubas, in northeastern West Bank, the Israeli Occupation Army (IOA) attacked dozens of Palestinians nonviolently protesting the illegal annexation of their lands, near Tayasir military roadblock, east of the city. The IOA shot a young man with rubber-coated steel bullets and caused dozens to suffer the effects of tear gas inhalation. The IOA stopped a Palestinian bus, filled with residents who participated in the nonviolent procession, before detaining and interrogating them at Tayasir roadblock for several hours. The IOA also detained twelve Palestinians, identified as Ahmad Samer Daraghma, Wajdi Talal Foqaha, Mustafa Fida Kheizaran, Mohammad Eyad Daraghma, Hasan Tareq Ghannam, Ahmad Mohammad Dibik, Ayham Samer Abu Ali, Bassel Abdul-Salam Abdul-Razeq, Mohammad Jihad Masaeed, Karim Hassan Darwish, Maher Ibrahim Yousef, and Abdul-Rahman Nasser Anbousi. (IMEMC 1 August 2021)
- The Israeli Occupation Army (IOA) assaulted nonviolent protesters in Sheikh Jarrah Palestinian neighborhood, in occupied Jerusalem. The Palestinians were protesting the illegal takeover of their homes, and the Israeli plans to force the Palestinians from their homes to replace them with the settlers. The IOA fired dozens of gas bombs at the protesters, causing many injuries, in addition to spraying them with wastewater mixed with chemicals. (IMEMC 1 August 2021)
- The Israeli Occupation Army (IOA) detained a young man, identified as Bilal Kamil, from Qabatia, south of the northern West Bank city of Jenin, after stopping him at a military roadblock near Misilyah village. (IMEMC 1 August 2021)
- The Israeli Occupation Army (IOA) conducted military drills in Khalayel al-Louz area, east of Bethlehem, south of occupied Jerusalem in the West Bank. Dozens of IOA invaded Khalayel al-Louz area, after surrounding it, and conducted their military drills between the homes. The training also including military helicopters and that the IOA then started running in the neighborhoods and a few abandoned homes. Many Palestinians, especially the children, suffered anxiety attacks, and the IOA also prevented many Palestinians from reaching their homes until the drills were over. (IMEMC 2 August 2021)

- The Israeli Occupation Army (IOA) and the navy attacked many Palestinian farmers, and fishermen, in the Gaza strip, causing damage, and forcing the Palestinians to leave. Israeli navy ships opened fire at several Palestinian fishing boats only three nautical miles from the shore, in the Sudaniyya Sea area, northwest of Gaza city. The navy attacked the boats with water cannons and several rounds of live ammunition, causing severe damage to at least one boat. The attack did not lead to casualties but forced the fishermen back to the shore in fear of further Israeli escalation, without being able to fish to provide for their families. (IMEMC 2 August 2021)
- The Israeli Occupation Army (IOA) stationed in military towers cross the perimeter fence near the Malaka area, east of Gaza city, fired many live rounds at Palestinian farmers, especially in the Zeitoun neighborhood, southeast of Gaza city, forcing them to leave. (IMEMC 2 August 2021)
- Several Israeli military vehicles invaded Palestinian farmlands in Khan Younis and al-Maghazi, in the besieged Gaza Strip. Four armored military vehicles, including a bulldozer, advanced dozens of meters into Palestinian farmlands in the al-Qarara area, northeast of Khan Younis. The vehicles invaded the lands through the as-Sreij gate of the perimeter fence, before bulldozing sections near the fence and installing sandhills. (IMEMC 2 August 2021)
- At least armored military bulldozers invaded farmlands east of the al-Maghazi, in central Gaza, and bulldozed several sections while military drones flew overhead. (IMEMC 2 August 2021)
- The Israeli occupation authority (IOA) continues to prevent the Islamic Awqaf Administration from carrying out cleaning and repair works in the eastern part of the Aqsa Mosque. A scene in the Mosque's eastern area where piles of dirt and waste have been there for years because the IOA does not allow the Islamic Awqaf and its crews to dispose of them. The Mosque's eastern area is also exposed to daily break-ins by Jewish settlers after the police force Muslim worshipers to leave it. Groups of settlers gather in this area for Talmudic prayers and stay there for a long time almost every day. They also use the area as a lavatory to relieve themselves. (PALINFO 2 August 2021)
- The Israeli Occupation Army (IOA) shot one Palestinian, and caused many to suffer the effects of tear gas inhalation, in addition to detaining two, in the al-Yamoun town, west of the northern West Bank

city of Jenin. Several army jeeps invaded the town before the IOA stormed and searched homes, and abducted Jamil Maher Khamaisa along with his son Mo'taz. The invasion led to protests before the IOA fired many rubber-coated steel bullets, gas bombs, and concussion grenades. A young man was shot with a rubber-coated steel bullet in the neck and another young man with a gas bomb in the head, and dozens of Palestinians suffered the effects of tear gas inhalation. (IMEMC 3 August 2021)

- The Israeli Occupation Army (IOA) invaded Silet al-Harithiya town, west of Jenin, and fired gas bombs at Palestinians attending a wedding celebration, causing several injuries. (IMEMC 3 August 2021)
- The Israeli Occupation Army (IOA) seriously injured a young Palestinian man near the Annexation Wall, west of the northern West Bank city of Jenin. The IOA opened fire at the Palestinian while he was walking near the Annexation Wall, near Taybeh village, west of Jenin, inflicting life-threatening wounds. The injured Palestinian is from Umm al-Fahem town in the Haifa District. After shooting the young man, who holds Israeli citizenship, the IOA took him to an Israeli hospital. (IMEMC 3 August 2021)
- The Israeli occupation army (IOA) carried out two small-scale incursions into border areas in the north and south of the besieged Gaza Strip. 12 armored vehicles, including bulldozers and tanks, advanced from a military post towards a border area in the east of az-Zeitoun neighborhood in Gaza City. Another group of nine army vehicles also infiltrated into the east of al-Qarara town in Khan Yunis, south of Gaza. Several tanks escorted the bulldozers, which embarked on digging and leveling swaths of land in the border areas. (PALINFO 3 August 2021)
- The Israeli Occupation Army (IOA) and undercover agents invaded the industrial zone of the city OF Jenin, firing live rounds at the Palestinians. The army shot and injured six Palestinians, one of whom was seriously injured after being shot in the abdomen. (IMEMC 4 August 2021)
- The Israeli Occupation Army (IOA) detained a young Palestinian man, who is also a former political prisoner, during his engagement party in the al-Isawiya town, in occupied Jerusalem and was identified as Anwar Sami Obeid. The IOA transferred Obeid to an interrogation facility. Obeid is a former political prisoner who was frequently

abducted, interrogated, and imprisoned, including when he was a child and was also previously exiled out of Jerusalem for several months. (IMEMC 6 August 2021)

- The Israeli Occupation Army (IOA) detained Ahmad Saleh Kash'am, 20, in addition to Yousef Resheq from Silwan town, in Jerusalem. Yousef was taken prisoner after the IOA summoned him for interrogation. The IOA invaded and searched many homes, including the home of a former political prisoner, identified as Shoeib Abu Sneina, who was forcibly exiled from Jerusalem to Gaza. (IMEMC 6 August 2021)
- The Israeli Occupation Army (IOA) blocked maintenance work to the entrance to Sebastia, detained the contractor and the workers and seized a bulldozer and other equipment in the area. (PALINFO 6 August 2021)
- The Israeli Occupation Army (IOA) shot one Palestinian with live fire, and nine with rubber-coated steel bullets, in addition to causing to suffer the effects of teargas inhalation in addition to cuts and bruises, during a procession in Beit town, south of the northern West Bank city of Nablus. The Palestinians held the procession to demand the army to transfer the corpse of **Shadi Omar Salim Shorafa**, 41, to his family to conduct the proper burial ceremony. The IOA invaded the area and started firing live rounds, rubber-coated steel bullets, gas bombs, and concussion grenades. The IOA shot a young man, 21, with a live round in the elbow. The IOA also shot nine Palestinians with rubber-coated steel bullets and caused at least twenty-seven to suffer the effects of tear gas inhalation before the medics provided them with the needed treatment. Shadi was killed, on July 27, 2021, at Beita Junction while trying to unlock the valve of the main water pipeline leading to the village, especially since the Israeli army frequently closes it, depriving more than 15,000 Palestinians of the needed water resources, approximated at 1300 Cubic/Meters. Shadi has been working as a water technician for 17 years, and recently became an advisor to the council due to his vast experience in water resources and management. The IOA fired more than twelve live rounds at the Shadi without a warning. (IMEMC 8 August 2021)
- In Nablus, in northern West Bank, the Israeli Occupation Army (IOA) attacked nonviolent protesters in Sbeih Mountain, in Beita town, south of the city, wounding many Palestinians. The shot a young man with a rubber-coated steel bullet in the arm, in addition to shooting four

others with gas bombs directly to the head, and caused 47 to suffer the effects of tear gas inhalation. (IMEMC 9 August 2021)

- In Bethlehem, south of occupied Jerusalem, the Israeli Occupation Army (IOA) invaded Beit Jala city, searched homes, and detained a young man, identified as Ibrahim Roumi. (IMEMC 9 August 2021)
- In Hebron, in southern West Bank, the Israeli Occupation Army (IOA) detained a member of the Regional Council of Fateh movement, identified as Mohammad Khaled Shawaheen, from his home in Yatta town, south of the city. (IMEMC 9 August 2021)
- The Israeli Occupation Army (IOA), accompanied by bulldozers, invaded Palestinian farmlands, east of the al-Maghazi refugee camp, in central Gaza, and bulldozed them. Six tanks and armored bulldozers, stationed at a military base across the perimeter fence, invaded Palestinian farmlands near the fence, east of the al-Maghazi refugee camp. The IOA bulldozed sections near the fence, and installed sand hills. The IOA also fired firing sporadic rounds of live ammunition and smoke bombs during the invasion. (IMEMC 9 August 2021)
- The Israeli occupation Army (IOA) invaded Sheikh Jarrah neighborhood of occupied East Jerusalem, and raided the home of Murad Atyeh, 26, one of the activists in the neighborhood against Israeli plans to displace many families and take over their homes for the benefit of Israeli settlers and detained him. (IMEMC 10 August 2021)
- The Israeli occupation Army (IOA) rounded up four Palestinians, including two brothers, and ransacked several houses in Deir al-Ghusun town, northeast of the northern West Bank city of Tulkarm. During the ensuing confrontations, the IOA opened fire towards local youths who attempted to block their passage, wounding and detaining one. (IMEMC 10 August 2021)
- In the southern West Bank, Israeli occupation Army (IOA) raided Husan village, west of Bethlehem, where they detained another. (IMEMC 10 August 2021)
- The Israeli occupation Army (IOA) conducted a raid into Dura town in the southern West Bank, south of Hebron, where they arrested two former prisoners. (IMEMC 10 August 2021)

- The Israeli occupation Army (IOA) shot and detained a Palestinian woman near Huwara town, south of Nablus in northern occupied West Bank. The IOA opened fire at the woman, injuring her in the leg, during what the army claimed was an attempted stabbing. The army detained the unidentified woman, and took her to an unknown location. Her condition was not known at the time of this report. The photo shows the young woman standing at the junction of Salman al-Farsi near Huwara town, near the Nablus- Qalqilia road, near the Israeli Yitzhar settlement, built on Palestinian lands. (IMEMC 10 August 2021)
- A Palestinian young woman suffered a bullet injury when Israeli occupation Army (IOA) opened fire at her near Huwara town, south of Nablus in the occupied West Bank. The IOA opened fire at a young woman during her presence at the junction of Salman al-Farsi near Huwara town. There was no immediate information about the identity of the woman and her health condition. (PALINFO 10 August 2021)
- Several Israeli military vehicles invaded the town of Jaba', south of the northern West Bank city of Jenin, before detaining two young men, and wounding dozens of Palestinians. The IOA invaded the town from several directions, before storming into homes and violently searching them. The IOA detained Maad Emad Kanaan and Eyad Yousef Malaysha from their homes and took them to an unknown destination. The invasion led to protests before the IOA fired many live rounds, gas bombs, and concussion grenades at the protesters and many surrounding homes. Dozens of residents, mainly those in their homes, suffered the effects of tear gas inhalation. (IMEMC 11 August 2021)
- The Israeli Occupation Army (IOA) invaded Hizma town, northeast of occupied Jerusalem, leading to protests, and fired many gas bombs and concussion grenades at several homes. (IMEMC 11 August 2021)
- The Israeli Occupation Army (IOA) detained three Palestinians in addition to invading and ransacking homes and shops in Nablus, in northern West Bank. The IOA stationed at the Huwwara military roadblock, south of Nablus, detained two Palestinians, identified as Jaber Hasan Mansour and Khaled Walid Amer. The IOA stopped and searched dozens of cars at the permanent military roadblock and interrogated many Palestinians while inspecting their ID cards. In addition, the IOA invaded the western and central areas of Nablus city, before invading and ransacking homes. The IOA also wired and

detonated the doors of many shops before invading and violently searching them. (IMEMC 11 August 2021)

- The Israeli Occupation Army (IOA) invaded the al-Jawaya community, east of Yatta town, south of Hebron, searched homes, and detained a young man, identified as Saddam Ahmad Shawaheen, 21. The IOA installed roadblocks at roads leading to many towns and refugee camps in Hebron, before stopping and searching dozens of cars, and interrogated many Palestinians while inspecting their ID cards. (IMEMC 11 August 2021)
- The Israeli Occupation Army (IOA) and the navy fired, many live rounds at Palestinian farmers and fishermen in the Gaza Strip. The IOA stationed in military towers and behind sand mounds across the perimeter fence east of Khan Younis, in the southern part of the Gaza Strip, fired sporadic rounds of live fire at the farmers. The farmers, working on their lands in the al-Fakhari area, east of Khan Younis, had to leave their lands in fear of further violations. (IMEMC 11 August 2021)
- Israeli navy ships fired live rounds at Palestinian fishing boats only three nautical miles from the shore of the Sudaniyya Sea area, northwest of Gaza city. The attack caused damage to at least one boat and forced the fishermen to sail back to the shore without being able to fish to provide for their families. (IMEMC 11 August 2021)
- Israeli police summoned two Palestinian residents of Sheikh Jarrah neighborhood of occupied East Jerusalem for questioning after taking part in a protest against the detention of a fellow resident of their neighborhood threatened with eviction and displacement for the benefit of Israeli settlers. The police summoned Mohammad al-Kurd and Omar Abu Sneineh, both active in the struggle to prevent the Israeli-orchestrated eviction of their families from their homes in Sheikh Jarrah in order to turn them over to Israeli settlers, after they protested outside the Magistrate Court in West Jerusalem demanding the release of Murad Atyeh, 26, also a resident of the same neighborhood and active in the struggle against the forced eviction of the neighborhood families. Atyeh was arrested a day earlier at his home in Sheikh Jarrah for yet unclear reasons and was brought before the court today, which remanded him for five days. (Wafa 11 August 2021)

- The Israeli Occupation Army (IOA) forced five Palestinians [to demolish their homes](#) in Beit Hanina, north of the occupied Palestinian capital, Jerusalem, in the West Bank, allegedly for being built without a permit. The Palestinians reside in the al-Ashqariyya neighborhood in Beit Hanina and had to demolish their homes to avoid paying the excessively high fines and fees if the City Council in Jerusalem demolishes the property using its workers and equipment. The properties are owned by Abdullah Khader, along with his sons and their families, who were all rendered homeless. Trying to save its homes, the family filed several appeals with Israeli courts, but the court ruled in favor of settlers, who alleged owning the lands where the homes were built. (IMEMC 12 August 2021)
- A Palestinian young man was pronounced dead after he succumbed to serious bullet injuries he sustained in early August during clashes with the Israeli occupation Army (IOA) in Jenin City. 25-year-old Diya as-Sabarini died of critical bullet injuries in his abdomen. Sabarini suffered severe internal bleeding and went into a coma due to Israeli bullets badly damaged the internal organs of the young man's body. Sabarini was wounded along with five other young men during violent clashes about two weeks ago (August 3) with Israeli troops who raided at dawn the industrial zone of Jenin City. (PALINFO 12 August 2021)
- The Israeli Occupation Army (IOA) fired live ammunition, rubber-coated metal, stun and tear gas canisters towards citizens, under the pretext that they had been pelted with stones as they stormed a number of houses during their raid into the city of Tubas. (NAD 12 August 2021)
- The Israeli Occupation Army (IOA) opened fire at Palestinian fishing boats near the shore of Gaza city, in the besieged and impoverished coastal region. One boat sustained damage after the navy fire many live rounds at it, less than six nautical miles from the shore. The attack did not lead to casualties but forced the fishermen to return to the shore without being able to fish and provide for their families. The attack is part of the constant Israeli violations against the Palestinians and their property in the coastal region. (IMEMC 13 August 2021)
- The Israeli Occupation Army (IOA) attacked the weekly procession against the Israeli colonialist activities in the Masafer Yatta area, south of Hebron, in the southern part of the occupied West Bank, wounding dozens in addition to detaining five Palestinians and one international peace activist. The IOA prevented the Palestinians from holding noon prayers on their lands in Um ash-Shaqhan area in Masafer Yatta. The

IOA fired a barrage of gas bombs and concussion grenades at the residents and assaulted many of them with clubs and rifle-butts, wounding a few, including an elderly man, identified as Ali Jabarin. Dozens of nonviolent protesters suffered the effects of tear gas inhalation, while the IOA also detained five Palestinians, in addition to one international solidarity activist. (IMEMC 13 August 2021)

- Hundreds of Palestinian muslims congregated for the afternoon prayer at the Ibrahimi Mosque in Hebron, in southern occupied West Bank, when the IOA stormed the mosque and terrorized worshipers. The Israeli army stormed the mosque and fired teargas and stun grenades at the crowd of worshipers, causing several people to suffer inhalation injuries. The mosque is on the World Heritage List of the United Nations Educational, Scientific and Cultural Organization (UNESCO), and is the fourth holiest site in Islam, the third of which is the Al-Aqsa mosque in occupied East Jerusalem. (IMEMC 13 August 2021)
- The Israeli Occupation Army (IOA) shot five Palestinians with rubber-coated steel bullets in Beit Danaj village, east of the northern West Bank city of Nablus, during a procession against the ongoing Israeli colonialist activities. The IOA attacked the Palestinians with gas bombs, concussion grenades, and rubber-coated steel bullets, during a nonviolent procession against the installation of an illegal colonialist outpost on their lands. Five Palestinians were shot with rubber-coated steel bullets. (IMEMC 13 August 2021)
- The Israeli Occupation Army (IOA) attacked the weekly procession in Kufur Qaddoum village, east of the northern West Bank city of Qalqilia, causing dozens of injuries. The Palestinians marched while chanting against the escalating Israeli violations, including the recent decision to build thousands of settlement units, and fired a barrage of gas bombs, concussion grenades, and rubber-coated steel bullets at the Palestinians, causing dozens of injuries, mainly due to the effects of tear gas inhalation. (IMEMC 13 August 2021)
- The Israeli Occupation Army (IOA) injured 39 Palestinians In the [Sbeih Mountain area](#), in Beita town, south of the northern West Bank city of Nablus, during a procession against the Israeli outpost and the ongoing takeover of their lands. The IOA attacked the protesters in rubber-coated steel bullets, gas bombs, and concussion grenades. 39 Palestinians were injured; five were shot with the rubber-coated steel bullets, nine suffered fractures, one was shot with a gas bomb in the

head, and 24 suffered the severe effects of tear gas inhalation. Israeli military bulldozers place rocks and sandhills on several roads leading to Sbeit Mountain to prevent the Palestinians from reaching it. (IMEMC 13 August 2021)

- Israeli occupation Army (IOA) attacked Muslim worshipers who attended the Friday prayer at the Ibrahimi Mosque in Hebron. Dozens of civilians were wounded by tear gas and sound bombs fired by the IOA. Hundreds of Hebronites gathered at the Ibrahimi Mosque and its courtyards to perform Friday prayer. The IOA hindered the entry of Muslim worshipers and were deployed in the Old City and the vicinity of the Ibrahimi Mosque. (PALINFO 13 August 2021)
- Israeli navy gunboats opened fire at fishermen's boats off the coast of Gaza City, damaging one of them. The Israeli gunboats attacked fishermen and their boats with live ammunition and water cannons during their presence within six nautical miles off the shore of Gaza City. No one was hurt, but at least one fishing boat sustained damage in the attack and the fishermen were forced to return ashore. (PALINFO 13 August 2021)
- 13 Birzeit University students have been in Israeli detention since they were detained by the Israeli occupation Army (IOA) following their solidarity visit in mid-July to the family of prisoner Muntaser Shalabi, whose home was razed in Turmus Ayya town, east of Ramallah. Five of the students are being held in the Moskobiya detention center (west Jerusalem) and eight others in the Ofer jail (Ramallah). (PALINFO 14 August 2021)
- The Israeli occupation police detained a Palestinian young man from his home in the east Jerusalem neighborhood of Sheikh Jarrah. The Israeli Police assaulted and detained Khalil Asho from his home in the neighborhood and hauled him to a detention center in the holy city. (PALINFO 14 August 2021)
- The Israeli occupation army (IOA) injured 39 Palestinians In the [Sbeih Mountain area](#), in Beita town, south of the northern West Bank city of Nablus, during a procession against the Israeli outpost and the ongoing takeover of their lands. The IOA attacked the protesters in rubber-coated steel bullets, gas bombs, and concussion grenades. Five were shot with the rubber-coated steel bullets, nine suffered fractures, one was shot with a gas bomb in the head, and 24 suffered the severe effects of tear gas inhalation. A day earlier, Israeli military bulldozers place rocks and sandhills on several roads leading to Sbeit Mountain to prevent the Palestinians from reaching it. (PALINFO 14 August 2021)

- The Israeli Occupation Army (IOA) injured many Palestinians in the town of Ya'bad, southwest of the northern West Bank city of Jenin. Several army jeeps invaded the town before the IOA stormed and ransacked homes, causing damage. The invasion led to protests before the IOA fired a barrage of gas bombs and concussion grenades at the protesters and many homes, causing several Palestinians to suffer the effects of tear gas inhalation. The invasion and searches of homes mainly took place in the neighborhoods in Abu Shamla and al-Ba'jawi. (IMEMC 15 August 2021)
- The Israeli occupation police assaulted and detained a Palestinian young man in Salahuddin street, east Jerusalem. Police officers severely beat a young man called Saadi Burqan and badly injured him during his presence in the street. The young man was also attacked with pepper spray by a police officer . (PALINFO 15 August 2021)
- The Israeli Occupation Army (IOA) uprooted dozens of Palestinian olive trees in Bardala village, in the Northern Plains of the occupied West Bank. Several army jeeps and bulldozers invaded the village, before storming an olive orchard. The IOA uprooted dozens of olive trees, in an orchard owned by Khaled Roshdi Sawafta, in the western area of the village. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) detained a young Palestinian man from his home in Hebron city, in the southern part of the occupied West Bank, and installed many roadblocks. The IOA invaded the Jabal ar-Rahma area, in the center of the city, before invading and searching homes, and detained a young man, identified as Yacoub Daoud al-Masri. The IOA installed many roadblocks, especially in Jabal Johar area in the southern part of Hebron city, in addition to the al-Kassara area, and the entrance of the al-Fawwar refugee camp, in addition to the Sammoa' the Yatta towns, south of Hebron, before stopping and searching dozens of cars and interrogated many Palestinians while inspecting their ID cards. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) detained three Palestinians, including a father and his son, in Qusra town, south of the northern West Bank city of Nablus, and at the southern entrance of Nablus city. Several army jeeps invaded Qusra, before the IOA stormed and violently searched a few homes. The IOA detained No'man Qassem Kanaan, and his son, Adham. (IMEMC 16 August 2021)

- Undercover Israeli occupation Army (IOA) detained a young man, identified as Fadi Yousef al-Qanni, after ambushing him at the southern entrance of Nablus city. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) shot and injured, three Palestinians and detained one, in Tammoun town, south of Tubas city, in northeastern West Bank. Several Israeli army vehicles invaded the town, before the IOA stormed and searched several homes, and detained a former political prisoner, identified as Ali Mohammad Bani Odah. The invasion led to protests before the IOA fired many live rounds, rubber-coated steel bullets, and gas bombs. The three young men were shot with live fire, and several Palestinians suffered the effects of tear gas inhalation. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) shot and injured three Palestinians and detained one, in Tammoun town, south of Tubas city, in northeastern West Bank. Several Israeli army vehicles invaded the town, before the IOA stormed and searched several homes, and detained a former political prisoner, identified as Ali Mohammad Bani Odah. The invasion led to protests before the IOA fired many live rounds, rubber-coated steel bullets, and gas bombs. Three young men were shot with live fire, and several Palestinians suffered the effects of tear gas inhalation. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) killed four Palestinians, and seriously wounded at least one, in Jenin, in northern West Bank, after the army and its undercover Army, invaded Jenin city and Jenin refugee camp, in the northern part of the occupied West Bank. Three Palestinians, identified as Saleh Ahmad Mahmoud Ammar, 19, from Jenin refugee camp, and Raed Ziad Abdul-Latif Abu Saif, 21, from Jenin city, and Nour Abdullah Jarrar, 19, from Jenin city, were killed by the IOA who took his corpse. The IOA also shot and seriously injured a fourth Palestinian, identified as Amjad Eyad Azmi Husseiniyya, 20, who succumbed to his wounds after the IOA detained him. The killing of the Palestinians took place when undercover Israeli army infiltrated into Jenin refugee camp using a civilian car before the soldiers stormed an under-construction residential building and secretly occupied its rooftop. Another Palestinian, identified as Qassam Mohammad Taha, 24, suffered various gunshot wounds to his left arm. In addition, the army invaded and ransacked homes in the Jenin refugee camp, and detained a young man, identified as Mohammad Abu Zeina. (IMEMC 16 August 2021)

- The Israeli Occupation Army (IOA) detained two Palestinians, including a cancer patient, in Jericho city, in northeastern West Bank. The IOA invaded Aqabat Jabr refugee camp, at the southern entrance of Jericho city, before storming the home of a university student, identified as Aysar Samhuri, and detained him. The IOA violently searched the property and confiscated the young man's personal computer. The IOA also detained a cancer patient, identified as Mohammad Badawi Eid who was heading to a military base to obtain a permit for medical treatment in occupied Jerusalem. Abu Eid has lung cancer and has been receiving treatment at the Augusta Vitoria hospital, in Jerusalem. (IMEMC 17 August 2021)
- The Israeli occupation army (IOA) carried out a small-scale incursion into a border area in the east of the central Gaza Strip. Seven armored bulldozers escorted by two Merkava tanks advanced from a military post into a border area in the east of al-Maghazi refugee camp in central Gaza. The bulldozers embarked on leveling and digging swaths of agricultural land, which are located about 100 hundred meters from the security fence. Two Merkava tanks were also deployed on mounds of dirt behind the security fence to provide protection for the bulldozers. (PALINFO 17 August 2021)
- The Israeli occupation authority started in the morning to carry out diggings in the Aqsa Mosque's western wall area (al-Buraq plaza). (PALINFO 17 August 2021)
- In Hebron, in the southern part of the West Bank, many Israeli army jeeps invaded Beit Ummar town, north of the city, before breaking into and ransacking many homes in 'Aseeda and Khlalet al-Ein areas. The IOA smashed the doors of many homes before breaking into them, and violently searched them causing extensive property damage. During the invasions, the IOA detained Moath Sa'id Awad, 21, and summoned a former political prisoner, identified as Mahdi Mirshed Za'aqeeq, for interrogation in Etzion military base and security center, north of Hebron. (IMEMC 18 August 2021)
- Several military vehicles invaded Bethlehem city, south of occupied Jerusalem, before the Israeli Occupation Army (IOA) stormed and ransacked homes in the Wad Ma'ali area, and the Old City, leading to protests. The invaded homes belong to members of the local al-Hreini family, including the home of a political prisoner, identified as Hamza Khaled al-Hreini. Furthermore, four Israeli military vehicles and a bulldozer invaded Za'tara town, east of the city. (IMEMC 18 August 2021)

- Several Palestinian university students were injured after the Israeli occupation Army (IOA) attacked a peaceful march staged at the northern entrance to Ramallah and Bireh in protest at the killing of four young men in Jenin a few days ago. The IOA at the checkpoint near the settlement of Beit El showered the participants in the march with tear gas canisters and fired rubber bullets at them. (PALINFO 18 August 2021)
- Two Palestinian young men suffered bullet injuries during clashes with the Israeli occupation Army (IOA) in Tayasir village, northeast of Tubas. The clashes started after the IOA stormed the village and set up a makeshift checkpoint at the entrance to the Tayasir High School for Boys and prevented students and teachers from entering their school easily. The IOA terrified the students, pointed their guns at them and interrogated two teachers at the entrance to the school. Two young men suffered bullet injuries in their lower extremities during clashes. The IOA also stormed Tubas City, kidnaped a citizen from his home and clashed with local youths. (PALINFO 18 August 2021)
- Many Palestinian workers, and schoolchildren, have been injured after Israeli occupation Army (IOA) fired a barrage of gas bombs at workers and two schools near the illegal Annexation Wall, south of the northern West Bank city of Tulkarem. The IOA attacked many laborers while working on lands near the Annexation Wall west of Far'on town, south of Tulkarem. The IOA fired a barrage of gas bombs at the workers on lands next to two local schools, causing dozens of Palestinians, including schoolchildren to suffer the effects of tear gas inhalation. The administration of the two schools had to shut them down, and sent the students to their homes to ensure their safety and in fear of additional Israeli violations. (IMEMC 19 August 2021)
- The Israeli Occupation Army (IOA) live-fire military training, for the third consecutive day, on Palestinian lands in several areas in the Northern Plains of the occupied West Bank. The military drills are ongoing in several areas and communities, especially in Wadi al-Maleh, ash-Shaq, and al-Farisiyya. The Israeli army is using live fire, in addition to tank and artillery shells in complete disregard to the lives of the Palestinians in the area. It is worth mentioning that the Israeli army carried these drills out several times a year, and uses various sorts of ammunition, including shells and explosives in Palestinian farmlands and grazing areas. The military drills include the use of live fire and shells in Bedouin villages and farmlands in the Jordan Valley, in addition to various areas in the occupied West Bank, mainly near

Tubas, in central West Bank, Hebron, in the southern part. (IMEMC 19 August 2021)

- Israeli gunboats attacked Palestinian fishermen off the coast of Gaza City and forced them to return ashore. Israeli gunboats opened machinegun fire at fishermen and their boats during their presence within three nautical miles off the shore of as-Sudaniya area in the northwest of Gaza City. Luckily, no one was hurt in the shooting attack. (PALINFO 19 August 2021)
- The Israeli Occupation Army (IOA) injured 117 Palestinians during the weekly nonviolent procession against the ongoing illegal Israeli attempt to annex [Sbeih Mountain](#), in Beita village, south of the northern West Bank city of Nablus. The IOA shot one Palestinian with a live round in the thigh, thirteen with rubber-coated steel bullets, and caused 91 to suffer the effects of tear gas inhalation. 12 Palestinians suffered fractures and bruises, after falling while the IOA were chasing them. The IOA closed all dirt roads leading to Sbeih Mountain, after placing sand hills on them, to prevent the Palestinian vehicles from reaching it. (IMEMC 20 August 2021)
- The Israeli Occupation Army (IOA) attacked nonviolent protesters in Beit Dajan and Beita, east and south of the northern West Bank, wounding dozens of residents. The protesters were marching on their lands, protesting the illegal takeover of their orchards and farmlands for the benefit of the illegal Israeli colonialist activities. In Beit Dagan, the IOA attacked the protesters with a barrage of gas bombs, concussion grenades, and rubber-coated steel bullets. Dozens of residents suffered the effects of tear gas inhalation, and one was shot with a rubber-coated steel bullet. The IOA shot one Palestinian with a live round in the thigh, twelve with rubber-coated steel bullets, and 91 others suffered the effects of tear gas inhalation after the army attacked the protesters in Beita town. (IMEMC 20 August 2021)
- The Israeli Occupation Army (IOA) attacked a nonviolent procession held by dozens of Palestinians and international peace activists, protesting the escalating Israeli violations in the Masafer Yatta area, south of Hebron, in the southern part of the occupied West Bank. Dozens of residents held Friday noon prayers on the lands in the Um ash-Shaqhan area, between Tiwani and Shu'ab al-Batim east of Yatta. The IOA started firing gas bombs, concussion grenades, and rubber-coated steel bullets at the protesters immediately after they started marching to the Palestinian lands . Dozens of protesters suffered the

effects of tear gas inhalation in addition to cuts and bruises. The IOA also detained three Palestinians and two international peace activists. (IMEMC 20 August 2021)

- The Israeli Occupation Army (IOA) injured dozens of Palestinians during the weekly procession in Kufur Qaddoum town, east of the northern West Bank city of Qalqilia. The IOA invaded Kufur Qaddoum immediately after the procession started. Several Palestinians then burnt tires and hurled stones at the invading army vehicles. The IOA fired a barrage of gas bombs and concussion grenades, in addition to rubber-coated steel bullets. Dozens of protesters suffered the effects of tear gas inhalation, in addition to cuts and bruises. (IMEMC 20 August 2021)

- A Palestinian was injured by a rubber-coated metal bullets and dozens of people who suffered breathing problems after Israeli Occupation Army (IOA) suppressed the weekly march rejecting the settlements in Beit Dajan, east of Nablus. After the Friday prayer, the march was launched from the center of the village towards the seized lands where IOA fired rubber-coated metal bullets and tear gas canisters at the civilians. (PALINFO 20 August 2021)

- The Israeli Occupation Army (IOA) in the northern part of the West Bank invaded the Tulkarem Governorate and stopped the Palestinian Department of Agriculture from carrying out a road rehabilitation project. The IOA then confiscated the Palestinian bulldozers that were being used for the project. The attack took place in the village of al-Jarushiyya, north of Tulkarem in the West Bank. Israeli troops invaded the site of the project, harassed and attacked the workers, and confiscated the equipment. In addition to seizing the bulldozers, the IOA also detained the drivers of the bulldozers, and a contractor hired to lead the project. The land on which the project was taking place was Palestinian land, owned by local farmers. (IMEMC 21 August 2021)

- The Israeli Occupation Army (IOA) attacked Palestinian land surveyors in Masafer Yatta village, in the Hebron District. A group of Palestinian technicians from the Land Settlement Authority were surveying land in the Umm al-Shaqhan area of Masafer Yatta village when they were attacked by invading IOA. The Israeli troops fired tear gas at the technicians, causing several of them to suffer from tear gas inhalation. The location where the surveyors were working was near the illegal Israeli settlement of Avigal, constructed on stolen Palestinian land. (IMEMC 21 August 2021)

- The Israeli Occupation Army (IOA) fired many missiles into several areas in the Gaza Strip, causing severe damage, while Israeli navy ships opened fire at Palestinian fishing boats. Israeli Airforce fired at least six missiles into a building in the Sheikh Ejleen area, southwest of Gaza city, completely leveling it and causing serious damage to surrounding homes. The Israeli Airforce also fired four missiles into another area in the Nusseirat refugee camp, in central Gaza, destroying it and causing damage to surrounding homes and buildings. Furthermore, Israeli navy ships fired sporadic roads of live fire at Palestinian fishing boats near the coast of Gaza city, causing damage. The boats were fishing less than three nautical miles from the shore and they had to sail back to the shore due to the Israeli violations. Among the wounded, is a child only 13 years of age, who remains in a critical condition due to his gunshot wounds to the head. (IMEMC 21 August 2021)
- 41 Palestinians, one of whom seriously injured, after the Israeli occupation Army (IOA) fired at dozens of demonstrators who approached the separation fence east of Gaza City. Ten Children were among the casualties. Dozens of young men walked towards the fence and set fire to tires while some climbed the fence and raised the Palestinian flag. Thousands of citizens were participating in a mass rally a to mark the fifty-second anniversary of the burning of Al-Aqsa Mosque. The IOA announced the reinforcement of its forces on the borders of the Gaza Strip in anticipation of confrontations with the Palestinians. (PALINFO 21 August 2021)
- Two Palestinians were injured and two others were arrested after the Israeli police attacked Muslim worshipers who arrived at Al-Aqsa Mosque in Occupied Jerusalem to perform the noon prayer via Bab al-Asbat. The Israeli occupation police assaulted the worshipers and beat them and two of them were wounded. The Israeli police arrested other residents while strict Israeli measures were imposed in the Old City of Jerusalem, at the gates of the Mosque and the roads leading to it on the fifty-second anniversary of the burning of Al-Aqsa Mosque. (PALINFO 21 August 2021)
- The Israeli Occupation Army (IOA) invaded the village of al-'Arqa, west of the northern West Bank city of Jenin, before storming and ransacking many shops, leading to protests. The IOA invaded and violently searched many shops, causing excessive damage, before inspecting surveillance recordings, in addition to interrogating the shop owners. Many Palestinian youngsters protested the invasion, and the IOA fired many gas bombs and concussion grenades, in addition to

rubber-coated steel bullets. Several Palestinians suffered the effects of tear gas inhalation. (IMEMC 22 August 2021)

- The Israeli Occupation Army (IOA) invaded Beit Fajjar town, south of Bethlehem, searched homes, and detained a young man, identified as Shadi Walid Taqatqa, 23. (IMEMC 22 August 2021)
- The Israeli Occupation Army (IOA) chased many Palestinian workers west of Far'un village, south of the northern West Bank city of Tulkarem, and detained dozens. The IOA stationed near the Annexation Wall west of the village, chased dozens of workers to prevent them from entering Jerusalem. The IOA detained and interrogated dozens of workers for several hours, before releasing them and forcing them to return to their communities. (IMEMC 22 August 2021)
- The Israeli Occupation Army (IOA) shot a young Palestinian man with special needs, east of Bethlehem, south of the occupied East Jerusalem, in the West Bank. The young man has been identified as Omar Mousa Hasan Shalalda, 25. Shalalda was shot with a live round in the leg. (IMEMC 22 August 2021)
- The Israeli Occupation Army (IOA) shot, a young Palestinian man at the container military roadblock, southeast of the occupied East Jerusalem, in the West Bank. The name and the condition of the Palestinian remain unknown, as the IOA closed the area, and later an Israeli ambulance took him to a hospital. The wounded young man is 25 years of age. (IMEMC 22 August 2021)
- The Israeli Occupation Army (IOA) detained Ali Nofal from Ras Karkar village, west of Ramallah. The IOA released Nofal several hours of interrogation. (PALINFO 22 August 2021)
- The Israeli Occupation Army (IOA) stormed Beit Fajjar town, south of Bethlehem, and detained Shadi Taqatqa, 23, after they raided and searched his family's house. (PALINFO 22 August 2021)
- In Jenin, confrontations broke out between the youths and the Israeli Occupation Army (IOA) after they raided a house in Kfeiret village, west of Jenin. (PALINFO 22 August 2021)
- Israeli warplanes launched a series of raids on the Gaza Strip. The warplanes bombed two sites in the central Gaza Strip, without any injuries reported. (PALINFO 22 August 2021)

- A Palestinian young man with special needs was injured and detained after the Israeli occupation Army (IOA) opened fire at him at a military checkpoint in the north of Bethlehem. The IOA at the Container checkpoint in northern Bethlehem opened fire at a young man with a disability as he was walking towards the checkpoint, without posing any threat. The young man suffered a bullet injury in his leg and was detained by the IOA. There was no information about his identity and health condition. The IOA closed the checkpoint in both directions following the incident, causing a heavy build-up of traffic. (PALINFO 22 August 2021)
- The Israeli occupation Army (IOA) stormed commercial stores in Araqah village, west of Jenin, amid clashes with local youths. The IOA interrogated storeowners and watched security camera recordings during the campaign. Meanwhile, the IOA clashed with local youths and showered them with tear gas canisters. Several young men suffered from their exposure to tear gas fumes. (PALINFO 23 August 2021)
- In Tulkarem, the Israeli occupation Army (IOA) behind the separation wall in the west of Far'un town chased a number of West Bank workmen as they were trying to reach workplaces in the 1948 occupied lands (Israel). The IOA prevented many workmen from crossing into Israel and detained dozens of them. (PALINFO 23 August 2021)
- The Palestinian Water Authority (PWA) stated that the Hebron Governorate in the south of the occupied West Bank is suffering from water shortage due to interruption in supply from the Israeli water company, Mekerot that led to heavy loss of water that exceeded 40,000 cubic meters. The PWA stated that despite the fact that its teams met last week with the Israeli company to discuss the repeated interruptions in water supply to the Hebron governorate, who promised to resolve this issue, the interruption in water supply has nevertheless continued and intensified today. (WAFA 23 August 2021)

Israeli Settler Violence

- In Bethlehem, south of occupied Jerusalem in the West Bank, Israeli settlers invaded a Palestinian orchard, owned by Yousef Abed Hajar, and sprayed his olive saplings with toxic chemicals. The attack took place in the Wad Abu Bkeir area, near the Neve Daniel and Eleazar settlements which were built on stolen Palestinian lands, and led to the destruction of more than 140 olive saplings. (IMEMC 1 August 2021)

- Dozens of Jewish settlers stormed the holy Al-Aqsa Mosque and performed Talmudic rituals in the eastern courtyards of the Mosque. The settlers carried out tours near Bab al-Rahma before leaving from Bab al-Silsila under the protection of the Israeli police. The occupation police facilitated the storming of settlers by securing their entry from the Magharabi Gate. The settlers documented their incursion by taking photos and videos. (PALINFO 1 August 2021)
- In Bethlehem, south of occupied Jerusalem in the West Bank, Israeli settlers invaded a Palestinian orchard, owned by Yousef Abed Hajar, and sprayed his olive saplings with toxic chemicals. The attack took place in the Wad Abu Bkeir area, near the Neve Daniel and Eleazar settlements which were built on stolen Palestinian lands, and led to the destruction of more than 140 olive saplings. (IMEMC 1 August 2021)
- Dozens of Jewish settlers stormed the holy Al-Aqsa Mosque and performed Talmudic rituals in the eastern courtyards of the Mosque. The settlers carried out tours near Bab al-Rahma before leaving from Bab al-Silsila under the protection of the Israeli police. The occupation police facilitated the storming of settlers by securing their entry from the Magharabi Gate. The settlers documented their incursion by taking photos and videos. (PALINFO 1 August 2021)
- Dozens of Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem under police protection. At least 78 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. A number of settlers also performed Talmudic prayers during their tours at the Islamic holy site. Meanwhile, police officers stopped a group of Palestinian women in Bab al-Sahira area and prevented them from entering the Aqsa Mosque at the pretext that they had no entry permits. (PALINFO 3 August 2021)
- Dozens of Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem under police guard. At least 168 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. A number of settlers also performed Talmudic prayers during their tours at the Islamic holy site. (PALINFO 4 August 2021)
- Dozens of Israeli settlers, accompanied by Israeli occupation Army (IOA) invaded the archeological area in Sebastia Palestinian town, north of the northern West Bank city of Nablus. Israeli army closed the entire area and restricted the freedom of movement to the Palestinians. Several army jeeps then accompanied a few buses filled with the colonizers into the site after completely isolating it from the surrounding areas, to prevent the Palestinians from reaching it. (IMEMC 5 August 2021)

- Dozens of Jewish settlers desecrated the Aqsa Mosque in Occupied Jerusalem under police escort. At least 145 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards in the morning. A number of settlers also performed Talmudic prayers during their tours at the Islamic holy site, mainly in its eastern area and near the Bab al-Rahma prayer hall. Later in the afternoon, about 39 settlers escorted by police officers defiled the Mosque in groups. (PALINFO 5 August 2021)
- Dozens of Israeli settlers broke into the archaeological area in Sebastia town, northwest of Nablus. Settlers broke into the place, amid strict military measures by the Israeli occupation Army (IOA). The area and the roads linking to it were closed to the Palestinian citizens. (PALINFO 6 August 2021)
- Israeli settlers chopped down dozens of perennial olive trees in the lands of al-Jaba'a village, southwest of Bethlehem. A group of settlers cut down dozens of olive trees that are over 60 years old in the Saqfan al-Dabaa area of Wadi al-Watout lands, southeast of the village. The olive trees belonged to the citizen Rifaat al-Tus, noting that the citizens were not able to reach the land to count the number of the trees which were cut. The Israeli occupation authorities allow the Palestinian landowners to access their lands only twice a year when pruning trees and the other time during the olive harvest. (PALINFO 6 August 2021)
- The Israeli Occupation Army (IOA) injured dozens of Palestinians during the weekly procession in Kufur Qaddoum town, east of the northern West Bank city of Qalqilia. Several Israeli army jeeps invaded Kufur Qaddoum, and started firing gas bombs, concussion grenades, and rubber-coated steel bullets at the Palestinians and many surrounding homes. The attack causing dozens of residents, including those in their homes, to suffer the effects of tear gas inhalation. The IOA also ambushed several Palestinians and tried to detain them. (IMEMC 7 August 2021)
- The Israeli Occupation Army (IOA) shot, and killed an unarmed Palestinian man, and injured several more in the northern West Bank village of Beita, south of Nablus, during a demonstration in rejection of the continued expropriation of Palestinian land. The IOA shot Emad Ali Dwaikat, 37, a father of five children, the youngest being only two months old, with a live round in his chest, causing life threatening wounds. The army also targeted a photo-journalist covering the demonstration, shooting him in the knee with a rubber-coated steel round. At least 20 protestors were injured with rubber-coated steel rounds, two were struck with teargas canisters, five suffered from falls

while being pursued by the IOA, and 31 people suffered the effects of teargas inhalation. (IMEMC 7 August 2021)

- Dozens of Israeli settlers attacked several Palestinian farmers, shot at them and smashed their car on Mount Abu al-Shawareb in Kafr Rai, southwest of Jenin. Ibrahim Melhem and a number of his companions were attacked by settlers while they were on their agricultural lands in the Kafr Rai area. The settlers chased the young men, opened fire at them and smashed Melhem's car. On 19/07/2021, the settlers had seized Mount Abu al-Shawareb, claiming that it was state property and that it had no owners. The settlers were stationed on the top of the mountain between Kafr Rai, built a road that leads to it, burned the weeds in the place, set up a fence around it, and began moving their belongings from the nearby Dotan settlement. (PALINFO 7 August 2021)
- Israeli settlers attacked many Palestinian cars near Taiseer Israeli military roadblock, east of Tubas in northeastern West Bank. Many settlers gathered near the roadblock and hurled stones at the Palestinian cars. The attack caused damage to at least two Palestinian cars and that the settlers were also hurling insults and trying to chase the cars, while the Israeli Occupation Army (IOA) did not even attempt to stop them. The settlers are also trying to install a new outpost on Palestinian lands in Bayyarat Saoud, area, east of Tubas. (IMEMC 8 August 2021)
- Several Israeli Settlers assaulted a man and destroyed his car, while he was on his farmland, south of the northern West Bank city of Jenin. The man, Ibrahim Hafeth Milhim, was working in his land in Jabal Abu ash-Shawareb mountain, in Kufur Ra'ey town, south of Jenin, when the settlers invaded his land and assaulted him. The man suffered various cuts and bruises. The settlers also attacked and damaged his car while it was parked near his land and kept the car in their possession. The Israeli assailants came from the settlement of Mevo Dotan. (IMEMC 8 August 2021)
- Israeli settlers resumed their daily intrusions into the courtyards of the Al-Aqsa Mosque from the Magharabi Gate under Israeli police protection. Dozens of settlers defiled the Al-Aqsa Mosque, carried out a provocative tour in its courtyards and performed Talmudic rituals. (PALINFO 8 August 2021).
- In Nablus, Israeli settlers assaulted a Palestinian farmer while he was working on his land in Beit Dajan, southeast of the city. The

Palestinian, Haitham Yasser an-Na'aji, 25, suffered various cuts and bruises. (IMEMC 9 August 2021)

- In occupied Jerusalem, dozens of settlers, accompanied by the Israeli Occupation Army (IOA) and police officers, stormed the courtyards of the Al-Aqsa Mosque, and conducted provocative tours, after the army assaulted the Palestinian Muslim worshipers and forced them away. (IMEMC 9 August 2021)
- In Tubas, in the northeastern West Bank, Israeli settlers attacked Palestinian cars, caused damage to two, near the Tayasir military roadblock. (IMEMC 9 August 2021)
- Israeli settlers organized a provocative rally in the Bab al-Asbat area in Occupied Jerusalem. The settlers were deployed in the Bab al-Asbat area, chanting inflammatory slogans against the Palestinians before they left the place. Meanwhile, the Israeli police were deployed in the Bab al-Asbat area and the vicinity of the Old City. This march comes hours after settlers toured the courtyards of Al-Aqsa Mosque in the morning and evening periods. (PALINFO 9 August 2021)
- Jewish settlers attacked a citizen and his sons in Kisan village, east of Bethlehem. A group of Ibi Hanahel settlers beat Hussein Obayat and his sons while they were on an agricultural land lot which they rented for cultivation near the settlement. He added that the Israeli occupation forces arrived at the place and detained Obayat and his sons. In another development, Ghazal pointed out that settlers brought large olive and pine trees and planted them in a mountainous area west of Kisan and installed electricity poles in the area. The village has been exposed to systematic settlement attacks that threaten to seize its lands and build a settlement road which results in preventing its owners from accessing and cultivating their lands. (PALINFO 9 August 2021)
- Dozens of Israeli settlers accompanied by Israeli occupation Army (IOA) invaded the archeological area in Sebastia Palestinian town, north of Nablus, in northern West Bank. More than 50 settlers and many IOA invaded the site. The IOA closed all surrounding areas, including many roads, seriously restricting the freedom of movement to the Palestinians. (IMEMC 10 August 2021)
- Israeli settlers stormed the courtyards of the holy Al-Aqsa Mosque. Dozens of settlers broke into the Al-Aqsa Mosque, carried out provocative tours and performed Talmudic rituals under Israeli police protection. Other groups of Jewish settlers raided the archaeological

site in the town of Sebastia, north of Nablus. About 50 settlers stormed the archaeological site in the town under heavy Israeli army protection. (PALINFO 10 August 2021)

- Israeli settlers of Ramat Yoshai settlements in Tal Romedina neighborhood in Hebron, attacked the home of Bassam Ali Abu Aisha, before assaulting him and his family. The Israeli Occupation Army (IOA) were in the area and did not attempt to stop the assailants. (IMEMC 11 August 2021)
- Dozens of Jewish settlers, led by rabbi Yehuda Glick, broke into the Al-Aqsa Mosque courtyards under Israeli police protection. Groups of settlers, including Glick, broke into the Al-Aqsa Mosque from the Magharabi Gate and carried out provocative tours in its courtyards while receiving explanations about the alleged temple. The occupation police continue to impose restrictions on the entry of Palestinian worshipers to Al-Aqsa and check their ID cards at its gates. (PALINFO 11 August 2021)
- A group of Israeli settlers attacked Palestinian homes in Urif town, south of Nablus in the occupied West Bank. Settlers from the settlement of Yitzhar attacked homes in the eastern neighborhood of the town. There was no information about wounded citizens or damaged property during the settler attack or the clashes with forces. (PALINFO 11 August 2021)
- The Israeli occupation Army (IOA) suppressed Palestinian citizens participating in a protest sit-in near the Ibrahimi Mosque in Hebron City, while Israeli settlers assaulted other citizens inside nearby commercial stores. The IOA quelled a peaceful rally staged by local residents in protest at a new Judaization project targeting the Ibrahimi Mosque. Dozens of Palestinian protesters suffered from their exposure to tear gas fired by the IOA during clashes near the Mosque. Meanwhile, a group of settlers, under military protection, assaulted and harassed several citizens who were inside stores near the Ibrahimi Mosque. The IOA also detained three citizens, including a young woman, near the Mosque following the assaults on local residents by the IOA and settlers. (PALINFO 12 August 2021)
- Groups of Israeli settlers, under the protection of the Israeli occupation police, stormed the courtyards of Al-Aqsa Mosque, and made provocative tours of its courtyards and facilities. (NAD 12 August 2021)
- A group of settlers razed an area estimated at 35 dunams of the lands of the western Mazraa town. The land is owned by: Muhammad Khalil Yousef Abu Rabei. (NAD 12 August 2021)

- A group of Israeli settlers accompanied by many Israeli Occupation Army (IOA) invaded archeological sites on Palestinian lands in Beit Ummar town, north of the northern West Bank city of Hebron. The IOA accompanied dozens of Settlers into the sites, and conducted tours while carrying maps of the Palestinian lands and the sites. The settlers and the IOA also invaded archeological areas south of Beit Ummar. The sites are close to the Karmie Tzur settlement and extends to the Gush Etzion colonialist block. (IMEMC 13 August 2021)
- An Israeli settler attacked a Palestinian bus driver in occupied Jerusalem, causing several injuries. The driver, Mohammad al-Qaq, 47, suffered various cuts and bruises to the head, including his face, and other parts of his body. The settlers assaulted the Palestinian after boarding the bus where he works for the Israeli Egged bus company, Atarot branch, in occupied Jerusalem. (IMEMC 13 August 2021)
- A Palestinian woman was injured when a group of Israeli settlers assaulted her in Hebron City in the occupied West Bank. A woman called Jihad Si'ifan, a resident of Wad al-Husain neighborhood in central Hebron, suffered injuries and bruises when settlers from the settlement of Kiryat Arba savagely beat her. The woman was assaulted as she was filming the settlers during their attack on homes in her neighborhood. (PALINFO 14 August 2021)
- A group of Israeli Settlers attacked Palestinian homes in Hebron city, in the southern part of the occupied West Bank, wounding a woman, and causing damage to the properties. Several paramilitary settlers from the Kiryat Arba' settlement attacked Palestinian homes in the Wad al-Haseen neighborhood. The attack caused damage to the homes, and led to the injury of one woman, identified as Jihad Hussein Es'eifan, 40. (IMEMC 15 August 2021)
- Israeli settlers installed an outpost and expanded another, in Khirbat Zannouta Palestinian village, south of Hebron, in the southern part of the occupied West Bank. The settlers brought mobile homes and started installing structures on lands, owned by the Palestinians from the families of Samamra, Abu Sharkh, and Jabarin. This outpost is the third to be installed on Palestinian lands in the same area this year, amidst the escalating Israeli attempts to build and expand the settlements built on Palestinian lands. Dozens of settlers invaded the Palestinian lands, accompanied by many Israeli Occupation Army (IOA), and installed the outpost on 20 Dunams. The settlers installed twenty mobile homes on the lands, near the Regional Council of

Settlements, in the southern area of Hebron. The settlers also expanded another outpost, which was installed on nearby Palestinian lands, owned by Abu Sharkh and Jabarin families. (IMEMC 15 August 2021)

- Jewish rabbi Yehuda Glick was among scores of settlers who desecrated the Aqsa Mosque under police protection. Dozens of settlers, including Glick and other rabbis, entered the Mosque in groups through its Maghariba Gate and toured its courtyards. The Israeli police close al-Maghariba Gate, which is used by Jews to enter the Mosque, at 10:30 am after the settlers complete their morning tours at the holy site. Later in the afternoon, the same gate is reopened for evening tours by settlers. During the presence of settlers inside the Mosque compound, entry restrictions are imposed on Muslim worshippers at the entrances leading to the Mosque and their IDs are seized until they leave the holy place. (PALINFO 15 August 2021)
- Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem in the morning and later in the afternoon. At least 100 settlers entered the Mosque in different groups and toured its courtyards in the morning. Some settlers performed Jewish prayers and read their holy book during their morning tours at the Islamic holy site. Meanwhile, police officers assaulted and arrested three young men at the Mosque's Silsila Gate. One of the detained young men was identified as Ibrahim Rizq. (PALINFO 16 August 2021)
- A group of Israeli Settlers a Palestinian child near Sielet ath-Thaher town, south of the northern West Bank city of Jenin, before taking him to the site of a former settlement where they tortured him and caused burns to his foot. The child, identified as Tareq Abdul-Razeq Zobeidi, suffered cuts and bruises to several parts of his body, in addition to burns to his foot. Zobeidi and his friends were walking to a picnic area before a car of Israeli settlers tried to ram them. The settlers then jumped out of their car and snatched Tareq before repeatedly beating him up, while his friends managed to escape. The settlers took the child to the area of the evacuated Homish settlement and started torturing the child after tearing his clothes, in addition to burning the soles of his feet with an eclectic lighter. The Israeli settlers fled the scene after assaulting the child. (IMEMC 17 August 2021)
- Dozens of Israeli settlers desecrated the Aqsa Mosque in Occupied Jerusalem under police guard. At least 136 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. Many settlers performed Jewish prayers during their tours at the Islamic holy site, while Aqsa guards prevented some settler children from taking a

- leak in the Mosque's yards. Meanwhile, police forces rounded up, with no reason, Jerusalemite activist Nidham Abu Romuz during his presence at the Aqsa Mosque. (PALINFO 17 August 2021)
- Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. 86 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them performed Talmudic prayers. The Aqsa Mosque is exposed to daily desecration by Jewish settlers and police forces in the morning and the afternoon except on Fridays and Saturdays. The Israeli police close al-Maghariba Gate, which is used by Jews to enter the Mosque, at 10:30 am after the settlers complete their morning tours at the holy site. Later in the afternoon, the same gate is reopened for evening tours by settlers. During the presence of settlers inside the Mosque compound, entry restrictions are imposed on Muslim worshipers at the entrances leading to the Mosque and their IDs are seized until they leave the holy place. (PALINFO 18 August 2021)
 - Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. 138 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them performed Talmudic rituals and prayers. (PALINFO 19 August 2021)
 - A Palestinian young man was seriously injured when Israeli settlers stabbed him during his presence near a bazaar in Occupied Jerusalem. A 19-year-old Palestinian suffered serious stab wounds in the upper extremities of his body after young settlers attacked him with knives near west Jerusalem's Mahane Yehuda market. The Palestinian was waiting for a ride home from work when Jewish settlers bullied him and then stabbed him all over his body. He started running until he collapsed in Agrippas street near the market. None of the settlers has been arrested by the Israeli occupation police, which said they were investigating a possible terror motive. (PALINFO 19 August 2021)
 - A group of Israeli Settlers attacked many Palestinians, including shepherds, in Khirbat Zannouta village, south of Hebron. The settlers attacked the residents and the shepherds in Khirbat Zannouta, located east of the ath-Thaheriyya town, south of Hebron. The settlers came from Shema settlement. The settlers hurled stones at the Palestinians, in addition to chasing the shepherds away to force them out of the area. (IMEMC 22 August 2021)

- Dozens of Jewish settlers escorted by police forces desecrated the Aqsa Mosque in Occupied Jerusalem. At least 120 settlers entered the Mosque in groups through its Maghariba Gate and toured its courtyards. During their tours at the Islamic holy site, the settlers received lectures from rabbis about the alleged temple mount and a number of them performed Talmudic rituals and prayers. Meanwhile, police officers detained two Palestinian young men at the Aqsa Mosque's Bab Hitta Gate and hauled them to a detention center in the holy city. During the presence of settlers inside the Mosque compound, entry restrictions are imposed on Muslim worshipers at the entrances leading to the Mosque and their IDs are seized until they leave the holy place. (PALINFO 22 August 2021)
- A group of Israeli settlers set fire to an olive grove in Burin town, south of Nablus in the occupied West Bank. Settlers from the settlement of Yitzhar stormed an agricultural area in the south of Burin and set ablaze dozens of olive trees in a grove belonging to a local resident. (PALINFO 23 August 2021)
- A group of Israeli settlers placed two mobile homes on a Palestinian-owned tract of land in Deir Istiya town, west of Salfit, while other settlers expelled local farmers from their lands in a nearby area called Mount al-Ras. Settlers deployed two prefabricated homes in Harikat Abu Zuhair area, west of the town. This tract of land is threatened with annexation as settlers want to establish an outpost near the settlement of Havot Yair. 10 days ago, Havot Yair settlers bulldozed the same land and built a dirt road reaching from the settlement to the area. (PALINFO 23 August 2021)
- A group of armed Israeli settlers escorted by the Israeli Occupation Army (IOA) forced Palestinian farmers at gunpoint to leave their lands in Mount al-Ras area, west of Salfit. (PALINFO 23 August 2021)

Home Demolition & Demolition threats

- **The Israeli occupation authorities delivered demolition orders of two agricultural rooms in al-Walaja village, northwest of Bethlehem. The two rooms for Talib Ahmed, Hadna, and Aisha Jaafar al-Daras are located in the Khalat Al-Hoor site in the Ain Gweizeh area, northeast of the village. (PALINFO 1 August 2021)**
- **The Israeli occupation authority (IOA) handed a Jerusalemite citizen a notice ordering him to demolish his own three-story house in al-Bustan neighborhood in Silwan, south of the Aqsa Mosque. The homeowner, Yaqoub Al-Rajabi, was given until August 15 to raze the house to avoid paying penalties and demolition expenses to the**

Israeli municipality. The IOA claimed the house, which consists of two apartments and three stores, was built with no license. (PALINFO 3 August 2021)

- The Israeli Occupation Army (IOA) conducted large-scale demolitions of Palestinian property in Khirbet Ibzeiq village, northeast of Tubas. The IOA escorted bulldozers into the village, where the heavy types of machinery have been tearing down residential structures and livestock sheds and sabotaging water tanks and solar panels since 6:00 AM in the morning. The IOA also seized several agricultural tractors and private vehicles. (IMEMC 4 August 2021)
- The Israeli Occupation Army (IOA) invaded Sebastia Palestinian town, north of the northern West Bank city of Nablus, before demolishing an agricultural room and bulldozing farmlands surrounding it. The IOA invaded the lands, close to the archeological area, before demolishing the room, owned by Abdul-Aziz Nabulsi. The IOA also bulldozed and uprooted the surrounding lands, in addition to destroying an irrigation network and a fence. This is the second time the IOA demolish the room in recent months. (IMEMC 4 August 2021)
- The Israeli Occupation Army (IOA) and bulldozers demolished 20 commercial structures in the town of Hizma, northeast of occupied East Jerusalem, in the West Bank. The IOA surrounded and invaded the area near the Hizma military roadblock, before demolishing the eight structures, owned by members of the local Khatib family. The Central Court in Jerusalem denied an appeal filed by a colonialist organization, two months ago, demanding the demolition of the structures, however, it changed its verdict and issued a demolition order that was carried within eight hours, before the Palestinians could file any appeals. Over the last few months, the Regavim colonialist organization filed lawsuits demanding the demolition of sixteen structures in Hizma, all owned by the Khatib family, and alleged that the structures are all within the boundaries of Jerusalem. (IMEMC 4 August 2021)
- The Israeli Occupation Army (IOA) invaded Thra' Awwad area, north of al-Hamra area, in the northern part of the Jordan Valley, in the occupied West Bank, and demolished three structures. Several army jeeps and bulldozers invaded the area, before demolishing three newly constructed cement rooms, owned by Adnan Salamin. The structures were built by the Palestinian on his own land, and the army claimed they were not licensed by the "Civil Administration Office," the

administrative branch of the illegal Israeli occupation. (IMEMC 4 August 2021)

- Israel destroyed, raided, and ransacked 11 Palestinian-owned printing presses, media offices, and bookstores in the first seven months of this year. Israel destroyed four printing presses or publishing houses and four bookshops during its 11-day offensive on Gaza in May. In the occupied West Bank, the Israeli Occupation Army (IOA) raided ransacked, and destroyed equipment in three printing presses in Ramallah, Bethlehem and in Al-Eizariya, east of occupied Jerusalem, while ordering the closure of the Ramallah-based printing press. (IMEMC 5 August 2021)
- The Israeli Occupation Army (IOA) demolished two Palestinian under-construction homes in Sa'ir town, east of the southern West Bank city of Hebron. Several Israeli army jeeps and a bulldozer invaded the Wad ash-Sharq area in Sa'ir, before demolishing two three-story homes, owned by 'Aahed Ali Jaradat and Jamal Mohammad Jaradat, and were built on their privately owned lands. Each floor of the two three-story homes was about two hundred square/meters, and were permitted by the local council, however, the army claimed the "Civil Administration Office," the administrative branch of the illegal Israeli occupation, did not grant permits to the buildings, because they are in Area C of the occupied West Bank. The Israeli Occupation Army (IOA) injured one Palestinian and caused dozens to suffer the effects of tear gas inhalation during protests that erupted after the army demolished two under-construction homes. The IOA shot one Palestinian with a rubber-coated steel bullet. The IOA also fired a barrage of gas bombs and concussion grenades at the Palestinians, causing dozens to suffer the effects of tear gas inhalation, in addition to cuts and bruises. (IMEMC 5 August 2021)
- The Israeli Occupation Army (IOA) demolished five agricultural rooms in Wadi Rahhal village, south of Bethlehem, south of occupied Jerusalem in the West Bank. The IOA invaded the Shu'ab Sultan area in Wadi Rahhal, and demolished the five rooms. The army claims the rooms, built on private Palestinian lands, did not receive a permit from the so-called "Civil Administration Office," the administrative branch of the illegal Israeli occupation of Palestine. It is worth mentioning that, about a month ago, the IOA invaded the area and handed fifty demolition orders targeting agricultural rooms, in addition to orders halting any construction in the area. (IMEMC 5 August 2021)

- The Israeli Occupation Army (IOA) demolished two residential tents and one residential shed, in addition to two barns, in the Ka'abna Bedouin village, near the al-Mo'arrajat area, east of the central West Bank city of Ramallah, and confiscated agricultural tools. Several Israeli army jeeps, accompanied by a truck and bulldozers, invaded the Bedouin community before demolishing two residential tents, one residential shed, and two barns. The IOA also confiscated agricultural tools and the materials of the demolished shed, barns, and tents. (IMEMC 5 August 2021)
- The Israeli Occupation Army (IOA) invaded Jit village, east of the northern West Bank city of Qalqilia, and handed a Palestinian, identified as Samed Khader, an order to halt the construction of his 120 square/meter home. (IMEMC 5 August 2021)
- The Israeli occupation army (IOA) demolished three homes in Sa'ir town, east of Hebron, at the pretext they were built with no permits in Area C of the West Bank. Israeli bulldozers escorted by the IOA stormed Wad ash-Sharq area of the town and knocked down three houses with three floors each, belonging to local residents from the family of Jaradat. The IOA assaulted the owners and their relatives and rounded up two young men as the bulldozers embarked on razing the homes. (PALINFO 5 August 2021)
- In the Bedouin communities near the Taybeh checkpoint, east of Ramallah, several Bedouin citizens, including children, women and elderly, have become homeless and will suffer from the harsh weather and its scorching heat for a while before they manage to have new makeshift homes again. (PALINFO 5 August 2021)
- A Palestinian citizen in Jit village, east of Qalqilya, received a stop-work order from the Israeli army against his unfinished house at the pretext of unlicensed construction. The house belongs to Samed Khader from the village. (PALINFO 5 August 2021)
- The Israeli Occupation Army (IOA) demolished two residential tents, one shed, and a barn in the Ka'abna Bedouin community in the al-Mo'arrajat area east of Ramallah, in central West Bank, in addition to confiscating agricultural equipment and tools used by the farmers and Shepherds. Several army jeeps and trucks invaded the Bedouin community after surrounding it. The IOA then dismantled and demolished two residential tents, one residential shed, and a barn, before confiscating the materials along with agricultural tools. The demolished and confiscated properties are owned by the family of

Mohammad Suleiman Ka'abna, in addition to Ahed Ali Jaradat and Jamal Mohammad Jaradat. (IMEMC 7 August 2021)

- The Israeli Occupation Army (IOA) invaded Jit village, east of the northern West Bank city of Qalqilia, and handed a Palestinian, identified as Samed Khader, a demolition order targeting his under-construction 120 square/meter home. (IMEMC 7 August 2021)
- Several Israeli army vehicles, including bulldozers, invaded the town of Ya'bad, southwest of the northern West Bank city of Jenin and demolished three commercial structures and a water tank. The IOA demolished three commercial structures at the southern entrance of the town. The structures are owned by Mohammad Khaled Atatra and Omar Zeid al-Kilani. The Israeli army claimed the three structures were not licensed by the so-called "Civil Administration Office," the administrative branch of the Israeli occupation.
- Israeli army vehicles demolished a water tank, owned by Palestinians from the local Sha'er family, near the main road between Ya'bad and Arraba towns in Jenin Governorate. The Israeli Army fired gas bombs and concussion grenades at Palestinians who gathered to protest the demolition process, causing a few to suffer the effects of tear gas inhalation. (IMEMC 9 August 2021)
- **Israeli occupation Army (IOA) stormed Ya'bad town, south of Jenin, and razed a commercial establishment and a cattle shed. The IOA patrols and a military bulldozer closed the entrance to Ya'bad and demolished a butchery, a restaurant and a cattle shed near the entrance owned by Mahmoud Abu Bakr. The IOA claimed that these buildings are built in an area where construction is prohibited (area C).** (PALINFO 9 August 2021)
- The Israeli Occupation Army (IOA) demolished a two-story Palestinian home in Silwan town, south of the Al-Aqsa Mosque, in occupied Jerusalem. The home is owned by two siblings, identified as Ramah and Ali Odah. The home is in the Be'er Ayyoub area in Silwan and that the IOA closed the entire area and prevented the Palestinians from entering or leaving it. The IOA then forced the family to remove their furniture and belongings from the property before demolishing it, rendering twelve Palestinians homeless. It took the family many years to save some money to build their home to provide stability and decent shelter to the family and added that the family has also been paying

various high fines and fees to the City Council, but it kept it refusing to grant them a permit for the property. (IMEMC 10 August 2021)

- The Israeli Occupation Army (IOA) invaded the town of Battir, west of Bethlehem city, south of the occupied Palestinian capital, Jerusalem, in the West Bank, and bulldozed a paved road. The IOA invaded the Karem Hadidoon area in basin Baten Abu Hasan, in the eastern part of the town. The Israeli military bulldozers then bulldozed and destroyed a 1-kilometer long road used by the Palestinians. Many Palestinians gathered in the area and protested the attack before the IOA assaulted and injured Zaki al-Batma, 60, a member of Battir Town Council, in addition to a council employee, identified as Sa'id Abu Harthiyya. (IMEMC 10 August 2021)
- **The Israeli occupation authority (IOA) displaced Jerusalemite families after forcing them to demolish their homes in Beit Hanina town, north of the holy city. 40 Palestinians were rendered homeless after the Israeli municipality in the occupied holy city forced seven brothers of the Obaidi family to knock down their homes. The seven families had to deploy a makeshift tent on the ruins of their homes, but they fear that the municipality may order the removal of the tent. They have been living here for 15 years. The family is composed of seven brothers and have families numbering about 40 people, mostly children under age 16. The municipality already imposed on him and one of his brothers tens of thousands of shekels in penalties for building the homes with no permits. (PALINFO 10 August 2021)**
- The Israeli Occupation Army (IOA) demolished a Palestinian carwash facility in the al-Lubban ash-Sharqiya village, south of the northern West Bank city of Nablus. Several Israeli military jeeps, and a bulldozer, invaded an area near the main entrance of the village, before demolishing the carwash facility. The destroyed facility is owned by a local man, identified as Khalil Ibrahim Oweiss. The Israeli army claims that Oweiss, who built the facility on his land, did not obtain a permit from the "Civil Administration Office," the administrative branch of the illegal Israeli occupation. (IMEMC 11 August 2021)
- The Israeli Occupation Army (IOA) demolished a chicken farm in Ein Jweiza neighborhood, in the al-Walaja village, northwest of Bethlehem, south of occupied Jerusalem in the West Bank. The farm is owned by a local man identified as Shadi Mousa Abed Sheikh. A week ago, the army issued a demolition order under the pretext of being built without a permit from the Israeli Civil Administration Office, and

demolished it today without allowing sufficient time for an appeal. The Palestinian had 300 chickens in the demolished farm, and most of the chickens died under the rubble as the soldiers did not allow him to take them out of the structure before tearing it down. (IMEMC 11 August 2021)

- The Israeli Occupation Army (IOA) demolished a Palestinian home, a well, and agricultural structures east of Yatta town, south of Hebron, in the southern part of the occupied West Bank. The Israeli bulldozers demolished a well, owned by Fikri Dababsa, in Khallet ad-Dabe' area, east of Yatta. The well was in Fakhri's land, in Area C of the occupied West Bank, and was used for irrigation. (IMEMC 11 August 2021)
- In Khallet ad-Dabe', the Israeli Occupation Army (IOA) demolished three residential sheds, owned by members of the Dababsa family, and attacked many residents, wounding Ali Amer Dababsa in his leg before he was moved to a local hospital. (IMEMC 11 August 2021)
- The Israeli Occupation Army (IOA) demolished an agricultural shed, owned by Akram Abu Sabha, in the al-Fakheet area, east of Yatta. The shed was previously demolished once before he rebuilt it. (IMEMC 11 August 2021)
- Israeli bulldozers demolished Palestinian structures to the east of Yatta city, south of the occupied West Bank city of Hebron. The Israeli Occupation Army (IOA) escorted bulldozers to Khallet al-Dabe' area, east of the city, where the heavy machineries demolished a rainwater collection well belonging to Fekri Dababsah. The well was demolished under the pretext that it was built in Area C. **(Wafa 11 August 2021)**
- The Israeli bulldozers tore down an agricultural shack for the second time in the area of al-Fakhit, east of Yatta, owned by local resident Akram Abu Sabha. The IOA also tore down an agricultural room besides to a 100-square-meter house belonging Muhammad Dababsah, displacing his family comprising over 12 members. **(Wafa 11 August 2021)**
- Five Palestinian families were displaced after the West Jerusalem Israeli municipality forced them to demolish their homes located in Beit Hanina neighborhood in northern East Jerusalem claiming the land the houses were built on was owned by Jews since before the 1967 Israeli occupation of the West Bank, including East Jerusalem, according to witnesses. Members of the Khader family began to

demolish their five apartments in the Ashqariya area of the neighborhood to avoid paying exorbitant fees in case the municipality carries out the demolition itself. An Israeli court last week rejected an appeal by the families to stop the municipality's demolition order, which was issued at the request of Israeli settlers who claimed ownership of the land on which the homes were built since 1962. The five apartments belong to Abdullah Khader and his sons and their families. (Wafa 12 August 2021)

- **The Israeli occupation Army (IOA) handed the citizens: Muhammad Ali Sawarka and Khalil Muhammad al-Shaer, notices to vacate their land, and to remove all the barracks in it for raising livestock within 14 days. (NAD 12 August 2021)**
- **The Jerusalemite family of Abdullah Talib Khudair from Beit Hanina town, in Occupied Jerusalem preferred to raze their house, which consisted of five apartments, rather than allowing Jewish settlers to live in it. Abdullah Khudair, had opted to demolish his home and the homes of his sons, otherwise the settlers would have seized them. The Israeli occupation municipality in Jerusalem had notified Khudair's family to evacuate their home within 20 days and the period ended on Thursday after which they should leave their homes and allow settlers to live in them. (PALINFO 13 August 2021)**
- **The Israeli Occupation Army (IOA) invaded Khirbat Yizra village, east of Tubas in northeastern West Bank, and dismantled solar panels, used by the Palestinians to provide them with electricity. Several Israeli army jeeps surrounded the community before invading it. The IOA confiscated a solar unit consisting of eight panels, used by Na'im Hafeth Masa'eed, and his son, Rami. The IOA also confiscated another solar unit of six panels, used by another Palestinian, identified as Sa'id Abu Thaher. (IMEMC 15 August 2021)**
- **The Israeli occupation authority (IOA) displaced Jerusalemite families after forcing them to demolish their own homes in Silwan district and Jabel al-Mukaber neighborhood at the pretext of unlicensed construction. Ththe Israeli police phoned Mohamed Matar and asked him to comply with a demolition order issued previously by the municipality against his house in Ein al-Hilweh neighborhood of Silwan district. The police also warned Matar that he would have to pay 100,000 shekels to the municipality if he refused to demolish his own house at his own expense. Matar had to start demolishing his house with his own hands because of his difficult living conditions and the financial penalty which he still**

pays to the municipality for building the house with no permit. Matar was given one week to finish demolishing the house, which he built 12 years ago. Matar lived in that house with his wife and four kids. (PALINFO 15 August 2021)

- **The Israeli municipality forced a young man called Ali Sari to demolish his own house in Jabel al-Mukaber, south of the Aqsa Mosque. Sari lived in the house, which he built five months ago, with his wife and three children. (PALINFO 15 August 2021)**
- A Palestinian man was forced to destroy his new home in at-Tur town in occupied East Jerusalem. Muhammad Dweik, recently married, completed the construction 6 months ago, and moved into the 70 square meter home, which he built next to his family's house. The Municipality of West Jerusalem ordered the home to be demolished, under the common pretext of building without a permit. Dweik appealed the decision, however the municipality denied the appeal, so he and his family members began to demolish the home in order to avoid paying the unreasonable fines imposed by the municipality if they carry out the demolition. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) invaded 'Atouf Palestinian village, southeast of Tubas in northeastern West Bank, before destroying a road and demolishing an agricultural room. Israeli military bulldozers destroyed a three-kilometer road, used by the farmers to reach their lands. The road was funded and supervised by the Palestinian Agricultural Relief, to help the dozens of farmers in the area. In addition, the IOA invaded a land, owned by Rami Srour Bani Odah, and demolished his agricultural room. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) demolished an agricultural room on Palestinian land in Deir Ballout town, west of Salfit, in central West Bank. The IOA invaded KHALLET al-'Abhar area, in the western part of Deir Ballout, and demolished an agricultural room, on land owned by Hosni Mousa. The area has been subject to repeated Israeli violations, including the demolition of property and the uprooting of trees. (IMEMC 16 August 2021)
- The Israeli Occupation Army (IOA) invaded Khirbet Ibbiq Bedouin village, in the Northern Plains of the occupied West Bank, before handing two families demolition orders targeting their homes and barns. The IOA handed two demolition notices targeting residential structures, and barns. The IOA also demanded another family to

demolish and remove their tents and barns within one week. The IOA also informed a family that they needed to leave their structures on August 22nd, 25th, and 31st, as the army intends to conduct live-fire training. It is worth mentioning that, this month alone, the army destroyed and seized 17 structures in the Bedouin community, displacing 27 people, including 19 children. (IMEMC 17 August 2021)

- The Israeli occupation authorities (IOA) demolished a kindergarten in Beit Sfafa town, southwest of the occupied city of Jerusalem. The IOA escorted a Jerusalem municipality bulldozer to al-Safeh area in the town, where the heavy machinery tore down a kindergarten belonging to Mohammad Jum'a. The kindergarten, adjacent the Jum'a family's house, was supposed to open its doors with the beginning of the new school year. (IMEMC 17 August 2021)
- The Israeli Occupation Army (IOA) demolished a Palestinian home in Yitma village, south of Nablus, in the northern part of the occupied West Bank. The IOA demolished the under-construction home on Bara' Ismael Najjar, in the northeastern part of the village. The army issued the demolition order against the property only a week ago, under the pretext of being built without a permit from the so-called "Civil Administration Office," run by the illegal Israeli occupation. It is worth mentioning that, fifteen years ago, the army demolished Bara's home under the same allegations. (IMEMC 17 August 2021)
- The Israeli Occupation Army (IOA) demolished a barn in Qaffin town, north of Tulkarem, in the northern part of the occupied West Bank. Several Israeli military jeeps and a bulldozer invaded the town before demolishing a barn and a water reservoir, owned by Nidal Abdul-Rahim Ajjouli, 40. The IOA Nidal, who was sleeping in his barn to guard his livestock and assaulted his cousin Rashwan Nasreddin Ajjouli who tried to help him in removing the livestock out of the barn before the soldiers demolished it. The destruction was carried out without a warning, especially since the Palestinian never received a demolition order. The attack is not the first, as the IOA demolished, nearly 18 months ago, a concrete room allegedly for being built with a permit from the so-called Civil Administration Office, the administrative branch of Israel's illegal occupation. (IMEMC 18 August 2021)
- The Israeli occupation Army (IOA) demolished a Palestinian-owned commercial structure in the town of Yabad, the second demolition for

the same owner. A force accompanied by Israeli military officials demolished the structure owned by Mohammad Atatra and located at the eastern entrance to the town. The forces demolished nine days ago a supermarket also owned by Atatra under the pretext they were built without a permit. (WAFA 19 August 2021)

- Dozens of Israeli occupation Army (IOA) invaded a Printshop in Hebron city, in the southern part of the occupied West Bank, confiscated its machines and equipment, in addition to ordering it shut until February of 2022. Dozens of IOA invaded the Ein Sarah area, in Hebron, before breaking into the Palestinian Advertisement Company, owned by Emad ath-Theeba, and confiscated more than 19 press machines, in addition to various official documents. The IOA weld the company's front iron doors shut and placed an order shutting it down until February of next year, 2022. The invasion led to protests before the IOA fired many gas bombs and concussion grenades; there have been no immediate reports of injuries. (IMEMC 18 August 2021)

Israeli Military Orders

- The Israeli occupation authorities (IOA) notified Palestinian landowners of their intention to evict them from their land in Teqoua' town, east of the southern West Bank city of Bethlehem. Residents Mohammad Sawarka and Khalil al-Sha'er received Israeli military orders to "evacuate" and remove all livestock shacks from their land within 14 days. The IOA seized some agricultural equipment and destroyed the doors of the livestock shacks of al-Sha'er while pointing that the occupation authorities have been targeting Palestinian livestock keepers in Teqoua' wilderness in order to expel them and seize their land to make room for colonial settlement expansion. (IMEMC 11 August 2021)
- The Israeli occupation army (IOA) notified a Palestinian citizen of its intent to demolish an agricultural storeroom and confiscate a drinking water tank in al-Khader town, south of Bethlehem. The storeroom is located in Wadi ash-Shami area of the town and belongs to farmer Ibrahim Suleiman, adding that the water tank is also located in the same area. (PALINFO 11 August 2021)

Confiscation & Razing of lands

- Israel plans to expropriate a thousand dunums of citizens' land in the Jordan Valley and preventing their owners from accessing it. Israeli bulldozing and road construction activities are ongoing in an area near al-Hadidiya, east of Tubas, which points to preparatory work for the establishment of a settlement outpost. There are 36 settlement outposts distributed on Palestinians' lands in that area and more than 20 military training camps. (PALINFO 2 August 2021)
- A new initiative by the Jewish National Fund (Keren Kayemeth LeIsrael) on registration of properties beyond the Green Line could lead to the eviction of Palestinians from their homes in the West Bank and East Jerusalem. JNF's board of directors is set to meet on Thursday to approve the plan, which entails reviewing 17,000 property assets across Israel and the West Bank that have not been registered to date. The entire project is expected to cost about 100 million shekels (\$31 million) and take five years to execute. The proposed project covers properties that were purchased by the JNF both before and after 1948. These properties are found only in the records of the JNF, or affiliated bodies, and were never registered with the government. In some cases, contracts and other agreements exist attesting to the purchases being finalized; in others, there are documentations of negotiations that were never completed. Furthermore, there are cases in which the JNF does not know exactly where the land is located because the documentation is obsolete. In the past, the JNF had purchased property throughout the West Bank, probably also in Areas A and B, which are under Palestinian civil jurisdiction. This would mean that Israel would not have authority, in terms of construction plans, in these places and the JNF would not be able to claim ownership of them. The JNF estimates that there its documentation applies to 360 West Bank properties, and that a contract proving ownership can be assigned to 170 of them. Most of the land was bought after 1967 by the JNF subsidiary Himnota, formed after the Six-Day War. A minority were acquired before 1948 by a nonprofit established during the British Mandate. Other properties are located in parts of Jerusalem east of the Green Line. They make up about 2,050 plots covering approximately 2,500 dunams (625 acres). These properties have been administered since 1967 by the Israeli government's General Custodian, which took them over from the Jordanian government's unit dealing with abandoned enemy properties. The JNF assumes that some properties are inhabited by Palestinians it deems "squatters." In cases where the JNF registers properties found to be inhabited by said "squatters", it will be up to the Israel Land Authority, which is the actual authority over these plots, to order evictions. These properties are similar in status to those located

in Jerusalem's Sheikh Jarrah and Beit Hanina neighborhoods, where Palestinian residents are currently waging a legal battle against evictions from houses owned by settler organizations. In the past, the JNF demanded the expulsion of Palestinians from land belonging to the organization. In 2019, a Palestinian family living near Bethlehem were evicted from their home and café, and an outpost was built on the land a short while after. Similarly, in East Jerusalem's Silwan neighborhood, a Palestinian family has been waging a legal battle for the past 20 years because their house was transferred to the JNF after it was declared an absentee asset. Last month, Haaretz reported that the Defense Ministry had asked the JNF to buy hundreds of dunams of privately owned Palestinian land in the West Bank that had been worked by settlers while access was denied to its Palestinian owners. The investigation also revealed the existence of secret transactions conducted by Himnota to purchase West Bank land without the knowledge of the JNF board. (Haaretz 5 August 2021)

- The Israeli occupation army (IOA) accompanied by heavy machinery, razed land near the al-Ibrahimi Mosque, in the southern occupied West Bank city of Hebron. Israeli military vehicles leveled the grounds adjacent to the holy site, implementing the occupation state's plan to construct an elevator and road exclusively for use by Israeli settlers. (IMEMC 11 August 2021)
- The Israeli occupation Army (IOA) bulldozed Palestinian lands near Sbeih Mountain in Beita town, south of the northern West Bank city of Nablus. The IOA bulldozed the Palestinian lands in Karem al-Nimir area, near Sbeih mountain, after isolating the entire area. The IOA also brought concrete blocks and closed an agricultural road leading to the mountain to prevent the Palestinians from reaching it. (IMEMC 19 August 2021)
- The Israeli occupation army (IOA) bulldozed a swath of land belonging to Othman Hassunah in Hebron City. The IOA also razed fences, walls, gardens, basins and mobile homes in Dahr al-Hawa area in northern Hebron at the pretext that they are located in Area C of the West Bank. (PALINFO 19 August 2021)
- In Bethlehem, the civil administration bulldozed a swath of land in Zaatara town belonging to Mohamed at-Taweel. (PALINFO 19 August 2021)
- The Israeli occupation army (IOA) bulldozed a vast tract of land in Qalqilya in order to expand a settler road. The Israeli army started to expand Road 55, which was built in the area between Qalqilya and Nablus. In 2019, the Israeli army announced its intent to seize about

166 dunums of land in the area in order to expand the road. According to the Israeli plan, this project will be carried out on lands seized from Azzun town, Nabi Ilyas village and Qalqilya city. (PALINFO 23 August 2021)

Expansion of settlements

- The Israeli occupation authorities (IOA) began implementing a Judaization project on an area of 300 square meters of the yards of the Ibrahimi Mosque by installing an electric elevator to facilitate the Jewish settlers' incursions. (PALINFO 13 August 2021)
- Israel has given initial approval to advance construction of 863 housing units in Palestinian villages in Area C of the West Bank for the first time in years, in a move led by Prime Minister Naftali Bennett to also push through plans for more than 2,000 settlement homes. The plans for new housing in five West Bank villages in Area C will be considered next week by the top planning council at Israel's Civil Administration in the West Bank prior to their being filed for public comment. The villages involved are Al-Ma'asara (150 units), Bir al-Basha (270), Al-Masqufa (233), Khirbet 'Aaba (160) and Khirbet Zakariya (50). The planning council is also expected to consider next week plans for 1,351 housing units in Israeli settlements in the West Bank before filing them for public comment, and approve 908 more units, alongside the plans for the Palestinian villages. The settlement housing units expected to get final approval include 58 in Beit El, 285 in Har Bracha and 105 in Alon Shvut. (Haaretz 11 August 2021)

Erection of Israeli checkpoints

- The Israeli occupation Army (IOA) set up a checkpoint at the northern entrance to the city of Salfit, to search cars and check the identities of citizens. (NAD 1 August 2021)
- The Israeli occupation Army (IOA) set up a checkpoint at the entrance to the town of Deir Ballut, to search cars and check the identities of the citizens. (NAD 1 August 2021)
- The Israeli occupation Army (IOA) set up a checkpoint at the western entrance to the town of Deir Istiya, to search cars and check the identities of citizens. (NAD 1 August 2021)
- The Israeli occupation Army (IOA) set up a checkpoint at the western entrance to the town of Kafr ad-Dik, to search cars and check the identities of the citizens. (NAD 1 August 2021)

- The Israeli occupation Army (IOA) set up a checkpoint at the western entrance to the town of Kafr ad-Dik, to search cars and check the identities of the citizens. (NAD 12 August 2021)
- The Israeli occupation Army (IOA) set up a checkpoint at the entrance to the town of Deir Istiya, to search cars and check the identities of the citizens. (NAD 12 August 2021)
- The Israeli occupation Army (IOA) on Wednesday evening deployed several concrete blocks on the road leading to Mount Sobeih in Beita town near Nablus City, while local youths continued to stage their night protests in the area. The IOA placed a number of concrete blocks on the road leading to al-Huta area near Mount Sobeih. (PALINFO 19 August 2021)
- The Israeli Occupation Army (IOA) installed many military roadblocks in various parts of the Hebron governorate, in the southern part of the occupied West Bank. The IOA installed roadblocks on roads leading to Yatta, Khallet al-Mayya, Masafer Yatta, the al-Fawwar refugee camp, the al-'Arroub refugee camp, Nabi Mousa, ath-Thaheriyya, and Ethna. The IOA stopped and searched dozens of cars, and interrogated scores of Palestinians while inspecting their ID cards. The roadblocks caused extended traffic jams and prevented the Palestinians from reaching their destinations, including work and schools in time. (PALINFO 22 August 2021)
- The Israeli Occupation Army (IOA) closed the Dothan checkpoint which leads to the settlement of Mevo Dothan, near Ya'bad town, southwest of Jenin, and carried out a search campaign. (PALINFO 22 August 2021)
- The Israeli Occupation Army (IOA) set up a military checkpoint southwest of Jenin, amidst the outbreak of clashes. The IOA fired sound bombs during the confrontations but no injuries or arrests were reported. (PALINFO 22 August 2021)

Israeli Closures

- The Israeli Occupation Army (IOA) set up an iron gate at the road leading to the al-Fredis Mountain, east of Bethlehem, and installed cellphone and telecommunications towers. The gate will prevent the Palestinians from entering their lands, and added that Israel has imposed severe restrictions in al-Fredis and Jib ath-Theeb areas. (IMEMC 1 August 2021)
- Israeli settlers closed a road connecting the northern West Bank districts of Jenin and Nablus and attacked Palestinian vehicles near the

town of Sebastia to the north of the city of Nablus. A group of settlers closed the road connecting Jenin and Nablus in the northern West Bank and attacked Palestinian vehicles near the entrance to the town of Sebastia, causing damages to several cars. (Wafa 14 August 2021)

- The Israeli Occupation sealed off the entrances to Sinjil town, northeast of the West Bank city of Ramallah, according to local sources. They said that Israeli forces used a bulldozer to close the entrances to the town with earth mounds, denying the town residents and other from the surrounding area access into and out of the town. Israeli severely restricts Palestinians' freedom of movement through a complex combination of approximately 100 fixed checkpoints, flying checkpoints, settler-only roads and various other physical obstructions. Closures besides to other measures, taken under the guise of security, are intended to entrench Israel's 54-year-old military occupation of the West Bank and its settler colonial project, which it enforces with routine and frequently deadly violence against Palestinians. (Wafa 23 August 2021)
- The Israeli Occupation Army (IOA) sealed off the entrances to Sinjil town, northeast of the West Bank city of Ramallah. The IOA used a bulldozer to close the entrances to the town with earth mounds, denying the town residents and other from the surrounding area access into and out of the town. (Wafa 23 August 2021)

Other

- Hebron Governorate in the south of the occupied West Bank is suffering from water shortage due to interruption in supply from the Israeli water company, Mekerot that led to heavy loss of water that exceeded 40,000 cubic meters. The Mekerot's frequent interruptions cause significant confusion in the wholesale distribution of water, as well as to local authorities providing households with their water needs. The continued cutting of water to the lines supplying the Palestinian communities lead to people not having even drinking water, particularly in this very hot weather condition. (Wafa 23 August 2021)
