# Israeli Violations' Activities in the occupied State of Palestine 1 November 2021

The daily report highlights the violations behind Israeli home demolitions and demolition threats in the occupied Palestinian territory, the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers violence against Palestinian civilians and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

The Violations are based on reports provided by field workers and \or news sources.

The text is not quoted directly from the sources but is edited for clarity.

## Violations of the Israeli Occupation Army

 The Israeli Occupation Army (IOA) confiscated a Palestinian-owned water tank from al-Khader village, south of Bethlehem in the southern occupied West Bank. The IOA entered the property of Palestinian resident Suleiman Salah and seized his water tank. (IMEMC 1 November 2021)

### Home Demolition & Demolition threats

- The Israeli Occupation Army (IOA) demolished a water tank in al-Khader town, south of Bethlehem. The IOA stormed Wadi ash-Shami area in the town and destroyed a water tank belonging to local residents at the pretext that it was built with no permit. (palinfo 1 November 2021)
- The Israeli occupation authority (IOA) continued to destroy parts of the centuries-old Muslim Cemetery of Yusufiya in the Old City of Jerusalem for the eighth consecutive day, amid ongoing Palestinian protests. Jewish settlers working for the Israeli municipality in Occupied Jerusalem and the Israel nature and parks authority work day and night under police protection on bulldozing and leveling the northern part of the cemetery and preparing it for the building of a Talmudic park. (PALINFO 1 November 2021)
- The Israeli Occupation Army (IOA) notified for the demolition of a Palestinian home in the town of Yabad to the west of Jenin, in the northern occupied West Bank. The IOA handed local resident Nawaf Hamdoni a notice ordering the demolition of his family house, sheltering 11 family members, under the pretext the house was built without an Israeli-issued permit. The notice gave the family until the 11th of November to appeal the decision. (WAFA 1 November 2021)

The Israeli occupation authorities (IOA) ordered the removal of a tent used as a clinic in Khirbet Ibzeeq community in the northern Jordan Valley north of the occupied West Bank city of Tubas. The IOA recently dismantled and seized another clinic in al-Maleh community, also in the northern Jordan Valley, and also dismantled rooms belonging to the local school. Israel is trying to prevent Palestinians from developing and living

in the occupied Jordan Valley, which it plans to annex. (Wafa 1 November 2021)

# Israeli Military Orders

• The Israeli occupation Army (IOA) carried out a small-scale incursion into a border area in the southeast of the besieged Gaza Strip. Seven military vehicles, including four armored bulldozers, advanced from a military post into a border area in the east of Khan Yunis in southern Gaza. (PALINFO 1 November 2021)
