

Israeli Violations' Activities in the occupied State of Palestine 10 November 2021

 ${f T}$ he daily report highlights the violations behind Israeli home demolitions and demolition threats the occupied Palestinian territory, in the confiscation and razing of lands, the uprooting and destruction of fruit trees, the expansion of settlements and erection of outposts, the brutality of the Israeli Occupation Army, the Israeli settlers against Palestinian civilians violence and properties, the erection of checkpoints, the construction of the Israeli segregation wall and the issuance of military orders for the various Israeli purposes.

Israeli Settler Violence

• Illegal Israeli settlers vandalized Palestinian-owned vehicles and homes, causing damage in the central occupied West Bank city of Al-Beireh, the Quds News Network reported. Witnesses stated that the settlers entered the city overnight and slashed the tires of three vehicles, spray-painted the star of David and hateful and threatening phrases on Palestinian-owned vehicles and homes. Home Demolition & Demolition threats

- Israeli forces stormed the home of Palestinian prisoner Mahmoud Jaber, demolished the inside and handed the family a demolition order for the remainder of the home, according to local sources. The (IOA) and officers of the Israeli municipality invaded the family home in the Wad al-Joz area of occupied East Jerusalem. The troops and officials proceeded to demolish the contents of the home, and demanded the family complete the demolition process or face a fine of 100,000 shekels (\$32,100 US). The demolition order is based on the commonly used pretext of being built without a license, which is nearly impossible for Palestinians to obtain. Additionally in the occupied East Jerusalem neighborhood of Beit Safafa, soldiers destroyed a 40 square meter balcony of another Palestinian-owned home, under the same pretext. - The Israeli occupation army (IOA) wreaked havoc on the interior of a Palestinian house in the east Jerusalem neighborhood of Wadi al-Joz and ordered its owners to demolish it at their own expense. According to local sources, police forces and municipal workers went on the rampage through the house, destroying parts of its inner walls and contents. The house belongs to Jerusalemite prisoner Mahmoud Jaber, whose family started to furnish it recently to make it ready ahead of his wedding that is slated to be held following his release. - The Israeli occupation army (IOA) demolished the inside of a Palestinianowned house in Wad al-Joz area of occupied East Jerusalem and issued a

demolition order for the entire house. The (IOA) demolished the balcony of another house in Beit Safafa neighborhood. (WAFA 10 November 2021)

Confiscation & Razing of lands

 Israeli military bulldozers razed Palestinian lands east of Khan Younis in the southern besieged Gaza strip. The five bulldozers, 2 graters infiltrated into Palestinian territory, across the so-called security fence, while military tanks were situated along the fence to provide cover for the invading machines. The heavy machinery was seen razing large sections of Palestinian-owned farm land east of Abasan al-Jadida town in Khan Younis, 70 meters past the Israeli border fence. The (IOA) has maintained a brutal air, land and sea blockade on the tiny coastal enclave for the past 15 years, in addition to launching 4 major military offensives against the more than two million inhabitants. The military frequently invades Palestinian-owned farm land, opens fire on farmers, and the Navy harasses fishermen while they attempt to fish in the Mediterranean sea. (IMEMC 10 NOVEMBER 2021)
